5. Summary/Purpose: The bill would establish a combination of permit application fees and annual fees for the Department of Environmental Quality's water and waste management permit programs. It provides for reduced fees for those facilities that have strong environmental management programs. The current fee structure will sunset on July 1, 2004. The provisions impacting each of the agency's affected programs are detailed below:

Virginia Pollutant Discharge Elimination System (VPDES) and Virginia Pollution Abatement (VPA) permit programs: The bill would provide for application fees for new facilities and for modifications that occur between permit issuance and the expiration date. Existing facilities would pay an annual permit maintenance fee (equal to 20 percent or less of the current application fee) and would not pay an application fee for permit renewals. Facilities in the toxics management program and facilities with more than five wastewater discharge outfalls would pay additional fees. Annual fees would be reduced for participants in the environmental excellence program.

Virginia Water Protection (VWP) permit program: The fees for smaller projects covered by general permits would not change from current law. For projects over one acre and for projects covered by individual permits, the costs would be increased based on the size of the impact. Permit fees would be increased for minimum instream flow projects and for reservoirs.

Solid waste management program: The bill would provide for reduced permit application fees and annual fees for all permitted facilities. Annual fees would be set by statute and would be reduced for participants in the environmental excellence program. Annual fees for municipal solid waste landfills and incinerators would be based on volume and flat fees would be assessed for all other facilities.

Hazardous waste management program: The bill would provide for reduced permit application fees and annual fees for all permitted treatment, storage, or disposal facilities, large quantity generators, and transporters. Annual fees would be reduced for participants in the environmental excellence program.

Air pollution program: The bill would establish a permit application fee of \$30,000 for new large air pollution sources. If the facility were constructed, the permit application fee would be considered a pre-payment of Title V annual fees.

The bill also would require a management efficiency peer review of the agency's Virginia Pollutant Discharge Elimination System permit program and air permit program as well as a review of the agency's solid waste permitting and inspection programs.

In addition, the bill would require the agency to implement a streamlined permit renewal application; expeditiously implement electronic permitting, filing, and reporting procedures; explore ways to reduce compliance costs to the permittee and to reduce the agency's oversight costs for ensuring compliance; and to encourage efficient and effective environmental performance by deeming a facility's demonstration of a proven environmental management system along with a commitment to pollution prevention, annual progress reporting, and a record of sustained compliance as meeting the criteria for acceptance into the department's programs for environmental excellence.

Finally, under the provisions of the bill if general fund revenues in excess of \$500,000 per year over the Governor's submitted budget for natural resources for the FY 2004-06 biennium are appropriated by the 2004 Appropriation Act and are allocated for implementation of the water permit programs, then the water permit fees must be reduced on a pro rata basis.

The direct program costs include only the costs of salaries and benefits for staff in these programs. It does not include costs for items such as vehicles, computers, training, or office space for program staff.

Any additional revenues associated with the Department of Environmental Quality's air pollution program are highly speculative and cannot be estimated. In addition, if a facility were constructed, then the permit application fee would be considered a pre-payment of Title V annual fees and would therefore not result in additional revenues. According to the Department of Environmental Quality, there would be additional costs associated with the other requirements of the bill but such costs could be handled within the resources provided under the provisions of the bill.

- 7. Budget amendment necessary: Yes (Item 385, Environmental Resources Management). While the introduced budget bill included sufficient nongeneral fund appropriations for these permit fee adjustments, the Department of Environmental Quality would still need an additional \$504,000 in annual general fund appropriations in order to implement the programs as currently structured. The Senate-passed budget amendments included \$400,000 (general fund) in each year of the next biennium for these programs.

- **9. Specific agency or political subdivisions affected:** Department of Environmental Quality; local governments.
- 10. Technical amendment necessary: No.
- **11. Other comments:** This bill is identical to HB 1350 as enrolled.
