A BILL to amend Chapter 624 of the Acts of Assembly of 2004 to designate additional portions of certain highways "Virginia's Heritage Music Trail: The Crooked Road."

Be it enacted by the General Assembly of Virginia:

1. § 1. The following route is hereby designated "Virginia's Heritage Music Trail: The Crooked Road": Beginning at the Blue Ridge Folklife Museum in Ferrum, thence west on U.S. Route 40 to 10 11 Shooting Creek Road, thence along Shooting Creek Road to its intersection with U.S. Route 221, thence 12 along U.S. 221 through the Town of Floyd and west on U.S. Route 221 to its intersection with U.S. 13 14 Route 58 in the Town of Hillsville, thence west on U.S. 58/221 to the Town of Independence, thence 15 west on U.S. Route 58 through the Town of Damascus to its intersection with U.S. Route 11, thence southeast on U.S. 11 through the Town of Abingdon where U.S. 11 joins with U.S. Route 19 to 16 Interstate Route 81 (Exit 5) in the City of Bristol, thence west on U.S. 58 and Interstate Route 81 to the 17 intersection of U.S. Route 421 (Exit 1), thence west on U.S. 58/421 to its intersection with U.S. Route 18 23 in the Town of Weber City, thence west and north on U.S. Route 23/58/421 to the Town of 19 20 Duffield, thence north on U.S. Route 23 through the Town of Big Stone Gap and the City of Norton to the intersection of U.S. Route 23 (business) south of the Town of Pound, thence north on U.S. 23 (business) into the Town of Pound to the intersection of Virginia Route 83, thence east on Virginia Route 83 to the Town of Clintwood; and, in addition, beginning in the Town of Floyd, south on 21 22 23 24 Virginia Route 8 through Woolwine, Buffalo Ridge, and Cruzes Store to the Town of Stuart, thence east 25 on U.S. Route 58 to Nettleridge, thence south on Virginia Route 700 to Moorefield Store, thence west on Virginia Route 631 to Palmetto, thence west on Virginia Route 653 to its intersection with Virginia 26 27 Route 8, thence north on Virginia Route 8 through Five Forks to its intersection with Virginia Route 28 103, thence west on Virginia Route 103 through Peters Creek, Dry Pond, and Claudville to its 29 intersection with Virginia Route 614, thence north on Virginia Route 614 to its intersection with 30 Virginia Route 645, thence west along Virginia Route 645 to its intersection with Virginia Route 773, thence south on Virginia Route 773 to its intersection with Virginia Route 672, thence west on Virginia 31 Route 672 to its intersection with Virginia Route 677, thence north on Virginia Route 677 to its 32 33 intersection with Virginia Route 675, thence east on Virginia Route 675 to its intersection with Virginia 34 Route 773, thence east on Virginia Route 773 to its intersection with Virginia Route 614, thence north on Virginia Route 614 to its intersection with U.S. Route 58 at Meadows of Dan, thence west on U.S. 35 36 Route 58 to Hillsville. The Department of Transportation shall place and maintain appropriate markers 37 indicating the designation of this route. This designation shall not affect any other designation heretofore 38 or hereafter applied to this route or any portions thereof.
