2 3 4 5 6 A BILL to amend the Code of Virginia by adding a section numbered 42.1-36.2, relating to establishing 7 a Public Library Internet Protection Fund. 8

Be it enacted by the General Assembly of Virginia:

1. That the Code of Virginia is amended by adding a section numbered 42.1-36.2 as follows:

§ 42.1-36.2. Public Library Internet Protection Fund established.

11 A. There is hereby created in the state treasury a special nonreverting fund to be known as the Public Library Internet Protection Fund, hereafter referred to as "the Fund." The Fund shall be 12 established on the books of the Comptroller. All moneys as may be appropriated by the General 13 Assembly and any gifts, grants, or donations from public or private sources shall be paid into the state 14 15 treasury and credited to the Fund. Any moneys remaining in the Fund at the end of each fiscal year 16 shall not revert to the general fund but shall remain in the Fund. The Fund shall be administered by the Board of the Library of Virginia and moneys in the Fund shall be used solely for the purposes set forth 17 in subsection B. Expenditures and disbursements from the Fund shall be made by the State Treasurer on 18 warrants issued by the Comptroller upon written request signed by the Librarian of Virginia or his 19 20 designee. 21

 \overline{B} . Disbursements from the Fund may be made by the Board for the following purposes and no 22 others:

23 1. Grants to any free public library or library system as reimbursement for the initial purchase or 24 subsequent renewal of technology protection measures, as provided in § 42.1-36.1, to be installed on 25 computers that are accessible to the public and have Internet access. For purposes of this section a 26 technology protection measure shall filter or block access through such computers to illegal material, 27 including child pornography and, with respect to minors, materials deemed harmful to juveniles; and

28 2. Grants to any free public library or library system that is part of a library system with multiple 29 branches as reimbursement for the one-time purchase of hardware needed to initially install technology 30 protection measures.

31 C. Grants made pursuant to subsection B shall not exceed \$50 per computer for the initial purchase, 32 \$35 per computer for the renewal of software licenses, and \$2,500 per public library system for hardware required for first-time installation of technology protection measures. If the moneys in the 33 34 Fund are insufficient to provide reimbursement for all grant applications received in any given fiscal 35 year then moneys available in the Fund shall be apportioned first to reimburse new purchases and then 36 on a pro rata basis to reimburse renewals. If moneys are insufficient to reimburse all new purchase 37 grant applications received then moneys available in the Fund shall be apportioned on a pro rata basis 38 to all eligible new purchase applicants.
