11 12	Be it enacted by the General Assembly of Virginia: 1. That the Code of Virginia is amended by adding in Chapter 12 of Title 63.2 an article
12	numbered 7, consisting of sections numbered 63.2-1249 through 63.2-1254 as follows:
14	Article 7.
15	Mutual Consent Adoption Registry.
16	§ 63.2-1249. Registry created; purpose.
17	A mutual consent adoption registry (the Registry) is established in the Department of Social Services.
18 19	Birth parents, adoptees, and birth siblings who wish to have identifying information released to each other may register with the Registry. The Department shall disclose identifying information contained in
20	the registry to birth parents, adoptees, and birth siblings in accordance with this article.
$\overline{21}$	§ 63.2-1250. Definitions.
22	"Adoptee" means an individual who was adopted by a resident of the Commonwealth or who was
23	placed for adoption by a child-placing agency licensed in the Commonwealth or a local department of
24 25	social services.
25 26	"Birth father" means a man who (i) was married to the adoptee's birth mother at the time of conception; (ii) was named as the father on the adoptee's pre-adoption birth certificate, unless he has
27	signed a denial of paternity or his nonpaternity has been determined by a court; or (iii) has been
28	adjudicated the father of the adoptee.
29	"Birth sibling" means an individual who is at least 21 years old and shares one or both birth
30 31	parents with an adoptee.
31 32	"Identifying information" means information that reveals the identity or location of an adoptee, or the birth parent or birth sibling of an adoptee.
33	"Registrant" means a person who has filed a registration form as provided in this article.
34	§63.2-1251. Mutual Consent Adoption Registry Fund created.
35	There is hereby created in the state treasury a special nonreverting fund to be known as the Mutual
36 37	Consent Adoption Registry Fund, hereafter referred to as "the Fund." The Fund shall be established on the books of the Comptroller. All registration fees collected by the Department pursuant to § 63.2-1254
37 38	shall be paid into the state treasury and credited to the Fund. Interest earned on moneys in the Fund
<b>39</b>	shall remain in the Fund and be credited to it. Any moneys remaining in the Fund, including interest
<b>40</b>	thereon, at the end of each fiscal year shall not revert to the general fund but shall remain in the Fund.
41	Moneys in the Fund shall be used solely for the purposes of the administration of the mutual consent

49 50	§ 63.2-1253. Registration; form; required information; penalty. A. An individual may register if (i) he is an adoptee who is 21 years of age or older and does not
51	have a birth sibling under 21 years of age; (ii) she is a birth mother; (iii) he is a birth father; and (iv)
52	he is a birth sibling.
53	B. The Department shall prepare a registration form that shall require (i) the registrant's current
54 55	name and any other name by which he was known; (ii) the registrant's address and telephone number;
55 56	(iii) if the registrant is the birth parent of an adoptee, the original and adopted names, if known, of the adoptee; (iv) if the registrant is an adoptee seeking information regarding the adoptee's birth parents,

- A. The Department shall establish and maintain the Registry and adopt rules and regulations to
   carry out the provisions of this article. Such regulations shall include procedures for promptly notifying
   registrants when a match is made.
- 71 A match shall be made in the following circumstances:
- 72 1. An adoptee and both birth parents register;
- 73 2. An adoptee and one or more birth siblings register;

3. An adoptee and one birth parent register and (i) the adoption or entrustment of the child was
made without the signature of the birth father as provided in § 63.2-1202, § 63.2-1222, or § 63.2-1233;
or (ii) the other birth parent is deceased.

The Department shall assess a \$25 registration fee, which shall be deposited in the Mutual Consent
 Adoption Registry Fund established in § 63.2-1251.

79 2. That the provisions of this act may result in a net increase in periods of imprisonment or
