## HOUSE BILL NO. 833

## AMENDMENT IN THE NATURE OF A SUBSTITUTE

(Proposed by the Senate Committee on Transportation  
on March 2, 2006)(Patrons Prior to Substitute—Delegate Welch, Senators Mims [SB 617], O'Brien [SB 128], Puller [SBs 1  
and 43], and Ruff [SB 50])*A BILL to amend and reenact § 46.2-749.78 of the Code of Virginia and to authorize certain special  
license plates, relating to special license plates; fees.***Be it enacted by the General Assembly of Virginia:****1. That § 46.2-749.78 of the Code of Virginia is amended and reenacted as follows:**

§ 46.2-749.78. Special license plates; United We Stand.

*A. On receipt of an application and payment of the fee prescribed by this section, the Commissioner  
shall issue special license plates whose design incorporates the flag of the United States of America and  
the legend: United We Stand.**B. The annual fee for plates issued pursuant to this section shall be twenty-five dollars in addition to  
the prescribed fee for state license plates. For each such twenty-five-dollar fee collected in excess of  
1,000 registrations pursuant to this section, fifteen dollars shall be paid into the state treasury and  
credited to a special nonreverting fund known as the United We Stand Fund established within the  
Department of Accounts. These funds shall be paid annually to the Rewards for Justice Fund and shall  
be used solely as reward payments to informants with information about known terrorists or terrorist  
plans.**2. § 1. Special license plates for supporters of childhood cancer awareness; fees.**A. On receipt of an application and payment of the fee prescribed by this section, the Commissioner  
of the Department of Motor Vehicles shall issue to the applicant special license plates for supporters of  
childhood cancer awareness.**B. The annual fee for plates issued pursuant to this section shall be \$25 in addition to the prescribed  
fee for state license plates. For each such \$25 fee collected in excess of 1,000 registrations pursuant to  
this section, \$15 shall be paid into the state treasury and credited to a special nonreverting fund known  
as the Childhood Cancer Awareness Fund established within the Department of Accounts. These funds  
shall be paid annually to CureSearch and used to promote childhood cancer awareness in Virginia. All  
other fees imposed under the provisions of this section shall be paid to, and received by, the  
Commissioner of the Department of Motor Vehicles, and paid by him into the state treasury and set  
aside as a special fund to be used to meet the necessary expenses incurred by the Department of Motor  
Vehicles.**§ 2. Special license plates for immediate family members of persons who have died in military  
service to their country; fees.**The Commissioner of the Department of Motor Vehicles shall issue special license plates, as  
prescribed herein, on receipt of an application and written evidence that the applicant is the owner of a  
motor vehicle and is a member of the immediate family of a member of the armed forces of the United  
States who lost his or her life under any of the following conditions:**1. During World War I, World War II, or any subsequent period of armed hostilities in which the  
United States was engaged before July 1, 1958;**2. Anytime after June 30, 1958:**a. While engaged in an action against an enemy of the United States;**b. While engaged in military operations involving conflict with an opposing foreign force;**c. While serving with friendly forces engaged in an armed conflict in which the United States is not  
a belligerent party against an opposing armed force; or**3. Anytime after March 28, 1973, as a result of:**a. An international terrorist attack against the United States or a foreign nation friendly to the  
United States, recognized as such an attack by the U. S. Secretary of Defense; or**b. Military operations while serving outside the United States, including commonwealths, territories,  
and possessions of the United States, as part of a peacekeeping force.**For the purposes of this section, a member of the immediate family shall include (i) a widow or  
widower, remarried or not; (ii) a mother, father, stepmother, stepfather, mother through adoption, father  
through adoption, and foster parents who stood in loco parentis; (iii) each child, stepchild, and adopted  
child; and (iv) each brother, half-brother, sister, and half-sister.**For each set of license plates issued under this section, the Commissioner shall charge, in addition  
to the prescribed cost of state license plates, a one-time fee of \$10 at the time the plates are issued.**The provisions of subdivisions B 1 and B 2 of § 46.2-725 of the Code of Virginia shall not apply to*

61 *§ 3. Special license plates for supporters of youth soccer.*

62 *On receipt of an application and following the provisions of § 46.2-725 of the Code of Virginia, the*  
63 *Commissioner of the Department of Motor Vehicles shall issue to the applicant special license plates for*

65 *§ 4. Special license plates honoring Robert E. Lee.*

66 *On receipt of an application and following the provisions of § 46.2-725 of the Code of Virginia, the*  
67 *Commissioner of the Department of Motor Vehicles shall issue to the applicant special license plates*  
68 *honoring Robert E. Lee.*

69 *§ 5. Special license plates bearing the legend I VOTED.*

70 *On receipt of an application and following the provisions of § 46.2-725 of the Code of Virginia, the*  
71 *Commissioner of the Department of Motor Vehicles shall issue to the applicant special license plates*  
72 *bearing the legend: I VOTED.*
