That the Code of Virginia is amended by adding in Title 15.2 a chapter numbered 68 consisting 11 of sections numbered 15.2-6800 through 15.2-6809, as follows: 12 13 CHAPTER 68. 14 WILLIAMSBURG AREA TRANSIT AUTHORITY. 15 § 15.2-6800. Short Title. 16 This chapter shall be known and may be cited as the Williamsburg Area Transit Authority. § 15.2-6801. Authority created. 17 There is hereby created a political subdivision of the Commonwealth known as the Williamsburg 18 19 Area Transit Authority, hereinafter known as "the Authority." 20 In addition to such other powers vested in the Authority by this chapter, the Authority shall have the 21 following powers and functions: 22 1. The Authority shall prepare a regional transit plan for the Williamsburg area, to include the City 23 of Williamsburg, the counties of James City and York, and the areas owned or operated by the College 24 of William and Mary and the Colonial Williamsburg Foundation, to include, but not necessarily be 25 limited to, transit improvements of regional significance, and those improvements necessary or incidental 26 thereto, and shall from time to time revise and amend the plan. 27 2. The Authority may, when a transit plan is adopted according to subdivision 1, construct or 28 acquire, by purchase, lease, contract, or otherwise, the transit facilities specified in such transit plan. 29 3. The Authority may enter into agreements or leases with public or private entities for the operation 30 of its facilities, or may operate such facilities itself. 31 4. The Authority may enter into contracts or agreements with the counties and cities embraced by the Authority, with other transit commissions of transportation districts adjoining any county or city 32 33 embraced by the Authority, with any transportation authority, or with any state, local, private, or federal 34 entity to provide, or cause to be provided, transit facilities and services to the area embraced by the 35 Authority. Such contracts or agreements, together with any agreements or leases for the operation of 36 such facilities, may be used by the Authority to finance the construction and operation of transit 37 facilities and such contracts, agreements, or leases shall inure to the benefit of any creditor of the 38 Authority. 39 5. Notwithstanding any other provision of law to the contrary the Authority may: 40 a. Acquire land or any interest therein by purchase, lease, or gift and provide transit facilities 41 thereon for use in connection with any transit service; b. Acquire land or any interest therein by purchase, lease, or gift in advance of the need for sale or 42 43 contribution to an agency, for use by that agency in connection with an adopted transit plan; 44 c. Prepare a plan for mass transit services with persons, cities, counties, agencies, authorities, or 45 transportation commissions and may further contract with any such person or other entity to provide 46 necessary facilities, equipment, operations and maintenance, access, and insurance pursuant to such 47 plan. 48 § 15.2-6802. Counties and cities embraced by the Authority. 49 The Authority shall embrace the Counties of James City and York and the City of Williamsburg. 50 § 15.2-6803. Composition of Authority; membership; terms. 51 The Authority shall consist of up to 7 members as follows: 52 Two members representing James City County: 53 One member representing York County; and 54 One member representing the City of Williamsburg. 55 In addition, the county and municipal corporation members may elect up to three additional members to represent the interests of higher-education facilities and private, nonprofit tourist-driven 56 agencies in the Williamsburg area, provided that such member facilities and organizations contribute 57 58 significant financial resources to the Authority.

59 The Authority shall appoint the chairman and vice-chairman.

60 § 15.2-6804. Staff.

61 The Authority shall employ an executive director and such staff as it shall determine to be necessary 62 to carry out its duties and responsibilities under this chapter. No such person shall contemporaneously 63 serve as a member of the Authority. The Virginia Department of Transportation and the Virginia 64 Department of Rail and Public Transportation shall make their employees available to assist the 65 Authority, upon request.

§ 15.2-6805. Decisions of Authority. 66

A majority of the Authority shall constitute a quorum. Decisions of the Authority shall require a 67 quorum and shall be in accordance with voting procedures established by the Authority. **68** 

69 § 15.2-6806. Allocation of certain Authority expenses among component members.

The administrative expenses of the Authority, as provided in an annual budget adopted by the 70 71 Authority, to the extent funds for such expenses are not provided from other sources, shall be allocated among the component counties, city, educational and nonprofit agencies pursuant to a funding formula 72 73 as duly adopted by the Authority. 74

§ 15.2-6807. Payment to members of Authority.

75 The members of the Authority may be paid for their services compensation in either (i) the amount 76 provided in the general appropriation act for members of the General Assembly engaged in legislative 77 business between sessions or (ii) a lesser amount as determined by the Authority. Members may be 78 reimbursed for all reasonable and necessary expenses provided in §§ 2.2-2813 and 2.2-2825, if 79 approved by the Authority. Funding for the costs of compensation and expenses of the members shall be 80 provided by the Authority.

81 § 15.2-6808. Formation of advisory committees.

The Authority may, in its discretion, form advisory committees to assist the Authority. 82

83 § 15.2-6809. Other duties and responsibilities of Authority.

84 In addition to other powers herein granted, the Authority shall have the following duties and 85 responsibilities:

86 1. General oversight of Williamsburg area programs involving mass transit or congestion mitigation;

87 2. Long-range transit planning in the Williamsburg area, both financially constrained and 88 unconstrained:

89 3. Recommending to state, regional, and federal agencies regional transit priorities, including 90 public-private transit projects and funding allocations;

91 4. Allocating to priority regional transit projects any funds made available to the Authority and, at 92 the discretion of the Authority, directly overseeing such projects;

93 5. Recommending to the Commonwealth Transportation Board priority regional transit projects for 94 receipt of federal and state funds;

95 6. Serving as an advocate for the transit needs of the Williamsburg area before the state and federal 96 governments;

97 7. Applying to and negotiating with the government of the United States, the Commonwealth of 98 Virginia, or any agency or instrumentality thereof, for grants and any other funds available to carry out 99 the purposes of this chapter and receiving, holding, accepting, and administering from any source gifts, bequests, grants, aid, or contributions of money, property, labor, or other things of value to be held, 100 101 used, and applied to carry out the purposes of this chapter subject, however, to any conditions upon 102 which gifts, bequests, grants, aid, or contributions are made. Unless otherwise restricted by the terms of 103 the gift, bequest, or grant, the Authority may sell, exchange, or otherwise dispose of such money,

securities, or other property given or bequeathed to it in furtherance of its purposes. 104
