10 11 12 13 14	Be it enacted by the General Assembly of Virginia: 1. That §§ 13.1-1002, 13.1-1020, 13.1-1123 and 58.1-811 of the Code of Virginia are amended and reenacted as follows: § 13.1-1002. Definitions. As used in this chapter:
14 15 16 17 18 19 20 21	As used in this chapter: "Articles of organization" means all documents constituting, at any particular time, the articles of organization of a limited liability company. It includes the original articles of organization, the original certificate of organization issued by the Commission, and all amendments to the articles of organization. When the articles of organization have been restated pursuant to any articles of amendment, it includes only the restated articles of organization and any subsequent amendments to the restated articles of organization, but does not include the articles of amendment accompanying the restated articles of organization.

"Manager" or "managers" means a person or persons designated by the members of a limited liability 66 company to manage the limited liability company as provided in the articles of organization or an 67 68 operating agreement.

"Manager-managed limited liability company" means a limited liability company that is managed by 69 70 a manager or managers as provided for in its articles of organization or an operating agreement.

71 "Member" means a person that has been admitted to membership in a limited liability company as provided in § 13.1-1038.1 and that has not ceased to be a member. 72

"Member-managed limited liability company" means a limited liability company that is not a 73 74 manager-managed limited liability company.

75 "Membership interest" or "interest" means, except as otherwise provided in the articles of 76 organization or an operating agreement, a member's share of the profits and the losses of the limited 77 liability company and the right to receive distributions of the limited liability company's assets.

78 "Non-United States entity" means a foreign limited liability company (other than one formed under the laws of a state), or a corporation, business trust or association, real estate investment trust, 79 80 common-law trust, or any other unincorporated business, including a partnership, formed, incorporated, 81 organized, created or that otherwise came into being under the laws of any foreign country or other foreign jurisdiction (other than any state). 82

"Operating agreement" means an agreement of the members as to the affairs of a limited liability 83 company and the conduct of its business, or a writing or agreement of a limited liability company with 84 85 one member that satisfies the requirements of subdivision A 2 of § 13.1-1023. 86

"Person" has the same meaning as specified in § 13.1-603.

87 "Principal office" means the office, in or out of the Commonwealth, where the principal executive 88 offices of a domestic or foreign limited liability company are located.

89 "State," when referring to a part of the United States, includes a state, commonwealth and the 90 District of Columbia, and their agencies and governmental subdivisions; and a territory or insular 91 possession, and their agencies and governmental subdivisions, of the United States.

92 "United States" includes a district, authority, bureau, commission, department and any other agency 93 of the United States. 94

§ 13.1-1020. Parties to actions.

95 A member of a limited liability company, solely by reason of being a member, is not a proper party to a proceeding by or against a limited liability company, except where (i) the object is to enforce a 96 97 member's right against or liability to the limited liability company or (ii) as provided in Article 8 98 (§ 13.1-1042 et seq.) of this chapter. 99

§ 13.1-1123. Coordination with other provisions of Virginia Code.

For purposes of all sections of this Code other than sections in Chapter 7 (§ 13.1-542 et seq.) and in 100 101 this chapter, whenever the term "professional corporation" is used, that term shall be deemed to include a professional limited liability company and wherever the terms "shareholder," "employee," "officer" or 102 "agent" are used those terms shall be deemed to include, as appropriate, the terms member, manager, 103 104 employee and agent.

§ 58.1-811. Exemptions.

105

A. The taxes imposed by §§ 58.1-801 and 58.1-807 shall not apply to any deed conveying real estate 106 107 or lease of real estate:

108 1. To an incorporated college or other incorporated institution of learning not conducted for profit, 109 where such real estate is intended to be used for educational purposes and not as a source of revenue or 110 profit;

111 2. To an incorporated church or religious body or to the trustee or trustees of any church or religious body, or a corporation mentioned in § 57-16.1, where such real estate is intended to be used exclusively 112 113 for religious purposes, or for the residence of the minister of any such church or religious body;

3. To the United States, the Commonwealth, or to any county, city, town, district or other political 114 115 subdivision of the Commonwealth; 116

4. To the Virginia Division of the United Daughters of the Confederacy;

117 5. To any nonstock corporation organized exclusively for the purpose of owning or operating a 118 hospital or hospitals not for pecuniary profit;

119 6. To a corporation upon its organization by persons in control of the corporation in a transaction which qualifies for nonrecognition of gain or loss pursuant to § 351 of the Internal Revenue Code as it 120

121 exists at the time of the conveyance;

122 7. From a corporation to its stockholders upon complete or partial liquidation of the corporation in a 123 transaction which qualifies for income tax treatment pursuant to § 331, 332, 333 or 337 of the Internal 124 Revenue Code as it exists at the time of liquidation;

125 8. To the surviving or new corporation, partnership, limited partnership, business trust, or limited 126 liability company upon a merger [or consolidation] of to which two or more such entities are parties, 127 corporations, partnerships or limited liability companies, or in a reorganization within the meaning of 128 § 368 (a) (1) (C) and (F) of the Internal Revenue Code as amended [, or to the surviving entity of a 129 conversion of one such entity into another such entity, or to any such entity that has domesticated into 130 or out of the Commonwealth];

131 9. To a subsidiary corporation from its parent corporation, or from a subsidiary corporation to a 132 parent corporation, if the transaction qualifies for nonrecognition of gain or loss under the Internal 133 Revenue Code as amended;

134 10. To a partnership or limited liability company, when the grantors are entitled to receive not less 135 than 50 percent of the profits and surplus of such partnership or limited liability company; provided that 136 the transfer to a limited liability company is not a precursor to a transfer of control of the assets of the 137 company to avoid recordation taxes;

138 11. From a partnership or limited liability company, when the grantees are entitled to receive not less 139 than 50 percent of the profits and surplus of such partnership or limited liability company; provided that 140 the transfer from a limited liability company is not subsequent to a transfer of control of the assets of 141 the company to avoid recordation taxes;

142 12. To trustees of a revocable inter vivos trust, when the grantors in the deed and the beneficiaries of 143 the trust are the same persons, regardless of whether other beneficiaries may also be named in the trust 144 instrument, when no consideration has passed between the grantor and the beneficiaries; and to the 145 original beneficiaries of a trust from the trustees holding title under a deed in trust;

146 13. When the grantor is the personal representative of a decedent's estate or trustee under a will or 147 inter vivos trust of which the decedent was the settlor, other than a security trust defined in § 55-58.1, 148 and the sole purpose of such transfer is to comply with a devise or bequest in the decedent's will or to 149 transfer title to one or more beneficiaries after the death of the settlor in accordance with a dispositive 150 provision in the trust instrument; or

151 14. When the grantor is an organization exempt from taxation under § 501 (c) (3) of the Internal 152 Revenue Code that is organized and operated primarily to acquire land and purchase materials to erect 153 or rehabilitate low-cost homes on such land, which homes are sold at cost to persons who otherwise 154 would be unable to afford to buy a home through conventional means, located in a county with a 155 population of not less than 28,500 and not more than 28,650 or a city with a population of not less than 156 66,000 and not more than 70,000.

157 B. The taxes imposed by §§ 58.1-803 and 58.1-804 shall not apply to any deed of trust or mortgage:

158 1. Given by an incorporated college or other incorporated institution of learning not conducted for 159 profit;

160 2. Given by the trustee or trustees of a church or religious body or given by an incorporated church 161 or religious body, or given by a corporation mentioned in § 57-16.1;

162 3. Given by any nonstock corporation organized exclusively for the purpose of owning and/or 163 operating a hospital or hospitals not for pecuniary profit;

164 4. Given by any local governmental entity or political subdivision of the Commonwealth to secure a 165 debt payable to any other local governmental entity or political subdivision; or

5. Securing a loan made by an organization described in subdivision 14 of subsection A of this 166 167 section. 168

C. The tax imposed by § 58.1-802 shall not apply to any:

169 1. Transaction described in subdivisions 6 through 13 of subsection A of this section;

170 2. Instrument or writing given to secure a debt;

171 3. Deed conveying real estate from an incorporated college or other incorporated institution of 172 learning not conducted for profit;

173 4. Deed conveying real estate from the United States, the Commonwealth or any county, city, town, 174 district or other political subdivision thereof;

175 5. Conveyance of real estate to the Commonwealth or any county, city, town, district or other 176 political subdivision thereof, if such political unit is required by law to reimburse the parties taxable 177 pursuant to § 58.1-802; or

178 6. Deed conveying real estate from the trustee or trustees of a church or religious body or from an 179 incorporated church or religious body, or from a corporation mentioned in § 57-16.1.

180 D. No recordation tax shall be required for the recordation of any deed of gift between a grantor or 181 grantors and a grantee or grantees when no consideration has passed between the parties. Such deed **182** shall state therein that it is a deed of gift.

183 E. The tax imposed by § 58.1-807 shall not apply to any lease to the United States, the Commonwealth, or any county, city, town, district or other political subdivision of the Commonwealth.

F. The taxes imposed by §§ 58.1-801, 58.1-802, 58.1-807, 58.1-808 and 58.1-814 shall not apply to
(i) any deed of gift conveying real estate or any interest therein to The Nature Conservancy or (ii) any
lease of real property or any interest therein to The Nature Conservancy, where such deed of gift or
lease of real estate is intended to be used exclusively for the purpose of preserving wilderness, natural
or open space areas.

190 G. The words "trustee" or "trustees," as used in subdivision 2 of subsection A, subdivision 2 of subsection B, and subdivision 6 of subsection C, include the trustees mentioned in § 57-8 and the ecclesiastical officers mentioned in § 57-16.

H. No recordation tax levied pursuant to this chapter shall be levied on the release of a contractualright, if the release is contained within a single deed that performs more than one function, and at leastone of the other functions performed by the deed is subject to the recordation tax.

196 I. No recordation tax levied pursuant to this chapter shall be levied on a deed, lease, easement,
 197 release, or other document recorded in connection with a concession pursuant to the Public-Private
 198 Transportation Act of 1995 (§ 56-556 et seq.) or similar federal law.
