23	recorded as unexpended, as of the close of business on the last day of the previous biennium, on the
24	final records of the State Comptroller; and
25	B. The public taxes and arrears of taxes, as well as moneys derived from all other sources, which

26 shall come into the state treasury prior to the close of business on the last day of the current biennium.
27 The term "moneys" means nontax revenues of all kinds, including but not limited to fees, licenses, services and contract charges, gifts, grants, and donations, and projected revenues derived from proposed legislation contingent upon General Assembly passage.
