Bucher and Son and renamed his company Nielsen Construction Company; and WHEREAS, Nielsen Construction Company became incorporated as Nielsen Builders, Inc., in 1951, and Joseph Nielsen continued to lead the company until his retirement in 1961, when Rockingham County native Samuel Shrum succeeded him as company president; and WHEREAS, today, Nielsen Builders, Inc., employs over 230 people in offices located in Harrisonburg and Charlottesville with two divisions, Nielsen Management Group and Nielsen Construction Company, providing consulting services, program management, construction management, and general contracting to design and build; and WHEREAS, committed to the prosperity of the Commonwealth and the well-being of its citizens, Nielsen Builders, Inc., has been a construction industry leader in Virginia for 100 years, building schools and universities, hospitals, long-term care facilities, and many other quality and innovative structures: and WHEREAS, Nielsen Builders, Inc., is a proud member and supporter of the Association of General Contractors and the Virginia Association of Nonprofit Homes for the Aging; and WHEREAS, an integral partner of the Harrisonburg community, Nielsen Builders, Inc., is dedicated to providing a safe workplace environment for its employees and "guaranteeing a total quality product to every client"; now, therefore, be it RESOLVED by the House of Delegates, the Senate concurring, That the General Assembly commend and congratulate Nielsen Builders, Inc., on the occasion of its 100th anniversary; and, be it
