- 5. Summary/Purpose: The bill requires the Virginia Department of Health (VDH) to issue a request for applications for additional nursing facility beds. VDH must accept applications and may issue certificates of public need for nursing home beds that would result in a 50 percent increase in the number of licensed nursing home beds for each nursing home that has reported to Virginia Health Information an average annual occupancy rate of 99 percent or higher for fiscal year 2006 and fiscal year 2007. The application must be filed on or before December 1, 2008, and approved additional nursing home beds may not be put into service prior to July 1, 2009.

7. **Budget amendment necessary:** No, the fiscal impact of this bill occurs in the out-years and not in the 2008-10 biennium.

- **8. Fiscal implications:** This bill has no fiscal impact on VDH but does impact the Medicaid budget in the Department of Medical Assistance Services (DMAS). VDH has determined that four nursing homes would meet the requirements of the bill and the potential number of additional nursing home beds is 155. DMAS assumes that any beds approved outside the COPN process will result in additional Medicaid reimbursable days. The beds are not likely to be in service until FY 2012. Based on current statewide statistics, DMAS assumes an occupancy rate of 91.20 percent and a Medicaid utilization rate of 63.82 percent. Using the average DMAS reimbursement per day increased by 3.4 percent a year, the average DMAS payment per day would be \$131.94 in FY 2012.
