7. Budget Amendment Necessary: Yes: At minimum, \$1,304,110 for FY 2009 and \$1,304,110 for FY 2010 would need to be added to Item 472 of the introduced budget to cover the general fund share of this cost increase. In addition, a minimum of \$536,000 in nongeneral fund appropriation each year would need to be added to Item 86 to cover the cost to the Local Choice program.

8. Fiscal Implications: The state employee and Local Choice health insurance programs administered by the Department of Human Resource Management do not currently contain all of the coverages mandated by the provisions in this bill. The Department of Human Resource Management indicates that this bill would cost between \$2.9 million and \$8.7 million for the state employee program and \$536,000 and \$1.6 million for the Local Choice program. This increase in cost is primarily the result of increased therapy coverage.

The increase in cost would result in the need for an increase in the premiums charged to employers and employees. Of the total state employee program cost, \$1.3 million to \$3.9 million would be the cost to agencies funded with general fund dollars, \$1.0 to \$3.1 would be the cost to nongeneral fund agencies, and \$550,430 to \$1.7 million would be paid by employees and retirees not yet eligible for Medicare.
