That § 63.2-1605 of the Code of Virginia is amended and reenacted as follows: 11 12 § 63.2-1605. Protective services for adults by local departments. 13 A. Each local board, to the extent that federal or state matching funds are made available to each locality, shall provide, subject to supervision of the Commissioner and in accordance with regulations 14 15 adopted by the Board, adult protective services for adults who are found to be abused, neglected or 16 exploited and who meet one of the following criteria: (i) the adult is 60 years of age or older or (ii) the adult is 18 years of age or older and is incapacitated. The requirement to provide such services shall not 17 limit the right of any individual to refuse to accept any of the services so offered, except as provided in 18 19 § 63.2-1608. 20 B. Upon receipt of the report pursuant to § 63.2-1606, the local department shall determine the validity of such report and shall initiate an investigation within 24 hours of the time the report is 21 22 received in the local department. Local departments shall consider valid any report meeting all of the 23 following criteria: (i) the subject of the report is an adult as defined in this article, (ii) the report 24 concerns a specific adult and there is enough information to locate the adult, and (iii) the report 25 describes the circumstances of the alleged abuse, neglect, or exploitation. 26 C. The local department shall refer any appropriate matter and all relevant documentation to the 27 appropriate licensing, regulatory, or legal authority for administrative action or criminal investigation. 28 D. If a local department is denied access to an adult for whom there is reason to suspect the need for 29 adult protective services, then the local department may petition the circuit court for an order allowing access or entry or both. Upon a showing of good cause supported by an affidavit or testimony in person, 30 31 the court may enter an order permitting such access or entry. E. In any case of suspected adult abuse, neglect, or exploitation, local departments, with the informed 32 33 consent of the adult or his legal representative, mayshall take or cause to be taken photographs, video 34 recordings, or appropriate medical imaging of the adult and his environment as long as such measures 35 are relevant to the investigation and do not conflict with § 18.2-386.1. 36 F. Local departments shall foster the development, implementation, and coordination of adult 37 protective services to prevent adult abuse, neglect, and exploitation. G. Local departments shall not investigate allegations of abuse, neglect, or exploitation of adults 38 39 incarcerated in state correctional facilities. 40 H. Local departments or the adult protective services hotline, upon receiving the initial report 41 pursuant to § 63.2-1606, shall immediately notify the local law-enforcement agency where the adult resides, or where the alleged abuse, neglect, or exploitation took place, or if these places are unknown, 42 then where the alleged abuse, neglect, or exploitation was discovered, when in receipt of a report 43 describing any of the following: 44 1. Sexual abuse as defined in § 18.2-67.10; 45 2. Death, serious bodily injury or disease as defined in § 18.2-369 that is believed to be the result of 46 abuse or neglect; or 47 3. Any other criminal activity involving abuse or neglect that places the adult in imminent danger of 48 49 death or serious bodily harm. I. The report and evidence received by the local department and any written findings, evaluations, 50 51 records, and recommended actions shall be confidential and shall be exempt from disclosure 52 requirements of the Virginia Freedom of Information Act (§ 2.2-3700 et seq.), except that such 53 information may be disclosed to persons having a legitimate interest in the matter in accordance with §§ 63.2-102 and 63.2-104 and pursuant to official interagency agreements or memoranda of 54 understanding between state agencies. 55
