6 **Be it enacted by the General Assembly of Virginia:**7 **1. That § 15.2-5113 of the Code of Virginia is amended and reenacted as follows:**

8 § 15.2-5113. Members of authority board; chief administrative or executive officer.

9 A. The powers of each authority created by the governing body of a single locality shall be exercised
10 by an authority board of five members, or at the option of the board of supervisors of a county, a
11 number of board members equal to the number of members of the board of supervisors. The powers of
12 each authority created by the governing bodies of two or more localities shall be exercised by the
13 number of authority board members specified in its articles of incorporation, which shall be not less
14 than one member from each participating locality and not less than a total of five members. The board
15 members of an authority shall be selected in the manner and for the terms provided by the agreement or
16 ordinance or resolution or concurrent ordinances or resolutions creating the authority. One or more
17 members of the governing body *or one or more directors of an industrial or economic development*
18 *authority* of a locality may be appointed board members of the authority, the provisions of any other
19 law to the contrary notwithstanding. No board member shall be appointed for a term of more than four
20 years. When one or more additional political subdivisions join an existing authority, each of such joining
21 political subdivisions shall have at least one member on the board. Board members shall hold office
22 until their successors have been appointed and may succeed themselves. The board members of the
23 authority shall elect one of their number chairman, and shall elect a secretary and treasurer who need
24 not be members. The offices of secretary and treasurer may be combined.

25 B. A majority of board members shall constitute a quorum and the vote of a majority of board
26 members shall be necessary for any action taken by the authority. An authority may, by bylaw, provide
27 a method to resolve tie votes or deadlocked issues.

28 C. No vacancy in the board membership of the authority shall impair the right of a quorum to
29 exercise all the rights and perform all the duties of the authority. If a vacancy occurs by reason of the
30 death, disqualification or resignation of a board member, the governing body of the political subdivision
31 which appointed the authority board member shall appoint a successor to fill the unexpired term.
32 Whenever a political subdivision withdraws its membership from an authority, the term of any board
33 member appointed to the board of the authority from such political subdivision shall immediately
34 terminate. Board members shall receive such compensation as fixed by resolution of the governing body
35 or bodies which are members of the authority, and shall be reimbursed for any actual expenses
36 necessarily incurred in the performance of their duties.

37 D. Alternate board members may also be selected. Such alternates shall be selected in the same
38 manner and shall have the same qualifications as the board members except that an alternate for an
39 elected board member need not be an elected official. The term of each alternate shall be the same as
40 the term of the board member for whom each serves as an alternate; however, the alternate's term shall
41 not expire because of the board member's death, disqualification, resignation, or termination of
42 employment with the member's political subdivision. If a board member is not present at a meeting of
43 the authority, the alternate for that board member shall have all the voting and other rights of a board
44 member and shall be counted for purposes of determining a quorum.

45 E. The board members may appoint a chief administrative or executive officer who shall serve at the
46 pleasure of the board members. He shall execute and enforce the orders and resolutions adopted by the
47 board members and perform such duties as may be delegated to him by the board members.
