11	1. That § 32.1-271 of the Code of Virginia is amended and reenacted as follows:
12	§ 32.1-271. Disclosure of information in records; when unlawful; when permitted; proceeding to
13	compel disclosure; when certain records made public.
14	A. To protect the integrity of vital records and to ensure the efficient and proper administration of
15	the system of vital records, it shall be unlawful, notwithstanding the provisions of §§ 2.2-3700 through
16 17	2.2-3714, for any person to permit inspection of or to disclose information contained in vital records or
17	to copy or issue a copy of all or part of any such vital records except as authorized by this section or regulation of the Board or when so ordered by a court of this Commonwealth.
19	B. Data contained in vital records may be disclosed for valid and substantial research purposes in
20	accordance with the regulations of the Board.
21	C. Any person aggrieved by a decision of a county or city registrar may appeal to the State
22	Registrar. If the State Registrar denies disclosure of information or inspection of or copying of vital
23	records, such person may petition the court of the county or city in which he resides if he resides in the
24	Commonwealth or in which the recorded event occurred or the Circuit Court of the City of Richmond,
25	Division I, for an order compelling disclosure, inspection or copying of such vital record. The State
26 27	Registrar or his authorized representative may appear and testify in such proceeding. D. When 100 years have elapsed after the date of birth, or 50 years have elapsed after the date of
28	death, marriage, or divorce, the records of these events in the custody of the State Registrar may
2 9	become public information and be made available in accordance with regulations that shall provide for
30	the continued safekeeping of the records. All records that are public information on July 1, 1983, shall
31	continue to be public information.
32	E. The State Registrar or the city or county registrar shall disclose data about or issue a certified
33	copy of a birth certificate of a child to the grandparent of the child upon the written request of the
34	grandparent when the grandparent has demonstrated to the State Registrar evidence of need, as
35 36	prescribed by Board regulation, for the data or birth certificate.
