- **5. Summary:** Transfers certain responsibilities regarding telework assistance from the Secretary of Administration to the Office of Telework Promotion and Broadband Assistance in the Secretary of Technology.

- **7. Budget Amendment Necessary:** Yes, Item 429 would need appropriations for dollars and positions.
- **8. Fiscal Implications:** The bill would require the addition of five full-time staff members to the Office of Telework Promotion and Broadband Assistance. The functions outlined (assistance, data collection, reporting) would also require office space, additional funding for programs, travel, and research functions. It should be noted that agencies currently responsible for these activities are fully staffed and funded to cover the functions/activities suggested in the bill. New staff would need to be hired or transferred in from these agencies to perform the tasks within the office.

Projected costs are calculated as follows. Note that these costs could be reduced if the bill allowed for positions and funding currently in place in other agencies for this purpose to be transferred to the Office of Telework Promotion and Broadband Assistance.

It should be noted that costs incurred due to enhanced responsibilities are reoccurring costs and would need to be covered for the duration of the existance of the Office of Telework Promotion and Broadband Assistance (there are eight years remaining out of a 10 year life). At the end of the period, all positions and responsibilities will need to be reassigned to other agencies.
