WHEREAS, Chief Crowder often went above and beyond his daily responsibilities to be of service
 to the City of Lexington and its residents, including functioning as the city's emergency services
 coordinator in addition to his duties as police chief; and

WHEREAS, Chief Crowder was honored at a retirement celebration on December 23, 2009, at the
Washington and Lee University Evans Dining Hall, where he received tokens of appreciation and heard
remarks from many grateful members of the community; and

WHEREAS, devoted to his family, Steve Crowder enjoys spending time with his loving family,
including his wife, Molly, and two children, Taylor and Justin; he also serves his community as a
member and usher at Lexington Presbyterian Church; and

WHEREAS, Steve Crowder has devoted his professional life to serving the citizens of theCommonwealth with professionalism, integrity, and dedication; now, therefore, be it
