WHEREAS, in 1956 Leo Griffin founded his own consulting and electrical engineering firm and became a valuable contributor to the designs of St. Mary's Hospital, the Blue Cross Building, Richmond City Hall, and the Commonwealth's Monroe Building; and

WHEREAS, possessing a strong work ethic, Leo Griffin worked many years for Dominion Virginia Power in the Nuclear Engineering Services Department until his retirement in July 2000; and

WHEREAS, Leo Griffin will be fondly remembered for his professionalism and for his love of life and family and will be greatly missed by his two sons, Leo T. Griffin, Jr., and wife, Peggy, and John Patrick Griffin and wife, Kathy; three grandchildren and a great-granddaughter; and a host of other loving family members and friends; now, therefore, be it
