3. Committee: Commerce and Labor

4. Title: Unemployment benefits; minimum earnings requirement.

5. Summary: This bill postpones the scheduled increase, from \$2,700 to \$3,000, in the minimum amount of wages an employee must have earned in the two highest earnings quarters of his base period in order to be eligible for unemployment benefits. The increase will apply to claims filed on or after July 3, 2011; it is currently scheduled to apply to claims filed on or after July 4, 2010. In addition, this bill deletes three sets of benefit payment tables based on their effective dates having passed.

7. Budget Amendment Necessary: Yes, Item 115.

8. Fiscal Implications: The Virginia Employment Commission estimates deferring the increase in minimum earnings requirement from \$2,700 to \$3,000 until July 2011 will increase the unemployment tax cost per employee by an average of \$0.22 in 2012 and \$0.28 in 2013.

Payment of unemployment taxes lowers corporations' taxable income. The impact on general fund revenues is estimated at an average reduction of \$2,000 annually from 2013 to 2015 as a result of the bill.
