2 *An Act to amend and reenact §§ 16.1-69.40:1 and 16.1-69.40:2 of the Code of Virginia, relating to*
 3 *prepayment of fines under local ordinances.*

6 **Be it enacted by the General Assembly of Virginia:**

7 **1. That §§ 16.1-69.40:1 and 16.1-69.40:2 of the Code of Virginia are amended and reenacted as**
 8 **follows:**

9 § 16.1-69.40:1. Traffic infractions within authority of traffic violations clerk; schedule of fines;
 10 prepayment of local ordinances.

11 A. The Supreme Court shall by rule, which may from time to time be amended, supplemented or
 12 repealed, but which shall be uniform in its application throughout the Commonwealth, designate the
 13 traffic infractions for which a pretrial waiver of appearance, plea of guilty and fine payment may be
 14 accepted. Such designated infractions shall include violations of §§ 46.2-878.2 and 46.2-1242 or any
 15 parallel local ordinances. Notwithstanding any rule of the Supreme Court, a person charged with a traffic
 16 offense that is listed as prepayable in the Uniform Fine Schedule may prepay his fines and costs without
 17 court appearance whether or not he was involved in an accident. The prepayable fine amount for a
 18 violation of § 46.2-878.2 shall be \$200 plus an amount per mile-per-hour in excess of posted speed
 19 limits, as authorized in § 46.2-878.3.

20 Such infractions shall not include:

21 (a) 1. Indictable offenses;

22 (b) 2. [Repealed.]

23 (c) 3. Operation of a motor vehicle while under the influence of intoxicating liquor or a narcotic or
 24 habit-producing drug, or permitting another person, who is under the influence of intoxicating liquor or
 25 a narcotic or habit-producing drug, to operate a motor vehicle owned by the defendant or in his custody
 26 or control;

27 (d) 4. Reckless driving;

28 (e) 5. Leaving the scene of an accident;

29 (f) 6. Driving while under suspension or revocation of driver's license;

30 (g) 7. Driving without being licensed to drive.

31 (h) 8. [Repealed.]

32 B. An appearance may be made in person or in writing by mail to a clerk of court or in person
 33 before a magistrate, prior to any date fixed for trial in court. Any person so appearing may enter a
 34 waiver of trial and a plea of guilty and pay the fine and any civil penalties established for the offense
 35 charged, with costs. He shall, prior to the plea, waiver, and payment, be informed of his right to stand
 36 trial, that his signature to a plea of guilty will have the same force and effect as a judgment of court,
 37 and that the record of conviction will be sent to the Commissioner of the Department of Motor Vehicles
 38 or the appropriate offices of the State where he received his license to drive.

39 C. The Supreme Court, upon the recommendation of the Committee on District Courts, shall
 40 establish a schedule, within the limits prescribed by law, of the amounts of fines and any civil penalties
 41 to be imposed, designating each infraction specifically. The schedule, which may from time to time be
 42 amended, supplemented or repealed, shall be uniform in its application throughout the Commonwealth.
 43 Such schedule shall not be construed or interpreted so as to limit the discretion of any trial judge trying
 44 individual cases at the time fixed for trial. The rule of the Supreme Court establishing the schedule shall
 45 be prominently posted in the place where the fines are paid. Fines and costs shall be paid in accordance
 46 with the provisions of this Code or any rules or regulations promulgated thereunder.

47 D. Fines imposed under local traffic infraction ordinances ~~which~~ *that* do not parallel provisions of
 48 state law and fulfill the criteria set out in subsection A of ~~this section~~ may be prepayable in the manner
 49 set forth in subsection B if such ordinances appear in a schedule entered by order of the local circuit
 50 courts. The ~~judges~~ *chief judge* of each circuit may establish a schedule of the fines, within the limits
 51 prescribed by local ordinances, to be imposed for prepayment of local ordinances designating each
 52 offense specifically. Upon the entry of such order it shall be forwarded within 10 days to the Supreme
 53 Court of Virginia by the clerk of the local circuit court. The schedule, which from time to time may be
 54 amended, supplemented or repealed, shall be uniform in its application throughout the circuit. Such
 55 schedule shall not be construed or interpreted so as to limit the discretion of any trial judge trying
 56 individual cases at the time fixed for trial. This schedule shall be prominently posted in the place where

57 fines are paid. Fines and costs shall be paid in accordance with the provisions of this Code or any rules
58 or regulations promulgated thereunder.

59 § 16.1-69.40:2. Nontraffic offenses for which prepayment authorized; schedules, fines; prepayment of
60 local ordinances.

61 A. The Supreme Court shall by rule, which may from time to time be amended, supplemented or
62 repealed, but which shall be uniform in its application throughout the Commonwealth, designate the
63 nontraffic offenses for which a pretrial waiver of appearance, plea of guilty and fine payment may be
64 accepted. Such offenses shall not include:

- 65 1. Indictable offenses;
- 66 2. Class 1 or Class 2 misdemeanors;
- 67 3. Offenses which involve moral turpitude;
- 68 4. Any offenses involving injury to persons;
- 69 5. Any offense punishable by incarceration or by a fine of more than \$500.

70 B. An appearance may be made in person or in writing by mail to a clerk of court or in person
71 before a magistrate, prior to any date fixed for trial in court. Any person so appearing may enter a
72 waiver of trial and plea of guilty and pay the fine established for the offense charged, with costs. He
73 shall, prior to the plea, waiver and payment, be informed of his right to stand trial and that his signature
74 to a plea of guilty will have the same force and effect as a judgment of court.

75 C. The Supreme Court, upon the recommendation of the Committee on District Courts, shall
76 establish a schedule, within the limits prescribed by law, of the amounts of fines to be imposed upon
77 prepayment of nontraffic offenses authorized as prepayable under subsection A of this section,
78 designating each offense specifically. The schedule, which may from time to time be amended,
79 supplemented or repealed, shall be uniform in its application throughout the Commonwealth. Such
80 schedule shall not be construed or interpreted so as to limit the discretion of any trial judge trying
81 individual cases at the time fixed for trial. The Rule of the Court establishing the schedule shall be
82 prominently posted in the place where the fines are paid. Fines and costs shall be paid in accordance
83 with the provisions of this Code or any rules or regulations promulgated thereunder.

84 D. Local ordinances fulfilling the criteria set out in subsection A of this section may be prepayable
85 in a like manner if such ordinances appear in a schedule entered by order of the local circuit courts. The
86 ~~judges~~ *chief judge* of each circuit may establish a schedule of the fines, within the limits prescribed by
87 local ordinances to be imposed for prepayment of local ordinances designating each offense specifically.
88 Upon the entry of such order it shall be forwarded within ~~ten~~ 10 days to the Supreme Court of Virginia
89 by the clerk of the local circuit court. The schedule, which may from time to time be amended,
90 supplemented or repealed, shall be uniform in its application throughout the circuit. Such schedule shall
91 not be construed or interpreted so as to limit the discretion of any trial judge trying individual cases at
92 the time fixed for trial. This schedule shall be prominently posted in the place where the fines are paid.
93 Fines and costs shall be paid in accordance with the provisions of this Code or any rules or regulations
94 promulgated thereunder.
