22 § 1-206. Certified mail equivalent to registered mail; certain subsequent mail or notice may be sent 23 by regular mail.

24 A. If any mail or notice is required to be sent by registered mail, it shall constitute compliance with 25 this requirement if such mail or notice is sent by certified mail.

26 B. Notwithstanding any provision of law to the contrary, whenever a state agency is required to send 27 any mail or notice by certified mail and such mail or notice is sent certified mail, return receipt 28 requested, then any subsequent, identical mail or notice that is sent by such state agency may be sent by 29 regular mail.

30 C. As used in this section, "state agency" means the same as that term is defined in § 2.2-4347.

31 § 2.2-401.1. Certified mail; subsequent mail or notices may be sent by regular mail.

32 Whenever in the Code of Virginia the Secretary is required to send any mail or notice by certified 33 mail and such mail or notice is sent certified mail, return receipt requested, then any subsequent, 34 identical mail or notice that is sent by the Secretary may be sent by regular mail. 35

§ 2.2-601.1. Certified mail; subsequent, identical mail or notices may be sent by regular mail.

36 Whenever in this title a state agency is required to send any mail or notice by certified mail and 37 such mail or notice is sent certified mail, return receipt requested, then any subsequent, identical mail 38 or notice that is sent by such agency may be sent by regular mail.

39 As used in this section, "state agency" means the same as that term is defined in § 2.2-4347. 40

§ 3.2-101.1. Certified mail; subsequent mail or notices may be sent by regular mail.

104 The Commission, on testimony of an officer at a hearing that he has personally observed a person 105 having dredging cable or dredging equipment overboard or in any way engaged in dredging in any area other than where a person holds a lawful permit or license to dredge, may revoke all permits and 106 107 licenses held by the person to dredge on public or private grounds and may refuse to issue any licenses or permits for such purposes for a period of one year. Before the Commission holds a hearing pursuant 108 to this section, it shall provide at least five days' written notice to the permittee or licensee. Notice shall 109 110 be served either by a Commission officer or by certified mail addressed to the permit or license holder at the address given on the permit or license. Any subsequent, identical notice that is sent by the 111 112 Commission may be sent by regular mail. 113
