6 **Be it enacted by the General Assembly of Virginia:**7 **1. That § 8.01-341.1 of the Code of Virginia is amended and reenacted as follows:**

8 § 8.01-341.1. Exemptions from jury service upon request.

9 Any of the following persons may serve on juries in civil and criminal cases but shall be exempt
10 from jury service upon his request:

11 1. through 3. [Repealed.]

12 4. A mariner actually employed in maritime service,

13 5. through 7. [Repealed.]

14 8. A person who has legal custody of and is necessarily and personally responsible for a child or
15 children 16 years of age or younger requiring continuous care by him during normal court hours, or any
16 mother who is breast-feeding a child,17 9. A person who is necessarily and personally responsible for a person having a physical or mental
18 impairment requiring continuous care by him during normal court hours,

19 10. Any person over 70 years of age,

20 11. Any person whose spouse is summoned to serve on the same jury panel,

21 12. Any person who is the only person performing services for a business, commercial or agricultural
22 enterprise and whose services are so essential to the operations of the business, commercial or
23 agricultural enterprise that such enterprise must close or cease to function if such person is required to
24 perform jury duty,25 13. Any person employed by the Office of the Clerk of the House of Delegates, the Office of the
26 Clerk of the Senate, the Division of Legislative Services, and the Division of Legislative Automated
27 Systems, however, this exemption shall apply only to jury service starting (i) during the period
28 beginning 60 days prior to the day any regular session commences and ending 30 days after the day of
29 adjournment of such session and (ii) during the period beginning seven days prior to the day any
30 reconvened or special session commences and ending seven days after the day of adjournment of such
31 session,32 14. *Any general registrar, member of a local electoral board, or person appointed or employed by*
33 *either the general registrar or the local electoral board, except officers of election appointed pursuant*
34 *to Article 5 (§ 24.2-115 et seq.) of Chapter 1 of Title 24.2; however, this exemption shall apply only to*
35 *jury service starting (i) during the period beginning 90 days prior to any election and continuing*
36 *through election day, (ii) during the period to ascertain the results of the election and continuing for 10*
37 *days after the local electoral board certifies the results of the election under § 24.2-671 or the State*
38 *Board of Elections certifies the results of the election under § 24.2-679, or (iii) during the period of an*
39 *election recount or contested election pursuant to Chapter 8 (§ 24.2-800 et seq.) of Title 24.2. Any*
40 *officer of election shall be exempt from jury service only on election day and during the periods set*
41 *forth in clauses (ii) and (iii).*
