8 WHEREAS, Philip M. Keating, a true pillar of the Arlington County community, husband, father,9 lawyer, and volunteer, died suddenly on January 18, 2011, at the age of 51; and

WHEREAS, Philip "Phil" Keating, born in the Bronx, New York, grew up in Somerset, New Jersey;
 graduated from Rutgers University, where he was honored as a "Loyal Son" in 1999; and received a law
 degree with honors from The George Washington University in 1984; and

WHEREAS, Phil Keating married Erin Devine in 1986 and had three children, Kathleen, Patrick, and
Caroline whom he supported, coached, and loved; he was heavily involved in their school and
extracurricular activities and passed on his love of God, family, and community to them; and

WHEREAS, Phil Keating coached his children's soccer and basketball youth teams, was a former
president of the Arlington Travel Soccer Club, current president of the Arlington Pride girls' basketball
league, and an active member of the Jamestown Elementary School, Williamsburg Middle School, and
Yorktown High School Parent Teacher Associations; and

WHEREAS, as a partner with the Arlington law firm of Bean, Kinney & Korman, PC, Phil Keating
worked primarily in the areas of labor and employment and immigration law, was named as one of
"Virginia's Legal Elite" by *Virginia Business* magazine in December 2010, and was a member of many
legal and professional associations; and

WHEREAS, as an active member of the business and civic community, Phil Keating was the 2010
Chairman of the Arlington Chamber of Commerce; past chair of the Chamber's Government and
Legislative Affairs Committee; an active participant in local, state, and federal campaigns and elections;
a member of the Arlington Community Energy and Sustainability Task Force; on the board of directors
of the Northern Virginia Transportation Alliance; a former member of Leadership Alexandria; and past
president of the DC Chapter of Rutgers Alumni Association; and

WHEREAS, as a parishioner of St. Charles Borromeo Catholic Church in Arlington, Phil Keating
 was devoted to the Church's teaching on social justice and peace and, as cofounder of the Borromeo
 Legal Project, he recruited other attorneys to do professional pro bono work to help new Americans
 become United States citizens; and

WHEREAS, a man of many accomplishments, Phil Keating touched the lives of countless individuals
 during his life and inspired many to become involved in and appreciate the civic and community life in
 Arlington County; and

WHEREAS, Phil Keating will be fondly remembered and greatly missed by his beloved wife, Erin
Devine; children, Kathleen, Patrick, and Caroline; his dear sisters, Patricia and Ellen, and brother,
Michael, and their families; other extended family members; and numerous friends and admirers; now,
therefore, be it

note with great sadness the loss of a respected citizen of the Commonwealth, Philip M. Keating; and, be
