WHEREAS, Cecil Bailey made numerous contributions not only to C.F. Sauer Company, but also to
other professionals in the area through his service as president of the Richmond chapter of the American
Marketing Association; and

WHEREAS, Cecil Bailey was also a certified meeting planner who served as president of the
 Virginia Chapter of Meeting Professionals International; his efforts to encourage and support rising
 meeting professionals earned him the chapter's mentor award for three years, at which point it was
 renamed in his honor; and

WHEREAS, Cecil Bailey went on to open his own company, Meeting Needs Unlimited, andprovided his clients with superior customer service as he planned their meetings and events; and

WHEREAS, a man of many interests, Cecil Bailey remained active during retirement, volunteering at
Lewis Ginter Botanical Garden and serving as a faithful doorkeeper with the Virginia General
Assembly; and
