6 **Be it enacted by the General Assembly of Virginia:**7 **1. That § 54.1-3452 of the Code of Virginia is amended and reenacted as follows:**

8 § 54.1-3452. Schedule IV.

9 The controlled substances listed in this section are included in Schedule IV unless specifically
10 excepted or listed in another schedule:11 1. Any material, compound, mixture, or preparation which contains any quantity of the following
12 substances having a potential for abuse associated with a depressant effect on the central nervous
13 system:

14 Alprazolam;

15 Barbitol;

67 2. Any compound, mixture or preparation which contains any quantity of the following substances
 68 including any salts or isomers thereof:

69 Fenfluramine.

70 3. Unless specifically excepted or unless listed in another schedule, any material, compound, mixture,
 71 or preparation which contains any quantity of the following substances having a stimulant effect on the
 72 central nervous system, including its salts, isomers (whether optical, position, or geometric), and salts of
 73 such isomers whenever the existence of such salts, isomers, and salts of isomers is possible within the
 74 specific chemical designation:

75 Cathine (+)-norpseudoephedrine;

76 Diethylpropion;

77 Fencamfamin;

78 Fenproporex;

79 Mazindol;

80 Mefenorex;

81 Modafinil;

82 Phentermine;

83 Pemoline (including organometallic complexes and chelates thereof);

84 Pipradrol;

85 Sibutramine;

86 SPA (-)-1-dimethylamino-1, 2-diphenylethane.

87 4. Unless specifically excepted or unless listed in another schedule, any material, compound, mixture,
 88 or preparation containing any of the following narcotic drugs, or their salts calculated as the free
 89 anhydrous base or alkaloid, in limited quantities as set forth below:

90 Dextropropoxyphene (alpha-(+)-4-dimethylamino-1, 2-diphenyl-3-methyl-2-propionoxy butane);

91 Not more than 1 milligram of difenoxin and not less than 25 micrograms of atropine sulfate per
 92 dosage unit.

93 5. Unless specifically excepted or unless listed in another schedule, any material, compound, mixture,
 94 or preparation which contains any quantity of the following substances, including their salts:

95 Butorphanol (including its optical isomers);

96 Pentazocine.

97 6. The Board may except by regulation any compound, mixture, or preparation containing any
 98 depressant substance listed in subdivision 1 from the application of all or any part of this chapter if the
 99 compound, mixture, or preparation contains one or more active medicinal ingredients not having a
 100 depressant effect on the central nervous system, and if the admixtures are included therein in
 101 combinations, quantity, proportion, or concentration that vitiate the potential for abuse of the substances
 102 which have a depressant effect on the central nervous system.
