Purchases from nonprofit sheltered workshops Employment Services Organizations of 15 16 Virginia serving the handicapped individuals with disabilites. A. The Division shall publish annually a list of materials, supplies, services and equipment which, in 17 the opinion of the Division, would be beneficial to the Commonwealth to procure from a sheltered 18 workshop an employment services organization. The list shall exclude items currently produced by 19 schools or workshops under the supervision of the Virginia Department for the Blind and Vision 20 21 Impaired or by inmates confined in state correctional institutions. 22 B. Any item or service included on the list required by subsection A may be purchased by the 23 Division from nonprofit sheltered workshops employment services organizations serving the handicapped 24 individuals with disabilities without competitive procurement, if the Division is satisfied that the items 25 and services (i) can be purchased within ten percent of their fair market value, (ii) will be of acceptable 26 quality, and (iii) can be produced in sufficient quantities within the time required. 27 C. Exemptions from competition for certain transactions. 30 A. Any public body may enter into contracts without competition for: 31 1. The purchase of goods or services that are produced or performed by: a. Persons, or in schools or workshops, under the supervision of the Virginia Department for the 32 33 Blind and Vision Impaired; or 34 b. Nonprofit sheltered workshops Employment services organizations or other nonprofit organizations 35 that offer transitional or supported employment services serving the handicapped. 36 2. The purchase of legal services, provided that the pertinent provisions of Chapter 5 (§ 2.2-500 et 37 seq.) of this title remain applicable, or expert witnesses or other services associated with litigation or 38 regulatory proceedings. 39 B. An industrial development authority may enter into contracts without competition with respect to any item of cost of "authority facilities" or "facilities" as defined in § 15.2-4902. 40 C. A community development authority formed pursuant to Article 6 (§ 15.2-5152 et seq.) of Chapter 41 51 of Title 15.2, with members selected pursuant to such article, may enter into contracts without 42 competition with respect to the exercise of any of its powers permitted by § 15.2-5158.
