AMENDMENT IN THE NATURE OF A SUBSTITUTE

(Proposed by the House Committee on Appropriations

on February 10, 2012)

(Patron Prior to Substitute—Delegate Peace)

2 3 4 5 6 A BILL to amend the Code of Virginia by adding in Article 1 of Chapter 34 of Title 38.2 a section 7 numbered 38.2-3407.18, relating to requirements for orally administered cancer chemotherapy drugs. 8 Be it enacted by the General Assembly of Virginia:

## 1. That the Code of Virginia is amended by adding in Article 1 of Chapter 34 of Title 38.2 a section numbered 38.2-3407.18 as follows: 9 10

§ 38.2-3407.18. Requirements for orally administered cancer chemotherapy drugs.

12 A. Each (i) insurer proposing to issue individual or group accident and sickness insurance policies providing hospital, medical and surgical, or major medical coverage on an expense-incurred basis; (ii) 13 corporation providing individual or group accident and sickness subscription contracts; and (iii) health 14 15 maintenance organization providing a health care plan for health care services, whose policies, contracts, or plans, including any certificate or evidence of coverage issued in connection with such 16 policies, contracts, or plans, include coverage for cancer chemotherapy drugs administered orally and 17 intravenously or by injection shall provide that the durational limits, deductibles, coinsurance factors, 18 and copayments for orally administered cancer chemotherapy drugs shall have consistently applied 19 20 criteria within the same plan as those for cancer chemotherapy drugs that are administered 21 intravenously or by injection.

22 B. The requirements of this section shall apply to all insurance policies, contracts, and plans 23 delivered, issued for delivery, reissued, renewed, or extended or at any time when any term of any such 24 policy, contract, or plan is changed or any premium adjustment is made, on and after the effective date of this section. The provisions of this section shall not apply to short-term travel, accident only, limited 25 26 or specific disease, or individual conversion policies or contracts, nor to policies or contracts designed 27 for issuance to persons eligible for coverage under Title XVIII of the Social Security Act, known as 28 Medicare, or any other similar coverage under state or federal governmental plans.

29 C. For health insurance coverage offered to state employees pursuant to § 2.2-2818 and for health 30 insurance coverage offered for employees of local governments, local officers, teachers, and retirees, 31 and the dependents of such employees, local officers, teachers and retirees pursuant to § 2.2-1204, the 32 health insurance coverage shall consistently apply the criteria for establishing the level of copayments or coinsurance for orally administered cancer treatment drugs and cancer chemotherapy drugs that are 33 administered intravenously or by injection within the same plan. 34
