9 10	Be it enacted by the General Assembly of Virginia:
11	1. That §§ 3.1 and 3.2, as amended, and §§ 3.5 and 3.8 of Chapter 304 of the Acts of Assembly of
12	1973 are amended and reenacted as follows:
13	§ 3.1. ELECTION, QUALIFICATION AND TERM OF OFFICE OF COUNCILMEN AND
14	MAYOR.
15	(a) The Town of West Point shall be governed by a town council composed of seven councilmen
16 17	and a mayor, all of whom shall be qualified voters of the town, to be elected from the town at large. (b) The mayor and councilmen in office at the time of the passage of this act shall continue in office
18	until the expiration of the terms for which they were elected. The councilmen and mayor shall be
19	elected at a regular municipal election to be held on the first Tuesday in May, 1982, in the manner
20	prescribed by law, for terms beginning on the first day of July next following their election, each of
21	them serving until the successors shall be elected and qualified. The three candidates for council
22	receiving the highest number of votes and the mayor shall be elected for initial terms of four years, and
23	the four candidates receiving the next highest number of votes shall be elected for initial terms of two
24	years. Thereafter, all councilmen and the mayor shall be elected for terms of four years at a regular
25 26	municipal election which shall be held on the first Tuesday in May of each even numbered year, the number of councilmen elected each election year being equal to the number of councilmen whose terms
20 27	expire during such year and the mayor being elected every fourth year.
28	However, beginning with elections to be held in 2012 and 2014, the council and mayor shall be
29	elected on the Tuesday following the first Monday in November to serve four-year terms that begin on
30	January 1 and end on December 31. All members whose terms would have expired on July 1 of 2012 or
31	2014 shall have their terms extended six months until their successors have been elected and qualified,
32	Thereafter, all member shall serve for terms of four years.
33 34	§ 3.2. VACANCIES ON COUNCIL. Vacancies on the council shall be filled from among the qualified voters of the town by a majority
35	vote of the members of the council. A person so elected by council shall serve until the first day of July
36	following the next regular election of members of council more than one hundred twenty days after the
37	vacancy occurs, or until the termination of the unexpired term, whichever shall occur first. If the term of
38	the person so elected by council expires on the first day of July following the next regular election of
39	members of council more than one hundred twenty days after the vacancy occurs, the vacancy for the
40 41	remaining two years of the unexpired term shall be filled by a special election for a twoyear term to be
41 42	held at the next regular election of members of council. When any vacancy shall occur for which a special election by the voters of the town is appropriate, council shall, within fifteen days of the
43	occurrence of such vacancy, petition the Judge of the Circuit Court of King William County to issue a
44	writ of election for that election.
45	(a) A vacancy on town council, whether occurring when for any reason an officer-elect does not take
46	office or occurring after an officer begins his term, shall be filled in accordance with state law and as
47	provided by Article 5 (§ 24.2-681 et seq.) of Chapter 6 of Title 24.2 of the Code of Virginia. The town
48 40	council shall, within 15 days of the occurrence of the vacancy, petition the circuit court to issue a writ
49 50	of election to fill the vacancy as set forth in Article 5 (§ 24.2-681 et seq.) of Chapter 6 of Title 24.2 of the Code of Virginia. Either upon receipt of the petition or on its own motion, the court shall issue the

51 writ ordering the election promptly, which shall be no later than the next general election in November 52 unless the vacancy occurs within 90 days of the next such general election, in which event it shall be 53 held promptly but no later than the second such general election. Upon receipt of written notification by 54 an officer or officer-elect of his resignation as of a stated date, the town council may immediately 55 petition the circuit court to issue a writ of election, and the court may immediately issue the writ to call **SB602**

60 (b) No election to fill a vacancy shall be ordered or held if the general election at which it is to be called is scheduled within 60 days of the end of the term of the office to be filled.

(c) When an interim appointment to a vacancy in town council has been made by the remaining
members thereof, no election to fill the vacancy shall be ordered or held if the general election at which
it is to be called is scheduled in the year in which the term expires.

§ 3.5. POWERS AND DUTIES OF MAYOR.

The mayor shall be the chief executive officer of the town. He shall have and exercise all power and 66 authority conferred by general law not inconsistent with this charter. He shall preside over the meetings 67 of the town council and shall have the same right to speak therein as a member of the council, but shall 68 not vote except in the case of a tie vote. He shall have the power of veto over the ordinances and 69 70 resolutions any action of the town council, but any such ordinances and resolutions action that has been 71 vetoed by the mayor may be passed over such veto by a two-thirds vote of the members of the town council present and voting. He shall be recognized as the head of the town government for all 72 73 ceremonial purposes. He shall perform such other duties consistent with his office as may be imposed 74 by the town council. He shall see that the duties of the various town officers are faithfully performed. The police force of the town shall be under the control of the mayor for the purpose of enforcing peace 75 and good order and executing the laws of the State and the ordinances of the town. He, or the person 76 77 acting as mayor, may deputize such assistant policemen as may be necessary; and shall authenticate by his signature, such documents or instruments as the council, this charter, or the laws of the 78 79 Commonwealth shall require.

80 § 3.8. MEETINGS OF COUNCIL.

The town council shall fix the time of its stated meetings, and it shall meet at least once a month, 81 and except as herein provided, the council shall establish its own rules of procedure. A journal shall be 82 83 kept of its official proceedings and its meetings shall be open to the public. Four members of the town council shall constitute a quorum for the transaction of business at any meeting. Special meetings may 84 85 be called at any time by the mayor or by any three members of the council; provided, that the mayor and all council members are duly notified a reasonable period of time prior to such meeting, and no 86 87 business shall be transacted at a special meeting thereof, except that for which it shall be called. If all 88 members are present, this provision may be waived by a majority vote of the council. No ordinance, 89 resolution, motion or vote shall be adopted by the council unless it shall have received the affirmative 90 votes of a majority of the members present.
