2 *An Act to amend and reenact § 30-19.3 of the Code of Virginia, relating to the signing of prefiled bills*

6 **Be it enacted by the General Assembly of Virginia:**

7 **1. That § 30-19.3 of the Code of Virginia is amended and reenacted as follows:**

8 § 30-19.3. Prefiling of bills and resolutions.

9 A. 1. Any member or member-elect of the next regular session of the General Assembly may prefile
10 bills and resolutions for even-numbered-year regular sessions beginning the third Monday in November
11 of the preceding year with the Clerk of the House of Delegates or Senate as appropriate.

12 2. Any member or member-elect of the General Assembly may prefile bills and resolutions for
13 odd-numbered-year regular sessions beginning the third Monday in July of the preceding year with the
14 Clerk of the House of Delegates or Senate as appropriate.

15 3. Any bill or resolution prefiled shall be endorsed by the handwritten signature of at least one
16 member or member-elect as a patron. *An electronic signature may be substituted for a handwritten*
17 *signature on prefiled legislation as may be approved by each house in accordance with its rules and*
18 *procedures.* In no event shall a bill or resolution be prefiled by a member of the General Assembly who
19 was not re-elected to the next regular session of the General Assembly. The deadline for submitting
20 drafting requests for legislation to be prefiled to the Division of Legislative Services and the deadline
21 for prefiling legislation with the appropriate Clerk shall be established by the procedural resolution
22 adopted by the General Assembly, or in default thereof, adopted by the Joint Rules Committee.

23 B. In the event of the convening of a special session of the General Assembly, only bills relating to
24 the stated purpose of such special session and resolutions affecting the rules of procedure or schedule of
25 business of the General Assembly may be prefiled as provided in subsection A of this section beginning
26 on the day on which either (i) the Governor announces the date on which such special session is to
27 convene, or (ii) two-thirds of the members elected to each house of the General Assembly make
28 application to the Governor for the convening of such special session.

29 C. The Clerks of the House of Delegates and Senate shall assign numbers to prefiled bills and
30 resolutions in the order of their receipt, refer them to the appropriate committee with the advice of the
31 Speaker of the House of Delegates, in the case of House bills, and in the case of Senate bills, in
32 accordance with the Rules of the Senate, and have a sufficient number of them printed for circulation as
33 provided in this section.

34 D. Printed prefiled bills and resolutions shall be periodically mailed to each member and
35 member-elect of the General Assembly and shall be made available to the press and public in the same
36 manner as bills and resolutions introduced after the General Assembly convenes.

37 **2. That the provisions of this act shall expire on July 1, 2014.**
