WHEREAS, the staff at Don's Auto Exchange has been very loyal to the company, boasting a combined century's worth of sales experience; as the dealership has grown it has remained a family business as Donnie Keene's wife and children enjoy helping out at the company; and

WHEREAS, Donnie Keene's strong emphasis on customer satisfaction has resulted in a great deal of
 repeat business; over the years, many customers, their children, and grandchildren have bought cars from
 Don's Auto Exchange; and
