8. Fiscal Implications: According to Department of General Service (DGS), this bill creates an in-state certification preference for Virginia small businesses. In-state preferences could limit competition and result in the increased costs of goods and services. In addition, preference procurements can increase administrative processing time and delay procurement awards, resulting in increased resource costs for all public bodies falling under the Virginia Public Procurement Act.

Department of Minority Business Enterprises (DMBE) states that it would require that the agency hire a minimum of five additional staff for FY 2013 at a cost of \$40,000 per person (\$200,000) to go back and reclassify the existing firms and maintain this staff going forward in order to handle the additional caseload. A classification system would have to be developed since Virginia firms are allowed a minimum of 10 NAICS codes in DMBE databases, so each firm's paperwork would have to be checked for multiple categories under the federal classification. According to DBME, there would also be a requirement to make

some database modifications to manage the number of documents expected to be received and also additional scanning would be necessary with a cost of \$80,000 for two years due to the level of the change needed. The agency indicates that it would need to hire one IT project manager to oversee the database revision at a cost of \$70,000 for both FY 2013 and FY 2014. After FY 2014, it is indicated that this IT project manager will no longer be needed as the system should be up-running.
