WHEREAS, J.W. Alvey Elementary School, which will celebrate its 10th anniversary of serving the families of Haymarket in Prince William County in 2013, has implemented numerous local and international humanitarian initiatives; and

WHEREAS, J.W. Alvey Elementary School, named for Prince William County leader James Alvey, has 48 teachers and 790 students from the neighborhoods of Dominion Valley and Carterwood; and

WHEREAS, J.W. Alvey Elementary School, under the leadership of principal Candace Rotruck, has a proud history of community service and academic excellence; and

WHEREAS, following the tsunami that devastated many of the countries bordering the Indian Ocean in 2004, a fifth-grade class wanted to help the affected people; their desire blossomed into the school's first walk-a-thon, which raised over \$26,000 for the Red Cross to aid tsunami victims; and

WHEREAS, J.W. Alvey Elementary School students raised money to purchase a car for a family displaced by Hurricane Katrina during the school's second walk-a-thon in 2005; and

WHEREAS, in the third year of the walk-a-thon, J.W. Alvey Elementary School students donated proceeds to the building of the Pentagon Memorial; the school's Singing Sunrays chorus performed at the dedication of the memorial; and

WHEREAS, J.W. Alvey Elementary School students have also raised funds for the American Heart Association, Transitional Housing Barn, and Leukemia and Lymphoma Society; and

WHEREAS, since its opening in 2003, J.W. Alvey Elementary School has been named a Prince William County School of Excellence seven years in a row, designated as a Fully Accredited School by the Commonwealth of Virginia, and recognized as a School of Excellence by the Prince William County School Board; and

WHEREAS, J.W. Alvey Elementary School also provides several extracurricular programs for students, such as Singing Sunrays, Chess Club, Fit Club, and Robotics Club, to enhance their education; students can also serve as peer mediators, safety patrols, and class ambassadors; and

WHEREAS, J.W. Alvey Elementary School has an in-house Start Program for potentially gifted students in kindergarten through grade three and an in-house Signet Program for gifted students in grades four and five; and

WHEREAS, J.W. Alvey Elementary School takes great pride in its students' accomplishments and development of compassion and concern for others around the world, holding a monthly Quality Student Breakfast in which students are recognized for being good citizens; now, therefore, be it
