6	A BILL to amend the Code of Virginia by adding in Chapter 10.1 of Title 33.1 a section numbered
7	33.1-391.5:1, relating to the Telework Grant Program.
8	Be it enacted by the General Assembly of Virginia:
9	1. That the Code of Virginia is amended by adding in Chapter 10.1 of Title 33.1 a section
10	numbered 33.1-391.5:1 as follows:
11	§ 33.1-391.5:1. Telework Grant Program established.
12	A. As used in this section, unless the context requires a different meaning:
13	"Department" means the Department of Rail and Public Transportation.
14	"Telework" means the performance of normal and regular work functions by an employee on a
15	workday at a location different from the place where work functions are normally performed and that is
16	within or closer to the employee's residence. The term "telework" shall not include performance of work
17	functions for a home-based business or by an individual who is self-employed. The term "telework" shall
18	also not include extensions of the workday or work performed on a weekend or holiday.
19	B. From such funds as may be appropriated by the General Assembly, there is hereby created in the
20	state treasury a special nonreverting fund to be known as the Telework Grant Fund, hereafter referred
21	to as "the Fund." The Fund shall be established on the books of the Comptroller. All interest earned on
22	moneys in the Fund shall remain in the Fund and be credited to it. Any moneys remaining in the Fund,
23	including interest thereon, at the end of each fiscal year shall not revert to the general fund but shall
24	remain in the Fund. Moneys in the Fund shall be used solely for the purposes of grants to qualified
25	individuals who telework. Expenditures and disbursements from the Fund shall be made by the State
26	Treasurer on warrants issued by the Comptroller upon written request signed by the Director.
27	C. An individual shall be eligible to apply to the Department for a \$250 grant if the individual
28	teleworks at least 20 hours a week during at least 45 weeks of the immediately preceding calendar year.
29	The application shall include a certification from the individual's employer to the Department, on such a
30	form or in such a manner as specified by the Department, that the individual teleworked at least 20
31	hours a week during at least 45 weeks for such employer in the taxable year for which the individual is
32	applying for credit under this section.
33	D. Grants shall be issued in the order that each completed application is received. In the event that
34	the amount of eligible grants requested in a fiscal year exceeds the funds available in the Fund, such
25	grants shall be paid in the part fiscal year in which funds are available

grants shall be paid in the next fiscal year in which funds are available.
E. The Department shall develop guidelines concerning the administration of the grant program.
2. That the provisions of this act shall not become effective unless an appropriation of general funds effectuating the purposes of this act is included in a general appropriation act passed by the 2013 Session of the General Assembly, which becomes law. 38 39
