2 *An Act to amend and reenact § 2.2-2614 of the Code of Virginia, relating to the Citizens' Advisory*

6 **Be it enacted by the General Assembly of Virginia:**7 **1. That § 2.2-2614 of the Code of Virginia is amended and reenacted as follows:**8 **§ 2.2-2614. Citizens' Advisory Council on Furnishing and Interpreting the Executive Mansion;**  
9 **purpose as a nonprofit charitable organization; membership; terms; officers and executive groups;**  
10 **compensation.**11 A. The Citizens' Advisory Council on Furnishing and Interpreting the Executive Mansion (the  
12 "Council") is established as an advisory council in the executive branch of state government to operate  
13 as a nonprofit charitable organization. No part of the Council's net earnings shall inure to the benefit of  
14 any private individual nor shall it carry on propaganda or otherwise attempt to influence legislation or  
15 participate in any political campaign on behalf of any candidate for public office.16 B. The Council shall not exceed ~~thirty~~ 30 members, who shall be appointed by the Governor. No  
17 employee of the Commonwealth or member of the General Assembly shall be eligible for appointment  
18 as a member of the Council. All members shall be deemed members-at-large charged with the  
19 responsibility of serving the best interests of the whole Commonwealth and no member shall act as  
20 representative of any particular region or of any particular agency or activity.21 C. ~~Of the members first appointed, nine shall be appointed for terms of one year, nine for terms of~~  
22 ~~three years, and the remaining number for terms of five years. After the original appointments, all~~ All  
23 appointments shall be for five-year terms. No member of the Council who serves a full five-year term  
24 shall be eligible for reappointment; provided, that one year after the termination of his ~~or her~~  
25 appointment, a member shall be eligible for reappointment. All vacancies shall be filled for the  
26 unexpired term in the same manner as the original appointments.27 D. The spouse of the Governor, if any, shall be the honorary chairperson of the Council. The  
28 Governor shall designate one member of the Council to serve as chairman of an executive group, such  
29 executive group to be determined by the Council, and to be composed of members of the Council. Other  
30 advisory and cooperative groups may be appointed by the chairman. After the chairman has served three  
31 years, the Council thereafter shall elect its chairman.32 E. Members of the Council shall not receive any compensation or reimbursement of expenses for  
33 their services.34 **2. That the terms of the members of the Citizens' Advisory Council on Furnishing and**  
35 **Interpreting the Executive Mansion shall be re-staggered as follows: (i) for the terms that are**  
36 **scheduled to expire on March 31, 2014, six members shall be appointed for a term of five years**  
37 **and two members shall be appointed for a term of six years; (ii) for the terms that are scheduled**  
38 **to expire on March 31, 2016, four members shall be appointed for a term of four years and four**  
39 **members shall be appointed for a term of five years; (iii) for the terms that are scheduled to**  
40 **expire on March 31, 2018, six members shall be appointed for a term of five years, six members**  
41 **shall be appointed for a term of four years, and two members shall be appointed for a term of**  
42 **three years. Thereafter, all terms shall be for five years.**
