WHEREAS, a dedicated educator, Harriet Mika encouraged students to excel in all of their endeavors and earned the respect of parents, colleagues, and school administrators for her commitment to high quality education; and

WHEREAS, Harriet Mika took an active role in community affairs as a longtime member of the Fairfax County Democratic Committee and Woman's National Democratic Club; and

WHEREAS, in retirement, Harriet Mika had the unique opportunity to give of her time and talents as a volunteer for President William Clinton's first transition into office; and

WHEREAS, Harriet Mika also provided valuable assistance through her work for the United States Department of Agriculture and at the Audrey Moore RECenter at Wakefield Park during retirement; and

WHEREAS, Harriet Mika enjoyed fellowship and worship at the Church of the Good Shepherd and later at St. Barnabas' Episcopal Church; she served as a vestry and altar guild member for both congregations; and

WHEREAS, Harriet Mika touched the lives of countless individuals over the course of her well-lived life with her kind and caring nature, dedication to her students, and commitment to helping those around her: and
