That §§ 4.1-100, 4.1-206, 4.1-231, and 4.1-233 of the Code of Virginia are amended and 10 reenacted as follows: 11 12 § 4.1-100. Definitions. 13 As used in this title unless the context requires a different meaning: 14 "Alcohol" means the product known as ethyl or grain alcohol obtained by distillation of any 15 fermented liquor, rectified either once or more often, whatever the origin, and shall include synthetic 16 ethyl alcohol, but shall not include methyl alcohol and alcohol completely denatured in accordance with formulas approved by the government of the United States. 17 "Alcohol vaporizing device" means any device, machine, or process that mixes any alcoholic 18 19 beverages with pure oxygen or other gas to produce a vaporized product for the purpose of consumption 20 by inhalation. 21 "Alcoholic beverages" includes alcohol, spirits, wine, and beer, and any one or more of such varieties 22 containing one-half of one percent or more of alcohol by volume, including mixed alcoholic beverages, 23 and every liquid or solid, patented or not, containing alcohol, spirits, wine, or beer and capable of being 24 consumed by a human being. Any liquid or solid containing more than one of the four varieties shall be 25 considered as belonging to that variety which has the higher percentage of alcohol, however obtained, according to the order in which they are set forth in this definition; except that beer may be 26 27 manufactured to include flavoring materials and other nonbeverage ingredients containing alcohol, as 28 long as no more than 49 percent of the overall alcohol content of the finished product is derived from 29 the addition of flavors and other nonbeverage ingredients containing alcohol for products with an alcohol 30 content of no more than six percent by volume; or, in the case of products with an alcohol content of 31 more than six percent by volume, as long as no more than one and one-half percent of the volume of 32 the finished product consists of alcohol derived from added flavors and other nonbeverage ingredients 33 containing alcohol. 34 "Arts venue" means a commercial or nonprofit establishment that is open to the public and in which 35 works of art are sold or displayed. 36 "Barrel" means any container or vessel having a capacity of more than 43 ounces. 37 "Bed and breakfast establishment" means any establishment (i) having no more than 15 bedrooms; 38 (ii) offering to the public, for compensation, transitory lodging or sleeping accommodations; and (iii) 39 offering at least one meal per day, which may but need not be breakfast, to each person to whom 40 overnight lodging is provided. 41 "Beer" means any alcoholic beverage obtained by the fermentation of an infusion or decoction of barley, malt, and hops or of any similar products in drinkable water and containing one-half of one 42 percent or more of alcohol by volume. 43 44 "Board" means the Virginia Alcoholic Beverage Control Board. "Bottle" means any vessel intended to contain liquids and having a capacity of not more than 43 45 46 ounces. 47 "Canal boat operator" means any nonprofit organization that operates tourism-oriented canal boats for recreational purposes on waterways declared nonnavigable by the United States Congress pursuant to 33 48 49 U.S.C. § 59ii. 50 "Club" means any private nonprofit corporation or association which is the owner, lessee, or 51 occupant of an establishment operated solely for a national, social, patriotic, political, athletic, or other 52 like purpose, but not for pecuniary gain, the advantages of which belong to all of the members. It also 53 means the establishment so operated. A corporation or association shall not lose its status as a club because of the conduct of charitable gaming conducted pursuant to Article 1.1:1 (§ 18.2-340.15 et seq.) 54 55 of Chapter 8 of Title 18.2 in which nonmembers participate frequently or in large numbers, provided that no alcoholic beverages are served or consumed in the room where such charitable gaming is being 56 57 conducted while such gaming is being conducted and that no alcoholic beverages are made available

58 upon the premises to any person who is neither a member nor a bona fide guest of a member.

59 Any such corporation or association which has been declared exempt from federal and state income 60 taxes as one which is not organized and operated for pecuniary gain or profit shall be deemed a nonprofit corporation or association. 61

62 "Container" means any barrel, bottle, carton, keg, vessel or other receptacle used for holding 63 alcoholic beverages.

64 "Contract winemaking facility" means the premises of a licensed winery or farm winery that obtains 65 grapes, fruits, and other agricultural products from a person holding a farm winery license and crushes, processes, ferments, bottles, or provides any combination of such services pursuant to an agreement with 66 the farm winery licensee. For all purposes of this title, wine produced by a contract winemaking facility 67 for a farm winery shall be considered to be wine owned and produced by the farm winery that supplied 68 the grapes, fruits, or other agricultural products used in the production of the wine. The contract 69 winemaking facility shall have no right to sell the wine so produced but may charge the farm winery for 70 71 its services.

72 "Convenience grocery store" means an establishment which (i) has an enclosed room in a permanent 73 structure where stock is displayed and offered for sale and (ii) maintains an inventory of edible items 74 intended for human consumption consisting of a variety of such items of the types normally sold in 75 grocery stores.

76 "Day spa" means any commercial establishment that offers to the public both massage therapy, 77 performed by persons certified in accordance with § 54.1-3029, and barbering or cosmetology services 78 performed by persons licensed in accordance with Chapter 7 (§ 54.1-700 et seq.) of Title 54.1.

79 "Designated area" means a room or area approved by the Board for on-premises licensees.

"Dining area" means a public room or area in which meals are regularly served.

"Establishment" means any place where alcoholic beverages of one or more varieties are lawfully manufactured, sold, or used. 81 82

83 "Farm winery" means an establishment (i) located on a farm in the Commonwealth with a producing vineyard, orchard, or similar growing area and with facilities for fermenting and bottling wine on the 84 85 premises where the owner or lessee manufactures wine that contains not more than 18 percent alcohol by volume or (ii) located in the Commonwealth with a producing vineyard, orchard, or similar growing 86 area or agreements for purchasing grapes or other fruits from agricultural growers within the 87 88 Commonwealth, and with facilities for fermenting and bottling wine on the premises where the owner or 89 lessee manufactures wine that contains not more than 18 percent alcohol by volume. As used in this 90 definition, the terms "owner" and "lessee" shall include a cooperative formed by an association of 91 individuals for the purpose of manufacturing wine. In the event such cooperative is licensed as a farm 92 winery, the term "farm" as used in this definition includes all of the land owned or leased by the individual members of the cooperative as long as such land is located in the Commonwealth. 93

"Gift shop" means any bona fide retail store selling, predominantly, gifts, books, souvenirs, specialty 94 95 items relating to history, original and handmade arts and products, collectibles, crafts, and floral arrangements, which is open to the public on a regular basis. Such shop shall be a permanent structure 96 where stock is displayed and offered for sale and which has facilities to properly secure any stock of 97 98 wine or beer. Such shop may be located (i) on the premises or grounds of a government registered 99 national, state or local historic building or site or (ii) within the premises of a museum. The Board shall 100 consider the purpose, characteristics, nature, and operation of the shop in determining whether it shall be 101 considered a gift shop.

102 "Gourmet brewing shop" means an establishment which sells to persons to whom wine or beer may 103 lawfully be sold, ingredients for making wine or brewing beer, including packaging, and rents to such persons facilities for manufacturing, fermenting and bottling such wine or beer. 104

"Gourmet shop" means an establishment provided with adequate inventory, shelving, and storage 105 facilities, where, in consideration of payment, substantial amounts of domestic and imported wines and 106 107 beers of various types and sizes and related products such as cheeses and gourmet foods are habitually 108 furnished to persons. 109

"Government store" means a store established by the Board for the sale of alcoholic beverages.

"Hotel" means any duly licensed establishment, provided with special space and accommodation, 110 where, in consideration of payment, food and lodging are habitually furnished to persons, and which has 111 112 four or more bedrooms. It shall also mean the person who operates such hotel.

113 "Interdicted person" means a person to whom the sale of alcoholic beverages is prohibited by order 114 pursuant to this title.

115 "Internet wine retailer" means a person who owns or operates an establishment with adequate inventory, shelving, and storage facilities, where, in consideration of payment, internet or telephone 116 117 orders are taken and shipped directly to consumers and which establishment is not a retail store open to 118 the public.

119 'Intoxicated" means a condition in which a person has drunk enough alcoholic beverages to 120 observably affect his manner, disposition, speech, muscular movement, general appearance or behavior.

121 "Licensed" means the holding of a valid license issued by the Board. 122

"Licensee" means any person to whom a license has been granted by the Board.

123 "Liqueur" means any of a class of highly flavored alcoholic beverages that do not exceed an alcohol 124 content of 25 percent by volume.

125 "Low alcohol beverage cooler" means a drink containing one-half of one percent or more of alcohol 126 by volume, but not more than seven and one-half percent alcohol by volume, and consisting of spirits 127 mixed with nonalcoholic beverages or flavoring or coloring materials; it may also contain water, fruit 128 juices, fruit adjuncts, sugar, carbon dioxide, preservatives or other similar products manufactured by 129 fermenting fruit or fruit juices. Low alcohol beverage coolers shall be treated as wine for all purposes of 130 this title; except that low alcohol beverage coolers shall not be sold in localities that have not approved 131 the sale of mixed beverages pursuant to \S 4.1-124. In addition, low alcohol beverage coolers shall not be 132 sold for on-premises consumption other than by mixed beverage licensees.

"Meal-assembly kitchen" means any commercial establishment that offers its customers, for 133 134 off-premises consumption, ingredients for the preparation of meals and entrees in professional kitchen 135 facilities located at the establishment.

136 "Meals" means, for a mixed beverage license, an assortment of foods commonly ordered in bona 137 fide, full-service restaurants as principal meals of the day. Such restaurants shall include establishments 138 specializing in full course meals with a single substantial entree.

139 "Member of a club" means (i) a person who maintains his membership in the club by the payment of 140 monthly, quarterly, or annual dues in the manner established by the rules and regulations thereof or (ii) 141 a person who is a member of a bona fide auxiliary, local chapter, or squadron composed of direct lineal 142 descendants of a bona fide member, whether alive or deceased, of a national or international 143 organization to which an individual lodge holding a club license is an authorized member in the same 144 locality. It shall also mean a lifetime member whose financial contribution is not less than 10 times the 145 annual dues of resident members of the club, the full amount of such contribution being paid in advance 146 in a lump sum.

147 "Mixed beverage" or "mixed alcoholic beverage" means a drink composed in whole or in part of 148 spirits.

149 "Mixer" means any prepackaged ingredients containing beverages or flavoring or coloring materials, 150 and which may also contain water, fruit juices, fruit adjuncts, sugar, carbon dioxide, or preservatives 151 which are not commonly consumed unless combined with alcoholic beverages, whether or not such 152 ingredients contain alcohol. Such specialty beverage product shall be manufactured or distributed by a 153 Virginia corporation.

154 "Place or premises" means the real estate, together with any buildings or other improvements thereon, 155 designated in the application for a license as the place at which the manufacture, bottling, distribution, 156 use or sale of alcoholic beverages shall be performed, except that portion of any such building or other 157 improvement actually and exclusively used as a private residence.

158 "Public place" means any place, building, or conveyance to which the public has, or is permitted to 159 have, access, including restaurants, soda fountains, hotel dining areas, lobbies and corridors of hotels, 160 and any park, place of public resort or amusement, highway, street, lane, or sidewalk adjoining any 161 highway, street, or lane.

162 The term shall not include (i) hotel or restaurant dining areas or ballrooms while in use for private 163 meetings or private parties limited in attendance to members and guests of a particular group, 164 association or organization; (ii) restaurants licensed by the Board in office buildings or industrial or 165 similar facilities while such restaurant is closed to the public and in use for private meetings or parties 166 limited in attendance to employees and nonpaying guests of the owner or a lessee of all or part of such 167 building or facility; (iii) offices, office buildings or industrial facilities while closed to the public and in use for private meetings or parties limited in attendance to employees and nonpaying guests of the 168 owner or a lessee of all or part of such building or facility; or (iv) private recreational or chartered boats 169 170 which are not licensed by the Board and on which alcoholic beverages are not sold.

171 "Residence" means any building or part of a building or structure where a person resides, but does 172 not include any part of a building which is not actually and exclusively used as a private residence, nor 173 any part of a hotel or club other than a private guest room thereof.

174 "Resort complex" means a facility (i) with a hotel owning year-round sports and recreational facilities 175 located contiguously on the same property or (ii) owned by a nonstock, nonprofit, taxable corporation 176 with voluntary membership which, as its primary function, makes available golf, ski and other 177 recreational facilities both to its members and the general public. The hotel or corporation shall have a 178 minimum of 140 private guest rooms or dwelling units contained on not less than 50 acres. The Board 179 may consider the purpose, characteristics, and operation of the applicant establishment in determining whether it shall be considered as a resort complex. All other pertinent qualifications established by the 180 181 Board for a hotel operation shall be observed by such licensee.

182 "Restaurant" means, for a beer, or wine and beer license or a limited mixed beverage restaurant 183 license, any establishment provided with special space and accommodation, where, in consideration of 184 payment, meals or other foods prepared on the premises are regularly sold.

185 "Restaurant" means, for a mixed beverage license other than a limited mixed beverage restaurant 186 license, an established place of business (i) where meals with substantial entrees are regularly sold and (ii) which has adequate facilities and sufficient employees for cooking, preparing, and serving such 187 188 meals for consumption at tables in dining areas on the premises, and includes establishments specializing 189 in full course meals with a single substantial entree.

"Sale" and "sell" includes soliciting or receiving an order for; keeping, offering or exposing for sale; 190 191 peddling, exchanging or bartering; or delivering otherwise than gratuitously, by any means, alcoholic 192 beverages.

"Sangria" means a drink consisting of red or white wine mixed with some combination of 193 194 sweeteners, fruit, fruit juice, soda, or soda water that may also be mixed with brandy, triple sec, or other 195 similar spirits.

196 "Special agent" means an employee of the Department of Alcoholic Beverage Control whom the 197 Board has designated as a law-enforcement officer pursuant to § 4.1-105.

198 "Special event" means an event sponsored by a duly organized nonprofit corporation or association 199 and conducted for an athletic, charitable, civic, educational, political, or religious purpose.

200 "Spirits" means any beverage which contains alcohol obtained by distillation mixed with drinkable 201 water and other substances, in solution, and includes, among other things, brandy, rum, whiskey, and 202 gin, or any one or more of the last four named ingredients; but shall not include any such liquors 203 completely denatured in accordance with formulas approved by the United States government.

"Wine" means any alcoholic beverage obtained by the fermentation of the natural sugar content of 204 fruits or other agricultural products containing (i) sugar, including honey and milk, either with or 205 206 without additional sugar; (ii) one-half of one percent or more of alcohol by volume; and (iii) no product of distillation. The term includes any wine to which wine spirits have been added, as provided in the 207 Internal Revenue Code, to make products commonly known as "fortified wine" which do not exceed an 208 209 alcohol content of 21 percent by volume.

210 "Wine cooler" means a drink containing one-half of one percent or more of alcohol by volume, and not more than three and two-tenths percent of alcohol by weight or four percent by volume consisting of 211 212 wine mixed with nonalcoholic beverages or flavoring or coloring materials, and which may also contain 213 water, fruit juices, fruit adjuncts, sugar, carbon dioxide, or preservatives and shall include other similar 214 products manufactured by fermenting fruit or fruit juices. Wine coolers and similar fermented fruit juice 215 beverages shall be treated as wine for all purposes except for taxation under § 4.1-236.

"With or without meals" means the selling and serving of alcoholic beverages by retail licensees for 216 217 on-premises consumption whether or not accompanied by food so long as the total food-beverage ratio 218 required by § 4.1-210, or the monthly food sale requirement established by Board regulation, is met by 219 such retail licensee. 220

§ 4.1-206. Alcoholic beverage licenses.

The Board may grant the following licenses relating to alcoholic beverages generally:

1. Distillers' licenses, which shall authorize the licensee to manufacture alcoholic beverages other 222 than wine and beer, and to sell and deliver or ship the same, in accordance with Board regulations, in 223 224 closed containers, to the Board and to persons outside the Commonwealth for resale outside the 225 Commonwealth. When the Board has established a government store on the distiller's licensed premises 226 pursuant to subsection D of § 4.1-119, such license shall also authorize the licensee to make a charge to 227 consumers to participate in an organized tasting event conducted in accordance with subsection G of 228 § 4.1-119 and Board regulations.

229 2. Fruit distillers' licenses, which shall authorize the licensee to manufacture any alcoholic beverages 230 made from fruit or fruit juices, and to sell and deliver or ship the same, in accordance with Board 231 regulations, in closed containers, to the Board and to persons outside the Commonwealth for resale 232 outside the Commonwealth.

233 3. Banquet facility licenses to volunteer fire departments and volunteer rescue squads, which shall 234 authorize the licensee to permit the consumption of lawfully acquired alcoholic beverages on the premises of the licensee by any person, and bona fide members and guests thereof, otherwise eligible for 235 236 a banquet license. However, lawfully acquired alcoholic beverages shall not be purchased or sold by the 237 licensee or sold or charged for in any way by the person permitted to use the premises. Such premises 238 shall be a fire or rescue squad station or both, regularly occupied as such and recognized by the 239 governing body of the county, city or town in which it is located. Under conditions as specified by 240 Board regulation, such premises may be other than a fire or rescue squad station, provided such other premises are occupied and under the control of the fire department or rescue squad while the privileges 241 242 of its license are being exercised.

243 4. Bed and breakfast licenses, which shall authorize the licensee to serve alcoholic beverages in

dining areas, private guest rooms and other designated areas to persons to whom overnight lodging is
being provided, with or without meals, for on-premises consumption only in such rooms and areas, and
without regard to the amount of gross receipts from the sale of food prepared and consumed on the
premises.

5. Tasting licenses, which shall authorize the licensee to sell or give samples of alcoholic beverages
of the type specified in the license in designated areas at events held by the licensee. A tasting license
shall be issued for the purpose of featuring and educating the consuming public about the alcoholic
beverages being tasted. A separate license shall be required for each day of each tasting event. No
tasting license shall be required for conduct authorized by § 4.1-201.1.

6. Museum licenses, which may be issued to nonprofit museums exempt from taxation under
§ 501(c)(3) of the Internal Revenue Code, which shall authorize the licensee to (i) permit the
consumption of lawfully acquired alcoholic beverages on the premises of the licensee by any bona fide
member and guests thereof and (ii) serve alcoholic beverages on the premises of the licensee to any
bona fide member and guests thereof. However, alcoholic beverages shall not be sold or charged for in
any way by the licensee. The privileges of this license shall be limited to the premises of the museum,
regularly occupied and utilized as such.

260 7. Equine sporting event licenses, which may be issued to organizations holding equestrian, hunt and
261 steeplechase events, which shall authorize the licensee to permit the consumption of lawfully acquired
262 alcoholic beverages on the premises of the licensee by patrons thereof during such event. However,
263 alcoholic beverages shall not be sold or charged for in any way by the licensee. The privileges of this
264 license shall be (i) limited to the premises of the licensee, regularly occupied and utilized for equestrian,
265 hunt and steeplechase events and (ii) exercised on no more than four calendar days per year.

8. Day spa licenses, which shall authorize the licensee to (i) permit the consumption of lawfully acquired wine or beer on the premises of the licensee by any bona fide customer of the day spa and (ii) serve wine or beer on the premises of the licensee to any such bona fide customer; however, the licensee shall not give more than two five-ounce glasses of wine or one 12-ounce glass of beer to any such customer, nor shall it sell or otherwise charge a fee to such customer for the wine or beer served or consumed. The privileges of this license shall be limited to the premises of the day spa regularly occupied and utilized as such.

9. Motor car sporting event facility licenses, which shall authorize the licensee to permit the consumption of lawfully acquired alcoholic beverages on the premises of the licensee by patrons thereof during such events. However, alcoholic beverages shall not be sold or charged for in any way, directly or indirectly, by the licensee. The privileges of this license shall be limited to those areas of the licensee's premises designated by the Board that are regularly occupied and utilized for motor car sporting events.

10. Meal-assembly kitchen license, which shall authorize the licensee to serve wine or beer on the
premises of the licensee to any such bona fide customer attending either a private gathering or a special
event; however, the licensee shall not give more than two five-ounce glasses of wine or two 12-ounce
glasses of beer to any such customer, nor shall it sell or otherwise charge a fee to such customer for the
wine or beer served or consumed. The privileges of this license shall be limited to the premises of the
meal-assembly kitchen regularly occupied and utilized as such.

285 11. Canal boat operator license, which shall authorize the licensee to permit the consumption of 286 lawfully acquired alcoholic beverages on the premises of the licensee by any bona fide customer 287 attending either a private gathering or a special event; however, the licensee shall not sell or otherwise 288 charge a fee to such customer for the alcoholic beverages so consumed. The privileges of this license 289 shall be limited to the premises of the licensee, including the canal, the canal boats while in operation, 290 and any pathways adjacent thereto. Upon authorization of the licensee, any person may keep and 291 consume his own lawfully acquired alcoholic beverages on the premises in all areas and locations 292 covered by the license.

293 12. Annual arts venue event licenses, to persons operating an arts venue, which shall authorize the 294 licensee participating in a community art walk [or open house event] that is open to the public to 295 serve lawfully acquired wine or beer on the premises of the licensee to adult patrons thereof during 296 such events. However, alcoholic beverages shall not be sold or charged for in any way, directly or 297 indirectly, by the licensee, and the licensee shall not give more than two five-ounce glasses of wine or 298 one 12-ounce glass of beer to any one adult patron. The privileges of this license shall be (i) limited to 299 the premises of the arts venue regularly occupied and used as such and (ii) exercised on no more than 12 calendar days per year. 300

(1) Wholesale wine license, \$185 for any wholesaler who sells 30,000 gallons of wine or less per year, \$930 for any wholesaler who sells more than 30,000 gallons per year but not more than 150,000 322 323 gallons of wine per year, \$1,430 for any wholesaler who sells more than 150,000 but not more than 324 300,000 gallons of wine per year, and, \$1,860 for any wholesaler who sells more than 300,000 gallons 325 of wine per year;
- 326 (2) Wholesale wine license, including that granted pursuant to § 4.1-207.1, applicable to two or more 327 premises, the annual state license tax shall be the amount set forth in subdivision b (1), multiplied by 328 the number of separate locations covered by the license;
- 329 c. Wine importer's license, \$370; 330
 - d. Retail off-premises winery license, \$145, which shall include a delivery permit;
- e. Farm winery license, \$190 for any Class A license and \$3,725 for any Class B license, each of 331 332 which shall include a delivery permit;
- 333 f. Wine shipper's license, \$95; and
 - g. Internet wine retailer license, \$150.

336 a. Brewery license, if not more than 10,000 barrels of beer manufactured during the year in which 337 the license is granted, \$2,150, and if more than 10,000 barrels manufactured during such year, \$4,300; 338

b. Bottler's license, \$1,430;

(1) Wholesale beer license, \$930 for any wholesaler who sells 300,000 cases of beer a year or 340 less, and \$1,430 for any wholesaler who sells more than 300,000 but not more than 600,000 cases of 341 beer a year, and \$1,860 for any wholesaler who sells more than 600,000 cases of beer a year;

(2) Wholesale beer license applicable to two or more premises, the annual state license tax shall be 342 343 the amount set forth in subdivision c (1), multiplied by the number of separate locations covered by the 344 license; 345

d. Beer importer's license, \$370;

346 e. Retail on-premises beer license to a hotel, restaurant, club or other person, except a common 347 carrier of passengers by train or boat, \$145; for each such license to a common carrier of passengers by 348 train or boat, \$145 per annum for each of the average number of boats, dining cars, buffet cars or club 349 cars operated daily in the Commonwealth; 350

f. Retail off-premises beer license, \$120, which shall include a delivery permit;

351 g. Retail on-and-off premises beer license to a hotel, restaurant, club or grocery store located in a 352 town or in a rural area outside the corporate limits of any city or town, \$300, which shall include a 353 delivery permit; 354

- h. Beer shipper's license, \$95; and
- i. Retail off-premises brewery license, \$120, which shall include a delivery permit.

The tax on each such license, except banquet and mixed beverage special events licenses, shall be 410 subject to protation to the following extent: If the license is granted in the second quarter of any year, 411 the tax shall be decreased by one-fourth; if granted in the third quarter of any year, the tax shall be 412 decreased by one-half; and if granted in the fourth quarter of any year, the tax shall be decreased by 413 three-fourths.
- 414 If the license on which the tax is prorated is a distiller's license to manufacture not more than 5,000 415 gallons of alcohol or spirits, or both, during the year in which the license is granted, or a winery license 416 to manufacture not more than 5,000 gallons of wine during the year in which the license is granted, the 417 number of gallons permitted to be manufactured shall be prorated in the same manner.
- 418 Should the holder of a distiller's license or a winery license to manufacture not more than 5,000 419 gallons of alcohol or spirits, or both, or wine, apply during the license year for an unlimited distiller's or 420 winery license, such person shall pay for such unlimited license a license tax equal to the amount that 421 would have been charged had such license been applied for at the time that the license to manufacture 422 less than 5,000 gallons of alcohol or spirits or wine, as the case may be, was granted, and such person 423 shall be entitled to a refund of the amount of license tax previously paid on the limited license.
- 424 Notwithstanding the foregoing, the tax on each license granted or reissued for a period of less than 425 12 months shall be equal to one-twelfth of the taxes required by subsection A computed to the nearest 426 cent, multiplied by the number of months in the license period.
- 427 C. Nothing in this chapter shall exempt any licensee from any state merchants' license or state

428 restaurant license or any other state tax. Every licensee, in addition to the taxes imposed by this chapter, 429 shall be liable to state merchants' license taxation and state restaurant license taxation and other state 430 taxation the same as if the alcoholic beverages were nonalcoholic. In ascertaining the liability of a beer 431 wholesaler to merchants' license taxation, however, and in computing the wholesale merchants' license 432 tax on a beer wholesaler, the first \$163,800 of beer purchases shall be disregarded; and in ascertaining 433 the liability of a wholesale wine distributor to merchants' license taxation, and in computing the 434 wholesale merchants' license tax on a wholesale wine distributor, the first \$163,800 of wine purchases 435 shall be disregarded.

§ 4.1-233. Taxes on local licenses.

437 A. In addition to the state license taxes, the annual local license taxes which may be collected shall 438 not exceed the following sums:

439 1. Alcoholic beverages. - For each:

440 a. Distiller's license, \$1,000; no local license shall be required for any person who manufactures not more than 5,000 gallons of alcohol or spirits, or both, during such license year; 441

- b. Fruit distiller's license, \$1,500; 442

- 444 d. Museum license, \$10;
- e. Tasting license, \$5 per license granted; 445
- 446 f. Equine sporting event license, \$10;

- 449 i. Meal-assembly kitchen license, \$20; and
- 450 j. Canal boat operator license, \$20; and
- k. Annual arts venue event license. \$20. 451
- 452 2. Beer. - For each:
- 453 a. Brewery license, \$1,000;
- b. Bottler's license, \$500; 454
- 455 c. Wholesale beer license, in a city, \$250, and in a county or town, \$75;

456 d. Retail on-premises beer license for a hotel, restaurant or club and for each retail off-premises beer 457 license in a city, \$100, and in a county or town, \$25; and

- 458 e. Beer shipper's license, \$10.
- 459 3. Wine. - For each:
- 460 a. Winery license, \$50;
- 461 b. Wholesale wine license, \$50;
- 462 c. Farm winery license, \$50; and
- d. Wine shipper's license, \$10. 463
- 464 4. Wine and beer. - For each:

465 a. Retail on-premises wine and beer license for a hotel, restaurant or club; and for each retail **466** off-premises wine and beer license, including each gift shop, gourmet shop and convenience grocery store license, in a city, \$150, and in a county or town, \$37.50; 467

468 b. Hospital license, \$10;

469 c. Banquet license, \$5 for each license granted, except for banquet licenses granted by the Board 470 pursuant to subsection A of § 4.1-215 for events occurring on more than one day, which shall be \$20 471 per license;

- 472 d. Gourmet brewing shop license, \$150;
- 473 e. Wine and beer shipper's license, \$10;
- f. Annual banquet license, \$15; and 474
- g. Gourmet oyster house license, in a city, \$150, and in a county or town, \$37.50. 5. Mixed beverages. For each: 475
- 476

477 a. Mixed beverage restaurant license, including restaurants located on the premises of and operated 478 by hotels or motels, or other persons:

- 479 (i) With a seating capacity at tables for up to 100 persons, \$200;
- 480 (ii) With a seating capacity at tables for more than 100 but not more than 150 persons, \$350; and
- (iii) With a seating capacity at tables for more than 150 persons, \$500. 481
- 482 b. Private, nonprofit club operating a restaurant located on the premises of such club, \$350;
- 483 c. Mixed beverage caterer's license, \$500;
- d. Mixed beverage limited caterer's license; \$100; 484
- 485 e. Mixed beverage special events licenses, \$10 for each day of each event;
- f. Mixed beverage club events licenses, \$10 for each day of each event; 486
- 487 g. Annual mixed beverage amphitheater license, \$300;
- 488 h. Annual mixed beverage motor sports race track license, \$300;
- 489 i. Annual mixed beverage banquet license, \$75;

490 j. Limited mixed beverage restaurant license:

(i) With a seating capacity at tables for up to 100 persons, \$100;

(ii) With a seating capacity at tables for more than 100 but not more than 150 persons, \$250;

493 (iii) With a seating capacity at tables for more than 150 persons, \$400;

494 k. Annual mixed beverage motor sports facility license, \$300; and

495 1. Annual mixed beverage performing arts facility license; \$300.

B. Common carriers. - No local license tax shall be either charged or collected for the privilege of
selling alcoholic beverages in (i) passenger trains, boats or airplanes and (ii) rooms designated by the
Board of establishments of air carriers of passengers at airports in the Commonwealth for on-premises
consumption only.

500 C. Merchants' and restaurants' license taxes. - The governing body of each county, city or town in 501 the Commonwealth, in imposing local wholesale merchants' license taxes measured by purchases, local 502 retail merchants' license taxes measured by sales, and local restaurant license taxes measured by sales, 503 may include alcoholic beverages in the base for measuring such local license taxes the same as if the alcoholic beverages were nonalcoholic. No local alcoholic beverage license authorized by this chapter 504 505 shall exempt any licensee from any local merchants' or local restaurant license tax, but such local merchants' and local restaurant license taxes may be in addition to the local alcoholic beverage license 506 507 taxes authorized by this chapter.

508 The governing body of any county, city or town, in adopting an ordinance under this section, shall 509 provide that in ascertaining the liability of (i) a beer wholesaler to local merchants' license taxation 510 under the ordinance, and in computing the local wholesale merchants' license tax on such beer 511 wholesaler, purchases of beer up to a stated amount shall be disregarded, which stated amount shall be 512 the amount of beer purchases which would be necessary to produce a local wholesale merchants' license 513 tax equal to the local wholesale beer license tax paid by such wholesaler and (ii) a wholesale wine 514 licensee to local merchants' license taxation under the ordinance, and in computing the local wholesale 515 merchants' license tax on such wholesale wine licensee, purchases of wine up to a stated amount shall 516 be disregarded, which stated amount shall be the amount of wine purchases which would be necessary 517 to produce a local wholesale merchants' license tax equal to the local wholesale wine licensee license tax 518 paid by such wholesale wine licensee.

519 D. Delivery. - No county, city or town shall impose any local alcoholic beverages license tax on any
520 wholesaler for the privilege of delivering alcoholic beverages in the county, city or town when such
521 wholesaler maintains no place of business in such county, city or town.

E. Application of county tax within town. - Any county license tax imposed under this section shall
not apply within the limits of any town located in such county, where such town now, or hereafter,
imposes a town license tax on the same privilege.
