5 **Be it enacted by the General Assembly of Virginia:**6 **1. That § 29.1-525 of the Code of Virginia is amended and reenacted as follows:**7 **§ 29.1-525. Employment of lights under certain circumstances upon places used by deer.**8 A. Any person in any vehicle and then in possession of any firearm, crossbow, bow and arrow or
9 speargun who employs a light attached to the vehicle or a spotlight or flashlight to cast a light beyond
10 the water or surface of the roadway upon any place used by deer shall be guilty of a Class 2
11 misdemeanor. Every person in or on any such vehicle shall be deemed prima facie a principal in the
12 second degree and subject to the same punishment as a principal in the first degree. This subsection
13 shall not apply to a landowner in possession of a weapon when he is on his own land and is making a
14 bona fide effort to protect his property from damage by deer and not for the purpose of killing deer
15 unless the landowner is in possession of a permit to do so pursuant to the provisions of § 29.1-529.16 B. Any person in any motor vehicle who deliberately employs a light attached to such vehicle or a
17 spotlight or flashlight to cast a light beyond the surface of the roadway upon any place used by deer,
18 except upon his own land or upon land on which he has an easement or permission for such purpose,
19 shall be guilty of a Class 4 misdemeanor. Every person in or on any such vehicle shall be deemed
20 prima facie a principal in the second degree and subject to the same punishment as a principal in the
21 first degree.22 C. *The provisions of subsections A and B shall not apply to activities conducted by a locality*
23 *pursuant to a permit or written authorization issued by the Department.*24 D. In addition to the penalties prescribed in subsection A, the court shall revoke the current hunting
25 license and privileges of the person convicted of a violation of subsection A and prohibit the person
26 from hunting for a period of one to five years. In addition to the penalties prescribed in subsection B,
27 the court may revoke the current hunting license and privileges of the person convicted of a violation of
28 subsection B and prohibit that person from hunting for one to five years. If a person convicted of a
29 violation of subsection A or B is found hunting during the prohibited period, the person shall be guilty
30 of a Class 2 misdemeanor. Notification of such revocation or prohibition shall be forwarded to the
31 Department pursuant to subsections C and D of § 18.2-56.1.
