	AMENDMENT IN THE NATURE OF A SUBSTITUTE

6	A BILL to amend and reenact § 63.2-1505 of the Code of Virginia, relating to child abuse and neglect
7	investigations; time for determination.
8	Be it enacted by the General Assembly of Virginia:
9	1. That § 63.2-1505 of the Code of Virginia is amended and reenacted as follows:
10	§ 63.2-1505. Investigations by local departments.
11	A. An investigation requires the collection of information necessary to determine:
12	1. The immediate safety needs of the child;
13	2. The protective and rehabilitative services needs of the child and family that will deter abuse or
14 15	neglect; 3. Risk of future harm to the child;
15 16	4. Alternative plans for the child's safety if protective and rehabilitative services are indicated and the
17	family is unable or unwilling to participate in services;
18	5. Whether abuse or neglect has occurred;
19	6. If abuse or neglect has occurred, who abused or neglected the child; and
20	7. A finding of either founded or unfounded based on the facts collected during the investigation.
21	B. If the local department responds to the report or complaint by conducting an investigation, the
22	local department shall:
23	1. Make immediate investigation and, if the report or complaint was based upon one of the factors
24	specified in subsection B of § 63.2-1509, the local department may file a petition pursuant to
25	§ 16.1-241.3;
26	2. Complete a report and transmit it forthwith to the Department, except that no such report shall be
27	transmitted in cases in which the cause to suspect abuse or neglect is one of the factors specified in
28 29	subsection B of § 63.2-1509 and the mother sought substance abuse counseling or treatment prior to the
29 30	child's birth; 3. Consult with the family to arrange for necessary protective and rehabilitative services to be
31	provided to the child and his family;
32	4. Petition the court for services deemed necessary including, but not limited to, removal of the child
33	or his siblings from their home;
34	5. Determine within 45 days if a report of abuse or neglect is founded or unfounded and transmit a
35	report to such effect to the Department and to the person who is the subject of the investigation.
36	However, in cases in which the investigation is being conducted in cooperation with the local
37	law-enforcement agency, upon written justification by the local department, the time for such
38	determination may be extended, not to exceed a total of 60 days or, in the event that the investigation is
39	being conducted in cooperation with a law-enforcement agency and both parties agree that
40	circumstances so warrant, as stated in the written justification, the time for such determination may be
41 42	extended not to exceed 90 days. If through the exercise of reasonable diligence the local department is
42 43	unable to find the child who is the subject of the report, the time the child cannot be found shall not be computed as part of the 45-day or 60-day period and documentation of such reasonable diligence shall
4 4	be placed in the record. In cases involving the death of a child or alleged sexual abuse of a child who is
45	the subject of the report, the time during which records necessary for the investigation of the complaint
46	but not created by the local department, including autopsy or medical or forensic records or reports, are
47	not available to the local department due to circumstances beyond the local department's control shall
48	not be computed as part of the 45-day or 60-day period, and documentation of the circumstances that
49	resulted in the delay shall be placed in the record;
50	6. If a report of abuse or neglect is unfounded, transmit a report to such effect to the complainant
51	and parent or guardian and the person responsible for the care of the child in those cases where such
52 52	person was suspected of abuse or neglect; and
53 54	7. If a report of child abuse and neglect is founded, and the subject of the report is a full-time,
54 55	part-time, permanent, or temporary employee of a school division located within the Commonwealth, notify the relevant school board of the founded complaint. Any information exchanged for the purposes
55 56	of this subsection shall not be considered a violation of § 63.2-102, 63.2-104, or 63.2-105.
57	C. Each local board may obtain and consider, in accordance with regulations adopted by the Board,
58	statewide criminal history record information from the Central Criminal Records Exchange and results of
59	a search of the child abuse and neglect central registry of any individual who is the subject of a child

abuse or neglect investigation conducted under this section when there is evidence of child abuse or 60 neglect and the local board is evaluating the safety of the home and whether removal will protect a 61 62 child from harm. The local board also may obtain such a criminal records or registry search on all adult 63 household members residing in the home where the individual who is the subject of the investigation 64 resides and the child resides or visits. If a child abuse or neglect petition is filed in connection with such removal, a court may admit such information as evidence. Where the individual who is the subject 65 of such information contests its accuracy through testimony under oath in hearing before the court, no 66 67 court shall receive or consider the contested criminal history record information without certified copies of conviction. Further dissemination of the information provided to the local board is prohibited, except 68 as authorized by law. 69
