WHEREAS, Elvira Shaw served with such organizations as the Criminal Justice Board; the State 10

Department of Volunteerism; Central Virginia Health Agency, Inc.; the social services board for 11 Colonial Heights and Chesterfield; the District 19 Community Services Board; and as a board member 12 13 of the Richard Bland College Foundation, the Department of Aging, and the Crater District Area Agency 14 on Aging; and

WHEREAS, dedicated to fair and orderly elections, Elvira Shaw served as secretary of the Virginia 15 Electoral Board for 25 years and on the Colonial Heights Electoral Board for more than half a century; 16 17 and

18 WHEREAS, Elvira Shaw was a tireless advocate for the elderly, serving with several organizations 19 dedicated to meeting the needs of the aging and as an active member of the AARP; and

20 WHEREAS, Elvira Shaw served on the legislative committee of AARP for several decades and 21 received the organization's Andrus Award for her exemplary service and advocacy; and

22 WHEREAS, in recognition of her tireless service to the community, Elvira Shaw received the Judah 23 P. Benjamin Award from the Virginia Division of the United Daughters of the Confederacy in 2010; 24 and

25 WHEREAS, Elvira Shaw enjoyed fellowship and worship alongside other community members at 26 Highland United Methodist Church and was a member of the Virginia United Methodist Conference; 27 and 28

WHEREAS, possessed of a strong community spirit, Elvira Shaw inspired those around her with her dedicated and meaningful volunteerism and leaves behind a remarkable legacy of civic service; and

WHEREAS, predeceased by her husband, Lawrence, Elvira Shaw will be fondly remembered and 30 31 greatly missed by her son, Ben, and his family, and numerous other family members, friends, and 32 admirers; now, therefore, be it 33
