An Act to amend and reenact §§ 46.2-100, 46.2-325, 46.2-626.1, 46.2-662, 46.2-694, as it is currently
effective and as it may become effective, 46.2-711, 46.2-715, 46.2-730, 46.2-910, 46.2-1011, 46.2-1012, 46.2-1014, 46.2-1057, 46.2-1067, 46.2-1068, 46.2-1092, 46.2-1157, 46.2-1167, 46.2-1500, and 46.2-1993 of the Code of Virginia, relating to a new class of vehicle known as an autocycle; licensure, fees, license plates, and safety, inspection, and other requirements.

9 Be it enacted by the General Assembly of Virginia:

10 1. That §§ 46.2-100, 46.2-325, 46.2-626.1, 46.2-662, 46.2-694, as it is currently effective and as it 11 may become effective, 46.2-711, 46.2-715, 46.2-730, 46.2-910, 46.2-1011, 46.2-1012, 46.2-1014, 12 46.2-1057, 46.2-1067, 46.2-1068, 46.2-1092, 46.2-1157, 46.2-1167, 46.2-1500, and 46.2-1993 of the

13 Code of Virginia are amended and reenacted as follows:

14 § 46.2-100. Definitions.

15 The following words and phrases when used in this title shall, for the purpose of As used in this 16 title, have the meanings respectively ascribed to them in this section except in those instances where 17 unless the context clearly indicates requires a different meaning:

"All-terrain vehicle" means a motor vehicle having three or more wheels that is powered by a motor
and is manufactured for off-highway use. "All-terrain vehicle" does not include four-wheeled vehicles
commonly known as "go-carts" that have low centers of gravity and are typically used in racing on
relatively level surfaces, nor does the term include any riding lawn mower.

"Antique motor vehicle" means every motor vehicle, as defined in this section, which was actually
 manufactured or designated by the manufacturer as a model manufactured in a calendar year not less
 than 25 years prior to January 1 of each calendar year and is owned solely as a collector's item.

"Antique trailer" means every trailer or semitrailer, as defined in this section, that was actually manufactured or designated by the manufacturer as a model manufactured in a calendar year not less than 25 years prior to January 1 of each calendar year and is owned solely as a collector's item.

"Autocycle" means a three-wheeled motor vehicle that has a steering wheel and seating that does not require the operator to straddle or sit astride and is manufactured to comply with federal safety requirements for motorcycles. Except as otherwise provided, an autocycle shall not be deemed to be a motorcycle.

32 "Automobile or watercraft transporters" means any tractor truck, lowboy, vehicle, or combination,
 33 including vehicles or combinations that transport motor vehicles or watercraft on their power unit,
 34 designed and used exclusively for the transportation of motor vehicles or watercraft.

"Bicycle" means a device propelled solely by human power, upon which a person may ride either on
or astride a regular seat attached thereto, having two or more wheels in tandem, including children's
bicycles, except a toy vehicle intended for use by young children. For purposes of Chapter 8 (§ 46.2-800
et seq.), a bicycle shall be a vehicle while operated on the highway.

39 "Bicycle lane" means that portion of a roadway designated by signs and/or pavement markings for40 the preferential use of bicycles, electric power-assisted bicycles, and mopeds.

"Business district" means the territory contiguous to a highway where 75 percent or more of the
property contiguous to a highway, on either side of the highway, for a distance of 300 feet or more
along the highway, is occupied by land and buildings actually in use for business purposes.

"Camping trailer" means every vehicle that has collapsible sides and contains sleeping quarters butmay or may not contain bathing and cooking facilities and is designed to be drawn by a motor vehicle.

"Cancel" or "cancellation" means that the document or privilege cancelled has been annulled or terminated because of some error, defect, or ineligibility, but the cancellation is without prejudice and reapplication may be made at any time after cancellation.

49 "Chauffeur" means every person employed for the principal purpose of driving a motor vehicle and
50 every person who drives a motor vehicle while in use as a public or common carrier of persons or
51 property.

52 "Circular intersection" means an intersection that has an island, generally circular in design, located
53 in the center of the intersection, where all vehicles pass to the right of the island. Circular intersections
54 include roundabouts, rotaries, and traffic circles.

55 "Commission" means the State Corporation Commission.

56 "Commissioner" means the Commissioner of the Department of Motor Vehicles of the

57 Commonwealth.

58 "Converted electric vehicle" means any motor vehicle, other than a motorcycle or autocycle, that has 59 been modified subsequent to its manufacture to replace an internal combustion engine with an electric 60 propulsion system. Such vehicles shall retain their original vehicle identification number, line-make, and 61 model year. A converted electric vehicle shall not be deemed a "reconstructed vehicle" as defined in this 62 section unless it has been materially altered from its original construction by the removal, addition, or substitution of new or used essential parts other than those required for the conversion to electric 63 64 propulsion.

65 "Crosswalk" means that part of a roadway at an intersection included within the connections of the 66 lateral lines of the sidewalks on opposite sides of the highway measured from the curbs or, in the absence of curbs, from the edges of the traversable roadway; or any portion of a roadway at an 67 intersection or elsewhere distinctly indicated for pedestrian crossing by lines or other markings on the 68 69 surface.

70 "Decal" means a device to be attached to a license plate that validates the license plate for a 71 predetermined registration period. 72

"Department" means the Department of Motor Vehicles of the Commonwealth.

73 "Disabled parking license plate" means a license plate that displays the international symbol of access 74 in the same size as the numbers and letters on the plate and in a color that contrasts with the 75 background.

76 "Disabled veteran" means a veteran who (i) has either lost, or lost the use of, a leg, arm, or hand; 77 (ii) is blind; or (iii) is permanently and totally disabled as certified by the U.S. Department of Veterans 78 Affairs. A veteran shall be considered blind if he has a permanent impairment of both eyes to the 79 following extent: central visual acuity of 20/200 or less in the better eye, with corrective lenses, or central visual acuity of more than 20/200, if there is a field defect in which the peripheral field has 80 contracted to such an extent that the widest diameter of visual field subtends an angular distance no 81 greater than 20 degrees in the better eye. 82

"Driver's license" means any license, including a commercial driver's license as defined in the Virginia Commercial Driver's License Act (§ 46.2-341.1 et seq.), issued under the laws of the 83 84 85 Commonwealth authorizing the operation of a motor vehicle.

"Electric personal assistive mobility device" means a self-balancing two-nontandem-wheeled device 86 that is designed to transport only one person and powered by an electric propulsion system that limits 87 the device's maximum speed to 15 miles per hour or less. For purposes of Chapter 8 (§ 46.2-800 et 88 89 seq.), an electric personal assistive mobility device shall be a vehicle when operated on a highway.

90 "Electric power-assisted bicycle" means a vehicle that travels on not more than three wheels in 91 contact with the ground and is equipped with (i) pedals that allow propulsion by human power and (ii) an electric motor with an input of no more than 1,000 watts that reduces the pedal effort required of the 92 rider. For the purposes of Chapter 8 (§ 46.2-800 et seq.), an electric power-assisted bicycle shall be a 93 94 vehicle when operated on a highway.

95 "Essential parts" means all integral parts and body parts, the removal, alteration, or substitution of 96 which will tend to conceal the identity of a vehicle.

97 "Farm tractor" means every motor vehicle designed and used as a farm, agricultural, or horticultural 98 implement for drawing plows, mowing machines, and other farm, agricultural, or horticultural machinery 99 and implements, including self-propelled mowers designed and used for mowing lawns.

"Farm utility vehicle" means a vehicle that is powered by a motor and is designed for off-road use 100 and is used as a farm, agricultural, or horticultural service vehicle, generally having four or more 101 102 wheels, bench seating for the operator and a passenger, a steering wheel for control, and a cargo bed. 103 "Farm utility vehicle" does not include pickup or panel trucks, golf carts, low-speed vehicles, or riding 104 lawn mowers.

105 "Federal safety requirements" means applicable provisions of 49 U.S.C. § 30101 et seq. and all 106 administrative regulations and policies adopted pursuant thereto.

"Financial responsibility" means the ability to respond in damages for liability thereafter incurred arising out of the ownership, maintenance, use, or operation of a motor vehicle, in the amounts provided 107 108 109 for in § 46.2-472.

"Foreign market vehicle" means any motor vehicle originally manufactured outside the United States, which was not manufactured in accordance with 49 U.S.C. § 30101 et seq. and the policies and 110 111 regulations adopted pursuant to that Act, and for which a Virginia title or registration is sought. 112

113 "Foreign vehicle" means every motor vehicle, trailer, or semitrailer that is brought into the 114 Commonwealth otherwise than in the ordinary course of business by or through a manufacturer or dealer 115 and that has not been registered in the Commonwealth.

116 "Golf cart" means a self-propelled vehicle that is designed to transport persons playing golf and their 117 equipment on a golf course.

118 "Governing body" means the board of supervisors of a county, council of a city, or council of a 119 town, as context may require.

"Gross weight" means the aggregate weight of a vehicle or combination of vehicles and the load 120 121 thereon.

122 "Highway" means the entire width between the boundary lines of every way or place open to the use 123 of the public for purposes of vehicular travel in the Commonwealth, including the streets and alleys, 124 and, for law-enforcement purposes, (i) the entire width between the boundary lines of all private roads or private streets that have been specifically designated "highways" by an ordinance adopted by the 125 126 governing body of the county, city, or town in which such private roads or streets are located and (ii) 127 the entire width between the boundary lines of every way or place used for purposes of vehicular travel 128 on any property owned, leased, or controlled by the United States government and located in the 129 Commonwealth.

130 "Intersection" means (i) the area embraced within the prolongation or connection of the lateral 131 curblines or, if none, then the lateral boundary lines of the roadways of two highways that join one 132 another at, or approximately at, right angles, or the area within which vehicles traveling on different 133 highways joining at any other angle may come in conflict; (ii) where a highway includes two roadways 134 30 feet or more apart, then every crossing of each roadway of such divided highway by an intersecting 135 highway shall be regarded as a separate intersection, in the event such intersecting highway also 136 includes two roadways 30 feet or more apart, then every crossing of two roadways of such highways 137 shall be regarded as a separate intersection; or (iii) for purposes only of authorizing installation of 138 traffic-control devices, every crossing of a highway or street at grade by a pedestrian crosswalk.

139 "Lane-use control signal" means a signal face displaying indications to permit or prohibit the use of **140** specific lanes of a roadway or to indicate the impending prohibition of such use.

141 "Law-enforcement officer" means any officer authorized to direct or regulate traffic or to make 142 arrests for violations of this title or local ordinances authorized by law. For the purposes of access to 143 law-enforcement databases regarding motor vehicle registration and ownership only, this term shall "law-enforcement officer" also include includes city and county commissioners of the revenue and 144 145 treasurers, together with their duly designated deputies and employees, when such officials are actually engaged in the enforcement of §§ 46.2-752, 46.2-753, and 46.2-754 and local ordinances enacted 146 147 thereunder.

148 "License plate" means a device containing letters, numerals, or a combination of both, attached to a 149 motor vehicle, trailer, or semitrailer to indicate that the vehicle is properly registered with the 150 Department. 151

"Light" means a device for producing illumination or the illumination produced by the device.

152 "Low-speed vehicle" means any four-wheeled electrically-powered vehicle, except a motor vehicle or 153 low-speed vehicle that is used exclusively for agricultural or horticultural purposes or a golf cart, whose 154 maximum speed is greater than 20 miles per hour but not greater than 25 miles per hour and is 155 manufactured to comply with safety standards contained in Title 49 of the Code of Federal Regulations, 156 § 571.500.

157 'Manufactured home" means a structure subject to federal regulation, transportable in one or more 158 sections, which in the traveling mode is eight body feet or more in width or 40 body feet or more in 159 length, or, when erected on site, is 320 or more square feet, and which is built on a permanent chassis 160 and designed to be used as a dwelling with or without a permanent foundation when connected to the required utilities, and includes the plumbing, heating, air conditioning, and electrical systems contained 161 162 therein.

163 "Moped" means every vehicle that travels on not more than three wheels in contact with the ground 164 that (i) has a seat that is no less than 24 inches in height, measured from the middle of the seat perpendicular to the ground; (ii) has a gasoline, electric, or hybrid motor that (a) displaces 50 cubic 165 centimeters or less or (b) has an input of 1500 watts or less; (iii) is power-driven, with or without 166 167 pedals that allow propulsion by human power; and (iv) is not operated at speeds in excess of 35 miles 168 per hour. For purposes of this title, a moped shall be a motorcycle when operated at speeds in excess of 169 35 miles per hour. For purposes of Chapter 8 (§ 46.2-800 et seq.), a moped shall be a vehicle while 170 operated on a highway.

171 "Motor-driven cycle" means every motorcycle that has a gasoline engine that (i) displaces less than 172 150 cubic centimeters; (ii) has a seat less than 24 inches in height, measured from the middle of the seat 173 perpendicular to the ground; and (iii) has no manufacturer-issued vehicle identification number.

174 "Motor home" means every private motor vehicle with a normal seating capacity of not more than 10 175 persons, including the driver, designed primarily for use as living quarters for human beings.

176 "Motor vehicle" means every vehicle as defined in this section that is self-propelled or designed for 177 self-propulsion except as otherwise provided in this title. Any structure designed, used, or maintained 178 primarily to be loaded on or affixed to a motor vehicle to provide a mobile dwelling, sleeping place,

179 office, or commercial space shall be considered a part of a motor vehicle. Except as otherwise provided,
180 for the purposes of this title, any device herein defined as a bicycle, electric personal assistive mobility
181 device, electric power-assisted bicycle, or moped shall be deemed not to be a motor vehicle.

"Motorcycle" means every motor vehicle designed to travel on not more than three wheels in contact
with the ground and is capable of traveling at speeds in excess of 35 miles per hour. The term
"motorcycle" "Motorcycle" does not include any "autocycle," "electric personal assistive mobility
device," "electric power-assisted bicycle," "farm tractor," "golf cart," "moped," "motorized skateboard or
foot-scooter," "utility vehicle," or "wheelchair or wheelchair conveyance" as defined in this section.

187 "Motorized skateboard or foot-scooter" means every vehicle, regardless of the number of its wheels
188 in contact with the ground, that (i) has no seat, but is designed to be stood upon by the operator, (ii) has
189 no manufacturer-issued vehicle identification number, and (iii) is powered by an electric motor having
190 an input of no more than 1,000 watts or a gasoline engine that displaces less than 36 cubic centimeters.
191 The term "motorized "Motorized skateboard or foot-scooter" includes vehicles with or without
192 handlebars, but does not include "electric personal assistive mobility devices."

193 "Nonresident" means every person who is not domiciled in the Commonwealth, except: (i) any foreign corporation that is authorized to do business in the Commonwealth by the State Corporation 194 195 Commission shall be a resident of the Commonwealth for the purpose of this title; in the case of 196 corporations incorporated in the Commonwealth but doing business outside the Commonwealth, only 197 such principal place of business or branches located within the Commonwealth shall be dealt with as 198 residents of the Commonwealth; (ii) a person who becomes engaged in a gainful occupation in the 199 Commonwealth for a period exceeding 60 days shall be a resident for the purposes of this title except 200 for the purposes of Chapter 3 (§ 46.2-300 et seq.); (iii) a person, other than a nonresident student as 201 defined in this section, who has actually resided in the Commonwealth for a period of six months, 202 whether employed or not, or who has registered a motor vehicle, listing an address in the 203 Commonwealth in the application for registration shall be deemed a resident for the purposes of this 204 title, except for the purposes of the Virginia Commercial Driver's License Act (§ 46.2-341.1 et seq.).

205 "Nonresident student" means every nonresident person who is enrolled as a full-time student in an206 accredited institution of learning in the Commonwealth and who is not gainfully employed.

207 "Off-road motorcycle" means every motorcycle designed exclusively for off-road use by an individual
208 rider with not more than two wheels in contact with the ground. Except as otherwise provided in this
209 chapter, for the purposes of this chapter off-road motorcycles shall be deemed to be "motorcycles."

210 "Operation or use for rent or for hire, for the transportation of passengers, or as a property carrier for 211 compensation," and "business of transporting persons or property" mean any owner or operator of any 212 motor vehicle, trailer, or semitrailer operating over the highways in the Commonwealth who accepts or 213 receives compensation for the service, directly or indirectly; but these terms do not mean a "truck 214 lessor" as defined in this section and do not include persons or businesses that receive compensation for 215 delivering a product that they themselves sell or produce, where a separate charge is made for delivery of the product or the cost of delivery is included in the sale price of the product, but where the person 216 217 or business does not derive all or a substantial portion of its income from the transportation of persons 218 or property except as part of a sales transaction.

219 "Operator" or "driver" means every person who either (i) drives or is in actual physical control of a
220 motor vehicle on a highway or (ii) is exercising control over or steering a vehicle being towed by a
221 motor vehicle.

222 "Owner" means a person who holds the legal title to a vehicle; however, if a vehicle is the subject of 223 an agreement for its conditional sale or lease with the right of purchase on performance of the 224 conditions stated in the agreement and with an immediate right of possession vested in the conditional 225 vendee or lessee or if a mortgagor of a vehicle is entitled to possession, then the conditional vendee or 226 lessee or mortgagor shall be the owner for the purpose of this title. In all such instances when the rent 227 paid by the lessee includes charges for services of any nature or when the lease does not provide that 228 title shall pass to the lessee on payment of the rent stipulated, the lessor shall be regarded as the owner 229 of the vehicle, and the vehicle shall be subject to such requirements of this title as are applicable to vehicles operated for compensation. A "truck lessor" as defined in this section shall be regarded as the 230 231 owner, and his vehicles shall be subject to such requirements of this title as are applicable to vehicles of 232 private carriers.

233 "Passenger car" means every motor vehicle other than a motorcycle *or autocycle* designed and used
234 primarily for the transportation of no more than 10 persons, including the driver.

"Payment device" means any credit card as defined in 15 U.S.C. § 1602(k) or any "accepted card or other means of access" set forth in 15 U.S.C. § 1693a(1). For the purposes of this title, this definition shall also include a card that enables a person to pay for transactions through the use of value stored on the card itself.

239 "Pickup or panel truck" means every motor vehicle designed for the transportation of property and

240 having a registered gross weight of 7,500 pounds or less.

241 "Private road or driveway" means every way in private ownership and used for vehicular travel by242 the owner and those having express or implied permission from the owner, but not by other persons.

"Reconstructed vehicle" means every vehicle of a type required to be registered under this title materially altered from its original construction by the removal, addition, or substitution of new or used essential parts. Such vehicles, at the discretion of the Department, shall retain their original vehicle identification number, line-make, and model year. Except as otherwise provided in this title, this definition shall not include a "converted electric vehicle" as defined in this section.

248 "Replica vehicle" means every vehicle of a type required to be registered under this title not fully 249 constructed by a licensed manufacturer but either constructed or assembled from components. Such 250 components may be from a single vehicle, multiple vehicles, a kit, parts, or fabricated components. The 251 kit may be made up of "major components" as defined in § 46.2-1600, a full body, or a full chassis, or 252 a combination of these parts. The vehicle shall resemble a vehicle of distinctive name, line-make, model, 253 or type as produced by a licensed manufacturer or manufacturer no longer in business and is not a 254 reconstructed or specially constructed vehicle as herein defined.

"Residence district" means the territory contiguous to a highway, not comprising a business district,
where 75 percent or more of the property abutting such highway, on either side of the highway, for a
distance of 300 feet or more along the highway consists of land improved for dwelling purposes, or is
occupied by dwellings, or consists of land or buildings in use for business purposes, or consists of
territory zoned residential or territory in residential subdivisions created under Chapter 22 (§ 15.2-2200
et seq.) of Title 15.2.

"Revoke" or "revocation" means that the document or privilege revoked is not subject to renewal or restoration except through reapplication after the expiration of the period of revocation.

263 "Roadway" means that portion of a highway improved, designed, or ordinarily used for vehicular
264 travel, exclusive of the shoulder. A highway may include two or more roadways if divided by a physical
265 barrier or barriers or an unpaved area.

"Safety zone" means the area officially set apart within a roadway for the exclusive use ofpedestrians and that is protected or is so marked or indicated by plainly visible signs.

268 "School bus" means any motor vehicle, other than a station wagon, automobile, truck, or commercial 269 bus, which is: (i) designed and used primarily for the transportation of pupils to and from public, private 270 or religious schools, or used for the transportation of the mentally or physically handicapped to and 271 from a sheltered workshop; (ii) painted yellow and bears the words "School Bus" in black letters of a 272 specified size on front and rear; and (iii) is equipped with warning devices prescribed in § 46.2-1090. A 273 yellow school bus may have a white roof provided such vehicle is painted in accordance with 274 regulations promulgated by the Department of Education.

275 "Semitrailer" means every vehicle of the trailer type so designed and used in conjunction with a
276 motor vehicle that some part of its own weight and that of its own load rests on or is carried by another
277 vehicle.

278 "Shared-use path" means a bikeway that is physically separated from motorized vehicular traffic by
279 an open space or barrier and is located either within the highway right-of-way or within a separate
280 right-of-way. Shared-use paths may also be used by pedestrians, skaters, users of wheel chairs or wheel
281 chair conveyances, joggers, and other nonmotorized users.

"Shoulder" means that part of a highway between the portion regularly traveled by vehicular trafficand the lateral curbline or ditch.

284 "Sidewalk" means the portion of a street between the curb lines, or the lateral lines of a roadway,285 and the adjacent property lines, intended for use by pedestrians.

"Snowmobile" means a self-propelled vehicle designed to travel on snow or ice, steered by skis or runners, and supported in whole or in part by one or more skis, belts, or cleats.

288 "Special construction and forestry equipment" means any vehicle which is designed primarily for
289 highway construction, highway maintenance, earth moving, timber harvesting or other construction or
290 forestry work and which is not designed for the transportation of persons or property on a public
291 highway.

292 "Specially constructed vehicle" means any vehicle that was not originally constructed under a
293 distinctive name, make, model, or type by a generally recognized manufacturer of vehicles and not a
294 reconstructed vehicle as herein defined.

295 "Stinger-steered automobile or watercraft transporter" means an automobile or watercraft transporter
296 configured as a semitrailer combination wherein the fifth wheel is located on a drop frame behind and
297 below the rearmost axle of the power unit.

298 "Superintendent" means the Superintendent of the Department of State Police of the Commonwealth.

299 "Suspend" or "suspension" means that the document or privilege suspended has been temporarily300 withdrawn, but may be reinstated following the period of suspension unless it has expired prior to the

301 end of the period of suspension.

"Tow truck" means a motor vehicle for hire (i) designed to lift, pull, or carry another vehicle by
means of a hoist or other mechanical apparatus and (ii) having a manufacturer's gross vehicle weight
rating of at least 10,000 pounds. "Tow truck" also includes vehicles designed with a ramp on wheels
and a hydraulic lift with a capacity to haul or tow another vehicle, commonly referred to as "rollbacks."
"Tow truck" does not include any "automobile or watercraft transporter," "stinger-steered automobile or
watercraft transporter," or "tractor truck" as those terms are defined in this section.

308 "Towing and recovery operator" means a person engaged in the business of (i) removing disabled 309 vehicles, parts of vehicles, their cargoes, and other objects to facilities for repair or safekeeping and (ii) 310 restoring to the highway or other location where they either can be operated or removed to other 311 locations for repair or safekeeping vehicles that have come to rest in places where they cannot be 312 operated.

313 "Toy vehicle" means any motorized or propellant-driven device that has no manufacturer-issued
314 vehicle identification number, that is designed or used to carry any person or persons, on any number of
315 wheels, bearings, glides, blades, runners, or a cushion of air. The term "Toy vehicle" does not include
316 electric personal assistive mobility devices, electric power-assisted bicycles, mopeds, or motorcycles, nor
317 does it include any nonmotorized or nonpropellant-driven devices such as bicycles, roller skates, or
318 skateboards.

319 "Tractor truck" means every motor vehicle designed and used primarily for drawing other vehicles
320 and not so constructed as to carry a load other than a part of the load and weight of the vehicle attached
321 thereto.

322 "Traffic control device" means a sign, signal, marking, or other device used to regulate, warn, or 323 guide traffic placed on, over, or adjacent to a street, highway, private road open to public travel, 324 pedestrian facility, or shared-use path by authority of a public agency or official having jurisdiction, or 325 in the case of a private road open to public travel, by authority of the private owner or private official 326 having jurisdiction.

327 "Traffic infraction" means a violation of law punishable as provided in § 46.2-113, which is neither a328 felony nor a misdemeanor.

329 "Traffic lane" or "lane" means that portion of a roadway designed or designated to accommodate the330 forward movement of a single line of vehicles.

331 "Trailer" means every vehicle without motive power designed for carrying property or passengers332 wholly on its own structure and for being drawn by a motor vehicle, including manufactured homes.

333 "Truck" means every motor vehicle designed to transport property on its own structure independent334 of any other vehicle and having a registered gross weight in excess of 7,500 pounds.

335 "Truck lessor" means a person who holds the legal title to any motor vehicle, trailer, or semitrailer 336 that is the subject of a bona fide written lease for a term of one year or more to another person, provided that: (i) neither the lessor nor the lessee is a common carrier by motor vehicle or restricted 337 common carrier by motor vehicle or contract carrier by motor vehicle as defined in § 46.2-2000; (ii) the 338 339 leased motor vehicle, trailer, or semitrailer is used exclusively for the transportation of property of the 340 lessee; (iii) the lessor is not employed in any capacity by the lessee; (iv) the operator of the leased 341 motor vehicle is a bona fide employee of the lessee and is not employed in any capacity by the lessor; and (v) a true copy of the lease, verified by affidavit of the lessor, is filed with the Commissioner. 342

343 "Utility vehicle" means a motor vehicle that is (i) designed for off-road use, (ii) powered by a motor,
344 and (iii) used for general maintenance, security, agricultural, or horticultural purposes. "Utility vehicle"
345 does not include riding lawn mowers.

346 "Vehicle" means every device in, on or by which any person or property is or may be transported or
347 drawn on a highway, except devices moved by human power or used exclusively on stationary rails or
348 tracks. For the purposes of Chapter 8 (§ 46.2-800 et seq.), bicycles, electric personal assistive mobility
349 devices, electric power-assisted bicycles, and mopeds shall be vehicles while operated on a highway.

350 "Wheel chair or wheel chair conveyance" means a chair or seat equipped with wheels, typically used
351 to provide mobility for persons who, by reason of physical disability, are otherwise unable to move
about as pedestrians. The term "Wheel chair or wheel chair conveyance" includes both three-wheeled
and four-wheeled devices. So long as it is operated only as provided in § 46.2-677, a self-propelled
wheel chair or self-propelled wheel chair conveyance shall not be considered a motor vehicle.

355 § 46.2-325. Examination of applicants; waiver of Department's examination under certain 356 circumstances; behind-the-wheel and knowledge examinations.

A. The Department shall examine every applicant for a driver's license before issuing any license to
determine (i) his physical and mental qualifications and his ability to drive a motor vehicle without
jeopardizing the safety of persons or property and (ii) if any facts exist which would bar the issuance of
a license under §§ 46.2-311 through 46.2-316, 46.2-334, or 46.2-335. The examination, however, shall
not include investigation of any facts other than those directly pertaining to the ability of the applicant

362 to drive a motor vehicle with safety, or other than those facts declared to be prerequisite to the issuance 363 of a license under this chapter. No applicant otherwise competent shall be required to demonstrate 364 ability to park any motor vehicle except in an adequate parking space between horizontal markers, and not between flags or sticks simulating parked vehicles. Except as provided for in § 46.2-337, applicants 365 366 for licensure to drive motor vehicles of the classifications referred to in § 46.2-328 shall submit to 367 examinations which relate to the operation of those vehicles. The motor vehicle to be used by the 368 applicant for the behind-the-wheel examination shall meet the safety and equipment requirements 369 specified in Chapter 10 (§ 46.2-1000 et seq.) and possess a valid inspection sticker as required pursuant 370 to § 46.2-1157. An autocycle shall not be used by the applicant for a behind-the-wheel examination.

371 Prior to taking the examination, the applicant shall either (a) present evidence that the applicant has 372 completed a state-approved driver education class pursuant to the provisions of § 46.2-324.1 or 46.2-334 373 or (b) submit to the examiner a behind-the-wheel maneuvers checklist, on a form provided by the 374 Department, that describes the vehicle maneuvers the applicant may be expected to perform while taking 375 the behind-the-wheel examination, that has been signed by a licensed driver, certifying that the applicant 376 has practiced the driving maneuvers contained and described therein, and that has been signed by the 377 applicant certifying that, at all times while holding a learner's permit, the applicant has complied with 378 the provisions of § 46.2-335 while operating a motor vehicle.

379 Except for applicants subject to § 46.2-312, if the Commissioner is satisfied that an applicant has
380 demonstrated the same proficiency as required by the Department's examination through successful
381 completion of either (1) the driver education course approved by the Department of Education or (2) a
382 driver training course offered by a driver training school licensed under Chapter 17 (§ 46.2-1700 et
383 seq.), he may waive those parts of the Department's examination provided for in this section that require
384 the applicant to drive and park a motor vehicle.

In addition, no person who fails the driver knowledge 392 examination for a driver's license administered by the Department three times shall be permitted to take 393 such examination a fourth time until he successfully completes, subsequent to the third examination 394 failure, the classroom component of driver instruction at a driver training school licensed under Chapter 395 17 (§ 46.2-1700 et seq.) or, for persons at least 19 years old, a course of instruction based on the 396 Virginia Driver's Manual offered by a driver training school licensed under Chapter 17 (§ 46.2-1700 et 397 seq.) and approved by the Department or the Department of Education.

398 The provisions of this subsection shall not apply to persons placed under medical control by the 399 Department pursuant to § 46.2-322.

400 § 46.2-626.1. Motorcycle purchased by manufacturer for parts; documentation required for sale 401 of parts.

402 For the purposes of this section, the terms "certificate of origin," "line-make," and "manufacturer,"
 403 shall and "new motorcycle" have the meanings ascribed to them in § 46.2-1993.

404 A licensed motorcycle manufacturer shall not be required to obtain a certificate of title for a new 405 motorcycle of a different line-make purchased by the manufacturer for the purpose of obtaining parts 406 used in the production of another *new* motorcycle *or an autocycle*, provided such manufacturer obtains a 407 salvage dealer license in accordance with § 46.2-1601. The manufacturer shall not be required to obtain 408 a nonrepairable certificate for the purchased motorcycle, as required by § 46.2-1603.1, but shall stamp 409 the words "Va. Code § 46.2-626.1: DISASSEMBLED FOR PARTS" in a minimum font size of 14 point 410 across the face of the original manufacturer's certificate of origin. The certificate of origin shall be forwarded to the Department, which shall make a record of the disassembly of the motorcycle. The 411 412 manufacturer shall retain a photocopy of the stamped certificate of origin for its records.

413 Any parts remaining from the purchased motorcycle and sold as parts by the manufacturer shall be 414 accompanied by documentation of how such parts were obtained. Documentation accompanying the 415 frame of the purchased motorcycle shall include a photocopy of the stamped manufacturer's certificate of 416 origin and certification from the manufacturer that the original certificate of origin has been forwarded 417 to the Department.

418 § 46.2-662. Temporary exemption for new resident operating vehicle registered in another state 419 or country.

420 A. A resident owner of any passenger car, pickup or panel truck, moped, *autocycle*, or motorcycle, 421 other than those provided for in § 46.2-652, that has been duly registered for the current calendar year in

422 another state or country and that at all times when operated in the Commonwealth displays the license

plate or plates issued for the vehicle in the other state or country, may operate or permit the operation of the passenger car, pickup or panel truck, moped, *autocycle*, or motorcycle within or partly within the Commonwealth for the first 30 days of his residency in the Commonwealth without registering the passenger car, pickup or panel truck, moped, *autocycle*, or motorcycle or paying any fees to the Commonwealth.

B. In addition to any penalty authorized under this title, any locality may adopt an ordinance imposing a penalty of up to \$250 upon the resident owner of any motor vehicle that, following the end of the 30-day period provided in subsection A, is required to be registered in Virginia but has not been so registered. The ordinance shall set forth a reasonable method for assessing and collecting the penalty, whether by civil, criminal, or administrative process, and shall identify the employees or agents of the locality who are to execute such assessment and collection.

434 § 46.2-694. (Contingent expiration date) Fees for vehicles designed and used for transportation
435 of passengers; weights used for computing fees; burden of proof.

A. The annual registration fees for motor vehicles, trailers, and semitrailers designed and used for thetransportation of passengers on the highways in the Commonwealth are:

438 1. Thirty-three dollars for each private passenger car or motor home if the passenger car or motor

In any case in which the local governing body grants 651 the funds to a regional emergency medical services council to be distributed to the licensed, nonprofit 652 emergency medical and rescue services, the local governing body shall remain responsible for the proper 653 use of the funds. If, at the end of any fiscal year, a report on the use of the funds returned to the locality pursuant to this section for that year has not been received from a local governing body, any 654 655 funds due to that local governing body for the next fiscal year shall be retained until such time as the 656 report has been submitted to the Board.

657 B. All motor vehicles, trailers, and semitrailers registered as provided in subsection B of § 46.2-646 658 shall pay a registration fee equal to one-twelfth of all fees required by subsection A of this section or 659 § 46.2-697 for such motor vehicle, trailer, or semitrailer, computed to the nearest cent, multiplied by the 660 number of months in the registration period for such motor vehicles, trailers, and semitrailers.

661 C. The manufacturer's shipping weight or scale weight shall be used for computing all fees required 662 by this section to be based upon the weight of the vehicle.

D. The applicant for registration bears the burden of proof that the vehicle for which registration is 663 664 sought is entitled by weight, design, and use to be registered at the fee tendered by the applicant to the 665 Commissioner or to his authorized agent.

§ 46.2-711. Furnishing number and design of plates; displaying on vehicles required. 666

667 A. The Department shall furnish one license plate for every registered moped, motorcycle, *autocycle*, 668 tractor truck, semitrailer, or trailer, and two license plates for every other registered motor vehicle, 669 except to licensed motor vehicle dealers and persons delivering unladen vehicles who shall be furnished 670 one license plate. The license plates for trailers, semitrailers, commercial vehicles, and trucks, other than 671 license plates for dealers, may be of such design as to prevent removal without mutilating some part of 672 the indicia forming a part of the license plate, when secured to the bracket.

B. The Department shall issue appropriately designated license plates for: 673

674 1. Passenger-carrying vehicles for rent or hire for the transportation of passengers for private trips;

675 2. Taxicabs:

683

676 3. Passenger-carrying vehicles operated by common carriers or restricted common carriers;

677 4. Property-carrying motor vehicles to applicants who operate as private carriers only;

678 5. Applicants who operate motor vehicles as carriers for rent or hire;

679 6. Vehicles operated by nonemergency medical transportation carriers as defined in § 46.2-2000; and

680 7. Trailers and semitrailers.

681 C. The Department shall issue appropriately designated license plates for motor vehicles held for 682 rental as defined in § 58.1-1735.

D. The Department shall issue appropriately designated license plates for low-speed vehicles.

684 E. No vehicles shall be operated on the highways in the Commonwealth without displaying the 685 license plates required by this chapter. The provisions of this subsection shall not apply to vehicles used 686 to collect and deliver the Unites States mail to the extent that their rear license plates may be covered by the "CAUTION, FREQUENT STOPS, U.S. MAIL" sign when the vehicle is engaged in the **687** 688 collection and delivery of the United States mail.

689 F. Pickup or panel trucks are exempt from the provisions of subsection B with reference to 690 displaying for-hire license plates when operated as a carrier for rent or hire. However, this exemption shall not apply to pickup or panel trucks subject to regulation under Chapter 21 (§ 46.2-2100 et seq.) of 691 692 this title. 693

§ 46.2-715. Display of license plates.

694 License plates assigned to a motor vehicle, other than a moped, motorcycle, *autocycle*, tractor truck, 695 trailer, or semitrailer, or to persons licensed as motor vehicle dealers or transporters of unladen vehicles, 696 shall be attached to the front and the rear of the vehicle. The license plate assigned to a moped, **697** motorcycle, *autocycle*, trailer, or semitrailer shall be attached to the rear of the vehicle. The license plate **698** assigned to a tractor truck shall be attached to the front of the vehicle. The license plates issued to 699 licensed motor vehicle dealers and to persons licensed as transporters of unladen vehicles shall consist of 700 one plate for each set issued and shall be attached to the rear of the vehicle to which it is assigned. 701

§ 46.2-730. License plates for antique motor vehicles and antique trailers; fee.

702 A. On receipt of an application and evidence that the applicant owns or has regular use of another 703 passenger car, *autocycle*, or motorcycle, the Commissioner shall issue appropriately designed license plates to owners of antique motor vehicles and antique trailers. These license plates shall be valid so 704 705 long as title to the vehicle is vested in the applicant. The fee for the registration card and license plates 706 of any of these vehicles shall be a one-time fee of \$50.

B. On receipt of an application and evidence that the applicant owns or has regular use of another 707 708 passenger car, autocycle, or motorcycle, the Commissioner may authorize for use on antique motor 709 vehicles and antique trailers Virginia license plates manufactured prior to 1976 and designed for use 710 without decals, if such license plates are embossed with or are of the same year of issue as the model 711 year of the antique motor vehicle or antique trailer on which they are to be displayed. Original metal 712 year tabs issued in place of license plates for years 1943 and 1952 and used with license plates issued in 713 1942 and 1951, respectively, also may be authorized by the Commissioner for use on antique motor 714 vehicles and antique trailers that are of the same model year as the year the metal tab was originally 715 issued. These license plates and metal tabs shall remain valid so long as title to the vehicle is vested in 716 the applicant. The fee for the registration card and permission to use the license plates and metal tabs on 717 any of these vehicles shall be a one-time fee of \$50. If more than one request is made for use, as 718 provided in this section, of license plates having the same number, the Department shall accept only the 719 first such application.

720 C. Notwithstanding the provisions of §§ 46.2-711 and 46.2-715, antique motor vehicles may display 721 single license plates if the original manufacturer's design of the antique motor vehicles allows for the 722 use of only single license plates or if the license plate was originally issued in one of the following 723 years and is displayed in accordance with the provisions of subsection B of this section: 1906, 1907, 724 1908, 1909, 1945, or 1946.

725 D. Antique motor vehicles and antique trailers registered with license plates issued or authorized for 726 use under this section shall not be used for general transportation purposes, including, but not limited to, 727 daily travel to and from the owner's place of employment, but shall only be used:

728 1. For participation in club activities, exhibits, tours, parades, and similar events;

729 2. On the highways of the Commonwealth for the purpose of testing their operation or selling the 730 vehicle or trailer, obtaining repairs or maintenance, transportation to and from events as described in subdivision 1 of this subsection, and for occasional pleasure driving not exceeding 250 miles from the 731 732 residence of the owner; and

733 3. To carry or transport (i) passengers in the antique motor vehicles, (ii) personal effects in the 734 antique motor vehicles and antique trailers, or (iii) other antique motor vehicles being transported for 735 show purposes.

736 The registration card issued to an antique motor vehicle or an antique trailer registered pursuant to 737 subsections A, B, and C shall indicate such vehicle or trailer is for limited use.

738 E. Owners of motor vehicles and trailers applying for registration pursuant to subsections A, B and C 739 shall submit to the Department, in the manner prescribed by the Department, certifications that such 740 vehicles or trailers are capable of being safely operated on the highways of the Commonwealth.

741 Pursuant to § 46.2-1000, the Department shall suspend the registration of any vehicle or trailer 742 registered with license plates issued under this section that the Department or the Department of State 743 Police determines is not properly equipped or otherwise unsafe to operate. Any law-enforcement officer 744 shall take possession of the license plates, registration card and decals, if any, of any vehicle or trailer 745 registered with license plates issued under this section when he observes any defect in such vehicle or 746 trailer as set forth in § 46.2-1000.

747 F. Antique motor vehicles and antique trailers displaying license plates issued or authorized for use 748 pursuant to subsections B and C of this section may be used for general transportation purposes if the 749 following conditions are met:

750 1. The physical condition of the vehicle's license plate or plates has been inspected and approved by 751 the Department; 752

2. The license plate or plates are registered to the specific vehicle by the Department;

753 3. The owner of the vehicle periodically registers the vehicle with the Department and pays a 754 registration fee for the vehicle equal to that which would be charged to obtain regular state license 755 plates for that vehicle;

756 4. The vehicle passes a periodic safety inspection as provided in Article 21 (§ 46.2-1157 et seq.) of 757 Chapter 10 of this title;

758 5. The vehicle displays current decals attached to the license plate, issued by the Department, 759 indicating the valid registration period for the vehicle; and

760 6. When applicable, the vehicle meets the requirement of Article 22 (§ 46.2-1176 et seq.) of Chapter 761 10 of this title.

762 If more than one request is made for use, as provided in this subsection, of license plates having the 763 same number, the Department shall accept only the first such application. Only vehicles titled to the 764 person seeking to use license plates as provided in this subsection shall be eligible to use license plates 765 as provided in this subsection.

766 G. Nothing in this section shall be construed as prohibiting the use of an antique motor vehicle to tow a trailer or semitrailer. 767

768 H. Any owner of an antique motor vehicle or antique trailer registered with license plates pursuant to 769 this section who is convicted of a violation of this section shall be is guilty of a Class 4 misdemeanor. Upon receiving a record of conviction of a violation of this section, the Department shall revoke and not 770 771 reinstate the owner's privilege to register the vehicle operated in violation of this section with license 772 plates issued or authorized for use pursuant to this section for a period of five years from the date of 773 conviction.

774 I. Except for the one-time \$50 registration fee prescribed in subsections A and B, the provisions of 775 this section shall apply to all owners of vehicles and trailers registered with license plates issued under 776 this section prior to July 1, 2007. Such owners shall, based on a schedule and a manner prescribed by 777 the Department, (i) provide evidence that they own or have regular use of another passenger car or 778 motorcycle, as required under subsections A and B, and (ii) comply with the certification provisions of 779 subsection E. The Department shall cancel the registrations of vehicles owned by persons that, prior to 780 January 1, 2008, do not provide the Department (i) evidence of owning or having regular use of another 781 autocycle, passenger car, or motorcycle as required under subsections A and B, and (ii) the certification 782 required pursuant to subsection E.

783 § 46.2-910. Motorcycle and autocycle operators to wear helmets, etc.; certain sales prohibited; 784 penalty.

785 A. Every person operating a motorcycle or autocycle shall wear a face shield, safety glasses or 786 goggles, or have his motorcycle or autocycle equipped with safety glass or a windshield at all times 787 while operating the vehicle, and operators and any passengers thereon shall wear protective helmets. Operators and passengers riding on motorcycles with wheels of eight inches or less in diameter or in 788

789 three-wheeled motorcycles which or autocycles that have nonremovable roofs, windshields, and enclosed 790 bodies shall not be required to wear protective helmets. The windshields, face shields, glasses or 791 goggles, and protective helmets required by this section shall meet or exceed the standards and 792 specifications of the Snell Memorial Foundation, the American National Standards Institute, Inc., or the 793 federal Department of Transportation. Failure to wear a face shield, safety glasses or goggles, or 794 protective helmets shall not constitute negligence per se in any civil proceeding. The provisions of this 795 section requiring the wearing of protective helmets shall not apply to operators of or passengers on 796 motorcycles or autocycles being operated (i) as part of an organized parade authorized by the 797 Department of Transportation or the locality in which the parade is being conducted and escorted, 798 accompanied, or participated in by law-enforcement officers of the jurisdiction wherein the parade is 799 held and (ii) at speeds of no more than fifteen 15 miles per hour.

800 No motorcycle or autocycle operator shall use any face shield, safety glasses, or goggles, or have his 801 motorcycle or autocycle equipped with safety glass or a windshield, unless of a type either (i) approved 802 by the Superintendent prior to July 1, 1996, or (ii) that meets or exceeds the standards and specifications of the Snell Memorial Foundation, the American National Standards Institute, Inc., or the federal 803 804 Department of Transportation and is marked in accordance with such standards.

805 B. It shall be unlawful to sell or offer for sale, for highway use in Virginia, any protective helmet 806 that fails to meet or exceed any standard as provided in the foregoing provisions of this section. Any 807 violation of this subsection shall constitute is a Class 4 misdemeanor.

808 § 46.2-1011. Headlights on motor vehicles.

809 Every motor vehicle other than a motorcycle, *autocycle*, road roller, road machinery, or tractor used 810 on a highway shall be equipped with at least two headlights as approved by the Superintendent, at the 811 front of and on opposite sides of the motor vehicle.

812 § 46.2-1012. Headlights, auxiliary headlights, tail lights, brake lights, and illumination of license 813 plates on motorcycles or autocycles.

814 Every motorcycle or *autocycle* shall be equipped with at least one headlight which shall be of a type 815 that has been approved by the Superintendent and shall be capable of projecting sufficient light to the 816 front of such motorcycle or autocycle to render discernible a person or object at a distance of 200 feet. However, the lights shall not project a glaring or dazzling light to persons approaching such motorcycles 817 818 or autocycles. In addition, each motorcycle or autocycle may be equipped with not more than two 819 auxiliary headlights of a type approved by the Superintendent.

820 Motorcycles or autocycles may be equipped with means of modulating the high beam of their 821 headlights between high and low beam at a rate of 200 to 280 flashes per minute. Such headlights shall 822 not be so modulated during periods when headlights would ordinarily be required to be lighted under 823 § 46.2-1030.

824 Every motorcycle or *autocycle* registered in the Commonwealth and operated on the highways of the 825 Commonwealth shall be equipped with at least one brake light of a type approved by the 826 Superintendent. Motorcycles or autocycles may be equipped with one or more auxiliary brake lights of a type approved by the Superintendent. The Superintendent may by regulation prescribe or limit the size, 827 828 number, location, and configuration of such auxiliary brake lights.

829 Every motorcycle or *autocycle* shall carry at the rear at least one or more red lights plainly visible in 830 clear weather from a distance of 500 feet to the rear of such vehicle. Such tail lights shall be 831 constructed and so mounted in their relation to the rear license plate as to illuminate the license plate 832 with a white light so that the same may be read from a distance of 50 feet to the rear of such vehicle. 833 Alternatively, a separate white light shall be so mounted as to illuminate the rear license plate from a 834 distance of 50 feet to the rear of such vehicle. Any such tail lights or special white light shall be of a 835 type approved by the Superintendent.

836 Motorcycles or autocycles may be equipped with a means of varying the brightness of the vehicle's 837 brake light for a duration of not more than five seconds upon application of the vehicle's brakes. 838

§ 46.2-1014. Brake lights.

839 Every motor vehicle, trailer, or semitrailer, except an antique vehicle not originally equipped with a 840 brake light, registered in the Commonwealth and operated on the highways in the Commonwealth shall 841 be equipped with at least two brake lights of a type approved by the Superintendent. Such brake lights 842 shall automatically exhibit a red or amber light plainly visible in clear weather from a distance of 500 843 feet to the rear of such vehicle when the brake is applied.

844 The provisions of this section shall not apply to motorcycles or autocycles equipped with brake lights 845 as required by § 46.2-1012. 846

§ 46.2-1057. Windshields.

847 It shall be unlawful for any person to drive on a highway in the Commonwealth any motor vehicle 848 or reconstructed motor vehicle, other than a motorcycle or autocycle, registered in the Commonwealth, 849 which that was manufactured, assembled, or reconstructed after July 1, 1970, unless the motor vehicle is

850 equipped with a windshield.

851 § 46.2-1067. Within what distances brakes should stop vehicle.

852 On a dry, hard, approximately level stretch of highway free from loose material, the service braking
853 system shall be capable of stopping a motor vehicle or combination of vehicles at all times and under
854 all conditions of loading at a speed of twenty 20 miles per hour within the following distances:

- 855 1. Passenger motor vehicles, except buses and antique vehicles, twenty-five 25 feet.
- **856** 2. Buses, trucks, and tractor trucks, forty 40 feet.

857 3. Motor vehicles registered or qualified to be registered as antique vehicles, when equipped with
858 two-wheel brakes, forty-five 45 feet; four-wheel brakes, twenty-five 25 feet.

- **859** 4. All combinations of vehicles, forty 40 feet.
- **860** 5. Motorcycles *or autocycles*, thirty *30* feet.
- 861 § 46.2-1068. Emergency or parking brakes.

862 Every motor vehicle and combination of vehicles, except motorcycles or autocycles, shall be
863 equipped with emergency or parking brakes adequate to hold the vehicle or vehicles on any grade on
864 which it is operated, under all conditions of loading on a surface free from snow, ice, or loose material.

865 § 46.2-1092. Safety lap belts or a combination of lap belts and shoulder harnesses to be 866 installed in certain motor vehicles.

867 No passenger car *or autocycle* registered in the Commonwealth and manufactured for the year 1963
868 or for subsequent years shall be operated on the highways in the Commonwealth unless the front seats
869 thereof are equipped with adult safety lap belts or a combination of lap belts and shoulder harnesses of
870 types approved by the Superintendent.

871 Failure to use the safety lap belts or a combination of lap belts and shoulder harnesses after
872 installation shall not be deemed to be negligence. Nor shall evidence of such nonuse of such devices be
873 considered in mitigation of damages of whatever nature.

874 No motor vehicle registered in the Commonwealth and manufactured after January 1, 1968, shall be
875 issued a safety inspection approval sticker if any lap belt, combination of lap belt and shoulder harness,
876 or passive belt systems required to be installed at the time of manufacture by the federal Department of
877 Transportation have been either removed from the motor vehicle or rendered inoperable.

878 No autocycle registered in the Commonwealth shall be issued a safety inspection sticker if any lap
879 belt, combination of lap belt and shoulder harness, or passive belt systems required to be installed
880 under this section have been either removed from the autocycle or rendered inoperable.

881 No passenger car, except convertibles, registered in the Commonwealth and manufactured on or after
882 September 1, 1990, shall be operated on the highways in the Commonwealth unless the forward-facing
883 rear outboard seats thereof are equipped with rear seat lap/shoulder belts of types required to be installed
884 at the time of manufacture by the federal Department of Transportation.

885 No passenger car, including convertibles, registered in the Commonwealth and manufactured on or
886 after September 1, 1991, shall be operated on the highways in the Commonwealth unless the
887 forward-facing rear outboard seats thereof are equipped with rear seat lap/shoulder belts of types
888 required to be installed at the time of manufacture by the federal Department of Transportation.

889 No truck, multi-purpose vehicle, or bus, except school buses and motor homes, with a gross vehicle
890 weight rating of 10,000 pounds or less, registered in the Commonwealth and manufactured on or after
891 September 1, 1991, shall be operated on the highways in the Commonwealth unless the forward-facing
892 rear outboard seats thereof are equipped with rear seat lap/shoulder belts of types required to be installed
893 at the time of manufacture by the federal Department of Transportation.

Passenger cars, trucks, multipurpose vehicles, and buses, except school buses and motor homes,
registered in the Commonwealth and manufactured on or after September 1, 1992, shall not be operated
on the highways of the Commonwealth unless equipped with rear seat lap/shoulder belts of types
required to be installed at the time of manufacture by the federal Department of Transportation for each
forward-facing rear outboard seating position on a readily removable seat.

899 For the purposes of this section, forward-facing rear outboard seats are defined as those designated 900 seating positions for passengers in outside front facing seats behind the driver and front passenger seats, except any designated seating position adjacent to a walkway that is located between the seat and the 902 near side of the vehicle and is designed to allow access to a more rearward seating position.

903 The Superintendent of State Police shall include in the Official Motor Vehicle Inspection Regulations 904 a section which identifies each classification of motor vehicle required to be equipped with any of the 905 devices described in the foregoing provisions of this section.

Such regulations shall also include a listing of the exact devices which are required to be installed in
 each motor vehicle classification and the model year of each motor vehicle classification on which the
 standards of the federal Department of Transportation first became applicable.

909 § 46.2-1157. Inspection of motor vehicles required.

910 Å. The owner or operator of any motor vehicle, trailer, or semitrailer registered in Virginia and

911 operated or parked on a highway within the Commonwealth shall submit his vehicle to an inspection of 912 its mechanism and equipment by an official inspection station, designated for that purpose, in 913 accordance with § 46.2-1158. No owner or operator shall fail to submit a motor vehicle, trailer, or 914 semitrailer operated or parked on the highways in the Commonwealth to such inspection or fail or refuse 915 to correct or have corrected in accordance with the requirements of this title any mechanical defects 916 found by such inspection to exist.

917 B. The provisions of this section requiring safety inspections of motor vehicles shall also apply to 918 vehicles used for fire fighting firefighting; inspections of fire-fighting firefighting vehicles shall be 919 conducted pursuant to regulations promulgated by the Superintendent of State Police, taking into 920 consideration the special purpose of such vehicles and the conditions under which they operate.

921 C. Each day during which such motor vehicle, trailer, or semitrailer is operated or parked on any 922 highway in the Commonwealth after failure to comply with this law shall constitute a separate offense.

923 D. Except as otherwise provided, autocycles shall be inspected as motorcycles under this article. 924

§ 46.2-1167. Charges for inspection and reinspection; exemption.

A. Each official safety inspection station may charge no more than:

1. Fifty-one dollars for each inspection of any (i) tractor truck, (ii) truck that has a gross vehicle 926 927 weight rating of 26,000 pounds or more, or (iii) motor vehicle that is used to transport passengers and 928 has a seating capacity of more than 15 passengers, including the driver, \$0.50 of which shall be 929 transmitted to the Department of State Police to support the Department's costs in administering the 930 motor vehicle safety inspection program;

931 2. Twelve dollars for each inspection of any motorcycle, \$10 of which shall be retained by the 932 inspection station and \$2 of which shall be transmitted to the Department of State Police who shall 933 retain \$0.50 to support the Department's costs in administering the motor vehicle safety inspection 934 program and deposit the remaining \$1.50 into the Motorcycle Rider Safety Training Program Fund 935 created pursuant to § 46.2-1191; and

936 3. Twelve dollars for each inspection of any autocycle, \$10 of which shall be retained by the 937 inspection station and \$2 of which shall be transmitted to the Department of State Police to be used to 938 support the Department's costs in administering the motor vehicle safety inspection program; and

939 4. Sixteen dollars for each inspection of any other vehicle, \$0.50 of which shall be transmitted to the 940 Department of State Police to support the Department's costs in administering the motor vehicle safety 941 inspection program.

942 No such charge shall be mandatory, however, and no such charge shall be made unless the station 943 has previously contracted therefor.

944 B. Each official safety inspection station may charge \$1 for each reinspection of a vehicle rejected 945 by the station, as provided in § 46.2-1158, if the vehicle is submitted for reinspection within the validity 946 period of the rejection sticker. If a rejected vehicle is not submitted to the same station within the 947 validity period of the rejection sticker or is submitted to another official safety inspection station, an 948 amount no greater than that permitted under subsection A may be charged for the inspection. 949

§ 46.2-1500. Definitions.

925

950 Unless the context otherwise requires, the following words and terms for the purpose of As used in this chapter shall have the following meanings, unless the context requires a different meaning: 951

952 "Board" means the Motor Vehicle Dealer Board.

953 "Certificate of origin" means the document provided by the manufacturer of a new motor vehicle, or 954 its distributor, which is the only valid indication of ownership between the manufacturer, its distributor, 955 its franchised motor vehicle dealers, and the original purchaser not for resale.

956 "Dealer-operator" means the individual who works at the established place of business of a dealer 957 and who is responsible for and in charge of day-to-day operations of that place of business.

958 "Demonstrator" means a new motor vehicle having a gross vehicle weight rating of less than 16,000 959 pounds that (i) has more than 750 miles accumulated on its odometer that has been driven by dealer 960 personnel or by prospective purchasers during the course of selling, displaying, demonstrating, showing, 961 or exhibiting it and (ii) may be sold as a new motor vehicle, provided the dealer complies with the 962 provisions of subsection D of § 46.2-1530.

963 "Distributor" means a person who is licensed by the Department of Motor Vehicles under Chapter 19 964 (§ 46.2-1900 et seq.) of this title and who sells or distributes new motor vehicles pursuant to a written 965 agreement with the manufacturer, to franchised motor vehicle dealers in the Commonwealth.

966 "Distributor branch" means a branch office licensed by the Department of Motor Vehicles under 967 Chapter 19 (§ 46.2-1900 et seq.) of this title and maintained by a distributor for the sale of motor 968 vehicles to motor vehicle dealers or for directing or supervising, in whole or in part, its representatives 969 in the Commonwealth.

970 "Distributor representative" means a person who is licensed by the Department of Motor Vehicles 971 under Chapter 19 (§ 46.2-1900 et seq.) of this title and employed by a distributor or by a distributor

972 branch, for the purpose of making or promoting the sale of motor vehicles or for supervising or 973 contacting its dealers, prospective dealers, or representatives in the Commonwealth.

974 "Factory branch" means a branch office maintained by a person for the sale of motor vehicles to 975 distributors or for the sale of motor vehicles to motor vehicle dealers, or for directing or supervising, in 976 whole or in part, its representatives in the Commonwealth.

977 "Factory representative" means a person who is licensed by the Department of Motor Vehicles under 978 Chapter 19 (§ 46.2-1900 et seq.) of this title and employed by a person who manufactures or assembles 979 motor vehicles or by a factory branch for the purpose of making or promoting the sale of its motor **980** vehicles or for supervising or contacting its dealers, prospective dealers, or representatives in the 981 Commonwealth.

982 "Factory repurchase motor vehicle" means a motor vehicle sold, leased, rented, consigned, or 983 otherwise transferred to a person under an agreement that the motor vehicle will be resold or otherwise **984** retransferred only to the manufacturer or distributor of the motor vehicle, and which is reacquired by the 985 manufacturer or distributor, or its agents.

986 "Family member" means a person who either (i) is the spouse, child, grandchild, spouse of a child, 987 spouse of a grandchild, brother, sister, or parent of the dealer or owner or (ii) has been employed 988 continuously by the dealer for at least five years.

989 "Franchise" means a written contract or agreement between two or more persons whereby one 990 person, the franchisee, is granted the right to engage in the business of offering and selling, servicing, or 991 offering, selling, and servicing new motor vehicles of a particular line-make or late model or used motor 992 vehicles of a particular line-make manufactured or distributed by the grantor of the right, the franchisor, 993 and where the operation of the franchisee's business is substantially associated with the franchisor's 994 trademark, trade name, advertising, or other commercial symbol designating the franchisor, the motor 995 vehicle or its manufacturer or distributor. The term shall include "Franchise" includes any severable part 996 or parts of a franchise agreement which separately provides for selling and servicing different line-makes 997 of the franchisor.

998 "Franchised late model or franchised used motor vehicle dealer" means a dealer selling used motor 999 vehicles, including vehicles purchased from the franchisor, under the trademark of a manufacturer or 1000 distributor that has a franchise agreement with a manufacturer or distributor.

1001 "Franchised motor vehicle dealer" means a dealer in new motor vehicles that has a franchise 1002 agreement with a manufacturer or distributor of new motor vehicles, trailers, or semitrailers to sell new 1003 motor vehicles or to sell used motor vehicles under the trademark of a manufacturer or distributor 1004 regardless of the age of the motor vehicles, trailers, or semitrailers.

1005 "Fund" means the Motor Vehicle Dealer Board Fund.

1006 "Independent motor vehicle dealer" means a dealer in used motor vehicles.

1007 "Late model motor vehicle" means a motor vehicle of the current model year and the immediately 1008 preceding model year.

1009 "Line-make" means the name of the motor vehicle manufacturer or distributor and a brand or name 1010 plate marketed by the manufacturer or distributor.

1011 "Manufacturer" means a person who is licensed by the Department of Motor Vehicles under Chapter 1012 19 (§ 46.2-1900 et seq.) of this title and engaged in the business of constructing or assembling new motor vehicles and, in the case of trucks, also means a person engaged in the business of manufacturing 1013 1014 engines, power trains, or rear axles, when such engines, power trains, or rear axles are not warranted by 1015 the final manufacturer or assembler of the truck.

1016 "Motor vehicle" means the same as provided in § 46.2-100, except, for the purposes of this chapter, 1017 it shall "motor vehicle" does not include (i) trailers and semitrailers; (ii) manufactured homes, sales of 1018 which are regulated under Chapter 4.2 (§ 36-85.16 et seq.) of Title 36; (iii) motor homes; (iv) 1019 motorcycles; (v) autocycles; (vi) nonrepairable vehicles, as defined in § 46.2-1600; (vii) salvage vehicles, as defined in § 46.2-1600; or (vii) (viii) mobile cranes that exceed the size or weight 1020 limitations as set forth in § 46.2-1105, 46.2-1110, or 46.2-1113, or Article 17 (§ 46.2-1122 et seq.) of 1021 1022 Chapter 10 of this title. 1023

"Motor vehicle dealer" or "dealer" means any person who:

1024 1. For commission, money, or other thing of value, buys, sells, exchanges, either outright or on 1025 conditional sale, bailment lease, chattel mortgage, or otherwise or arranges or offers or attempts to 1026 solicit or negotiate on behalf of others a sale, purchase, or exchange of an interest in new motor 1027 vehicles, new and used motor vehicles, or used motor vehicles alone, whether or not the motor vehicles 1028 are owned by him; or

1029 2. Is wholly or partly engaged in the business of selling new motor vehicles, new and used motor 1030 vehicles, or used motor vehicles only, whether or not the motor vehicles are owned by him; or

1031 3. Offers to sell, sells, displays, or permits the display for sale, of five or more motor vehicles within 1032 any 12 consecutive months.

The term "motor "Motor vehicle dealer" or "dealer" does not include: 1033

1034 1. Receivers, trustees, administrators, executors, guardians, conservators or other persons appointed 1035 by or acting under judgment or order of any court or their employees when engaged in the specific 1036 performance of their duties as employees.

1037 2. Public officers, their deputies, assistants, or employees, while performing their official duties.

1038 3. Persons other than business entities primarily engaged in the leasing or renting of motor vehicles 1039 to others when selling or offering such vehicles for sale at retail, disposing of motor vehicles acquired 1040 for their own use and actually so used, when the vehicles have been so acquired and used in good faith 1041 and not for the purpose of avoiding the provisions of this chapter.

1042 4. Persons dealing solely in the sale and distribution of funeral vehicles, including motor vehicles 1043 adapted therefor; however, this exemption shall not exempt any person from the provisions of 1044 §§ 46.2-1519, 46.2-1520, and 46.2-1548.

1045 5. Any financial institution chartered or authorized to do business under the laws of the 1046 Commonwealth or the United States which may have received title to a motor vehicle in the normal 1047 course of its business by reason of a foreclosure, other taking, repossession, or voluntary reconveyance 1048 to that institution occurring as a result of any loan secured by a lien on the vehicle.

1049 6. An employee of an organization arranging for the purchase or lease by the organization of 1050 vehicles for use in the organization's business.

1051 7. Any person licensed to sell real estate who sells a manufactured home or similar vehicle in 1052 conjunction with the sale of the parcel of land on which the manufactured home or similar vehicle is 1053 located.

1054 8. Any person who permits the operation of a motor vehicle show or permits the display of motor 1055 vehicles for sale by any motor vehicle dealer licensed under this chapter.

1056 9. An insurance company authorized to do business in the Commonwealth that sells or disposes of vehicles under a contract with its insured in the regular course of business. 1057

10. Any publication, broadcast, or other communications media when engaged in the business of 1058 advertising, but not otherwise arranging for the sale of vehicles owned by others. 1059 1060

11. Any person dealing solely in the sale or lease of vehicles designed exclusively for off-road use.

12. Any credit union authorized to do business in Virginia, provided the credit union does not 1061 1062 receive a commission, money, or other thing of value directly from a motor vehicle dealer.

13. Any person licensed as a manufactured home dealer, broker, manufacturer, or salesperson under 1063 1064 Chapter 4.2 (§ 36-85.16 et seq.) of Title 36.

14. The State Department of Social Services or local departments of social services.

1066 "Motor vehicle salesperson" or "salesperson" means (i) any person who is hired as an employee by a 1067 motor vehicle dealer to sell or exchange motor vehicles and who receives or expects to receive a 1068 commission, fee, or any other consideration from the dealer; (ii) any person who supervises salespersons employed by a motor vehicle dealer, whether compensated by salary or by commission; (iii) any person, 1069 compensated by salary or commission by a motor vehicle dealer, who negotiates with or induces a 1070 1071 customer to enter into a security agreement on behalf of a dealer; or (iv) any person who is licensed as 1072 a motor vehicle dealer and who sells or exchanges motor vehicles. For purposes of this section, any person who is an independent contractor as defined by the United States Internal Revenue Code shall be 1073 1074 deemed not to be a motor vehicle salesperson.

"Motor vehicle show" means a display of motor vehicles to the general public at a location other 1075 1076 than a dealer's location licensed under this chapter where the vehicles are not being offered for sale or 1077 exchange during or as part of the display.

"New motor vehicle" means any vehicle that is in the possession of the manufacturer, factory branch, 1078 1079 distributor, distributor branch, or motor vehicle dealer and for which an original title has not been issued 1080 by the Department of Motor Vehicles of the Commonwealth or by the issuing agency of any other state 1081 and has less than 7,500 miles accumulated on its odometer.

1082 "Original license" means a motor vehicle dealer license issued to an applicant who has never been 1083 licensed as a motor vehicle dealer in Virginia or whose Virginia motor vehicle dealer license has been 1084 expired for more than 30 days. 1085

"Relevant market area" means as follows:

1065

1086 1. In metropolitan localities, the relevant market area shall be a circular area around an existing 1087 franchised dealer with a population of 250,000, not to exceed a radius of 10 miles, but in no case less 1088 than seven miles.

1089 2. If the population in an area within a radius of 10 miles around an existing franchised dealer is less 1090 than 250,000, but the population in an area within a radius of 15 miles around an existing franchised 1091 dealer is 150,000 or more, the relevant market area shall be that area within the 15-mile radius.

1092 3. In all other cases the relevant market area shall be an area within a radius of 20 miles around an 1093 existing franchised dealer or the area of responsibility defined in the franchise, whichever is greater. In

any case where the franchise agreement is silent as to area of responsibility, the relevant market area shall be the greater of an area within a radius of 20 miles around an existing franchised dealer or that area in which the franchisor otherwise requires the franchisee to make significant retail sales or sales efforts.

 Notwithstanding the foregoing provision of this section, in the case of dealers in motor vehicles with gross vehicle weight ratings of 26,000 pounds or greater, the relevant market area with respect to the dealer's franchise for all such vehicles shall be a circular area around an existing franchised dealer with a radius of 25 miles, except where the population in such circular area is less than 250,000, in which case the relevant market area shall be a circular area around an existing franchised dealer with a radius of 50 miles.

1104 In determining population for this definition, the most recent census by the U.S. Bureau of the
1105 Census or the most recent population update, either from the National Planning Data Corporation or
1106 other similar recognized source, shall be accumulated for all census tracts either wholly or partially
1107 within the relevant market area.

1108 "Retail installment sale" means every sale of one or more motor vehicles to a buyer for his use and 1109 not for resale, in which the price of the vehicle is payable in one or more installments and in which the 1110 seller has either retained title to the goods or has taken or retained a security interest in the goods under 1111 form of contract designated either as a security agreement, conditional sale, bailment lease, chattel 1112 mortgage, or otherwise.

1113 "Sale at retail" or "retail sale" means the act or attempted act of selling, bartering, exchanging, or 1114 otherwise disposing of a motor vehicle to a buyer for his personal use and not for resale.

"Sale at wholesale" or "wholesale" means a sale to motor vehicle dealers or wholesalers other than to consumers; a sale to one who intends to resell.

1117 "Used motor vehicle" means any vehicle other than a new motor vehicle as defined in this section.

1118 "Wholesale auction" means an auction of motor vehicles restricted to sales at wholesale.

1119 § 46.2-1993. Definitions.

1120 Unless the context otherwise requires, the following words and terms for the purpose of As used in 1121 this chapter shall have the following meanings, unless the context requires a different meaning:

1122 "All-terrain vehicle" shall have has the meaning ascribed to it in § 46.2-100.

1123 "Autocycle" has the meaning ascribed to it in \S 46.2-100.

"Certificate of origin" means the document provided by the manufacturer of a new motorcycle, or its distributor, which is the only valid indication of ownership between the manufacturer, its distributor, its franchised motorcycle dealers, and the original purchaser not for resale.

1127 "Dealer-operator" means the individual who works at the established place of business of a dealer 1128 and who is responsible for and in charge of day-to-day operations of that place of business.

1134 "Distributor representative" means a person employed by a distributor or by a distributor branch, for
1135 the purpose of making or promoting the sale of motorcycles or for supervising or contacting its dealers,
1136 prospective dealers, or representatives in the Commonwealth.

1137 "Factory branch" means a branch office maintained by a person for the sale of motorcycles to distributors or for the sale of motorcycles to motorcycle dealers, or for directing or supervising, in whole or in part, its representatives in the Commonwealth.

1140 "Factory representative" means a person employed by a person who manufactures or assembles
1141 motorcycles, or by a factory branch for the purpose of making or promoting the sale of its motorcycles, or for supervising or contacting its dealers, prospective dealers, or representatives in the Commonwealth.

1143 "Factory repurchase motorcycle" means a motorcycle sold, leased, rented, consigned, or otherwise 1144 transferred to a person under an agreement that the motorcycle will be resold or otherwise retransferred 1145 only to the manufacturer or distributor of the motorcycle, and which is reacquired by the manufacturer 1146 or distributor, or its agents.

offering, selling, and servicing new motorcycles of a particular line-make or late model or factory
repurchase motorcycles of a particular line-make manufactured or distributed by the grantor of the right,

1166 "Independent motorcycle dealer" means a dealer in used motorcycles.

"Late model motorcycle" means a motorcycle of the current model year and the immediately 1167 1168 preceding model year.

1169 "Line-make" means the name of the motorcycle manufacturer or distributor and a brand or name 1170 plate marketed by the manufacturer or distributor. For the purposes of this chapter, the "line-make" of a 1171 motorcycle manufacturer, factory branch, distributor, or distributor branch shall include includes every 1172 brand of all-terrain vehicle, *autocycle*, and off-road motorcycle manufactured or distributed bearing the 1173 name of the motorcycle manufacturer or distributor.

1216 dealer's location licensed under this chapter where the motorcycles are not being offered for sale or 1217 exchange during or as part of the display.

1218 "New motorcycle" means any motorcycle which (i) has not been previously sold except in good faith 1219 for the purpose of resale, (ii) has not been used as a rental, driver education, or demonstration 1220 motorcycle, or for the personal and business transportation of the manufacturer, distributor, dealer, or 1221 any of his employees, (iii) has not been used except for limited use necessary in moving or road testing 1222 the motorcycle prior to delivery to a customer, (iv) is transferred by a certificate of origin, and (v) has 1223 the manufacturer's certification that it conforms to all applicable federal motorcycle safety and emission 1224 standards. Notwithstanding provisions (i) and (iii), a motorcycle that has been previously sold but not 1225 titled shall be deemed a new motorcycle if it meets the requirements of provisions (ii), (iv), and (v). 1226

"Off-road motorcycle" shall have has the meaning ascribed to it in § 46.2-100.

1227 "Original license" means a motorcycle dealer license issued to an applicant who has never been 1228 licensed as a motorcycle dealer in Virginia or whose Virginia motorcycle dealer license has been expired 1229 for more than 30 days.

"Relevant market area" means:

1230

1231 1. That area within a circle having a radius of 20 miles around an existing franchised dealer location, 1232 except as provided in subdivisions 2 and 3.

1233 2. That area within a circle having a radius of 30 miles around an existing franchised dealer location 1234 if the population within that circle is less than one million but more than 750,000.

1235 3. If the population within a circle having a radius of 30 miles around an existing franchised dealer 1236 location is less than 750,000, "relevant market area" means that area within a circle around such dealer 1237 having a radius of 40 miles.

1238 In any case in which the franchise agreement or the manufacturer requires the franchisee to make 1239 significant retail sales or marketing efforts in geographic areas beyond the franchisee's relevant market 1240 area, then such geographic areas shall be added to the relevant market area of the dealer.

In determining population for this definition, the most recent census by the U.S. Bureau of the 1241 1242 Census or the most recent population update, either from the National Planning Data Corporation or 1243 other similar recognized source, shall be accumulated for all census tracts either wholly or partially 1244 within the relevant market area.

1254 "Used motorcycle" means any motorcycle other than a new motorcycle as defined in this section.

1255 "Wholesale auction" means an auction of motorcycles restricted to sales at wholesale.
