2 *An Act to amend and reenact §§ 3.2-6553 and 3.2-6584 of the Code of Virginia, relating to*
3 *compensation for livestock and poultry killed by dogs and hybrid canines.*

6 **Be it enacted by the General Assembly of Virginia:**

7 **1. That §§ 3.2-6553 and 3.2-6584 of the Code of Virginia are amended and reenacted as follows:**

8 **§ 3.2-6553. Compensation for livestock and poultry killed by dogs.**

9 Any person who has any livestock or poultry killed or injured by any dog not his own shall be
10 entitled to receive as compensation the fair market value of such livestock or poultry not to exceed \$400
11 \$750 per animal or \$10 per fowl if: (i) the claimant has furnished evidence within 60 days of discovery
12 of the quantity and value of the dead or injured livestock and the reasons the claimant believes that
13 death or injury was caused by a dog; (ii) the animal control officer or other officer shall have been
14 notified of the incident within 72 hours of its discovery; and (iii) the claimant first has exhausted his
15 legal remedies against the owner, if known, of the dog doing the damage for which compensation under
16 this section is sought. Exhaustion shall mean a judgment against the owner of the dog upon which an
17 execution has been returned unsatisfied.

18 Local jurisdictions may by ordinance waive the requirements of *clause* (ii) or (iii) or both provided
19 that the ordinance adopted requires that the animal control officer has conducted an investigation and
20 that his investigation supports the claim. Upon payment under this section, the local governing body
21 shall be subrogated to the extent of compensation paid to the right of action to the owner of the
22 livestock or poultry against the owner of the dog and may enforce the same in an appropriate action at
23 law.

24 **§ 3.2-6584. Compensation for livestock and poultry killed by hybrid canines.**

25 Any person who has any livestock or poultry killed or injured by any hybrid canine not his own
26 shall be entitled to receive as compensation the fair market value of such livestock or poultry not to
27 exceed \$400 \$750 per animal or \$10 per fowl if: (i) the claimant has furnished evidence within 60 days
28 of discovery of the quantity and value of the dead or injured livestock and the reasons the claimant
29 believes that death or injury was caused by a hybrid canine; (ii) the animal control officer or other
30 officer shall have been notified of the incident within 72 hours of its discovery; and (iii) the claimant
31 first has exhausted his legal remedies against the owner, if known, of the hybrid canine doing the
32 damage for which compensation under this section is sought. Exhaustion shall mean a judgment against
33 the owner of the hybrid canine upon which an execution has been returned unsatisfied.

34 Local jurisdictions may by ordinance waive the requirements of *clause* (ii) or (iii) or both provided
35 that the ordinance adopted requires that the animal control officer has conducted an investigation and
36 that his investigation supports the claim. Upon payment under this section the local governing body shall
37 be subrogated to the extent of compensation paid to the right of action to the owner of the livestock or
38 poultry against the owner of the hybrid canine and may enforce the same in an appropriate action at
39 law.
