11	Be it enacted by the General Assembly of Virginia:
12	1. That § 19.2-386.28 of the Code of Virginia is amended and reenacted and that the Code of
13 14	Virginia is amended by adding a section numbered 18.2-308.1:6 as follows: § 18.2-308.1:6. Possession of firearms following certain criminal convictions; penalty.
14	A. Any person who knowingly and intentionally possesses or transports any firearm, or who
16	knowingly and intentionally possesses, transports, or carries about his person any weapon described in
17	subsection A of § 18.2-308, within a five-year period following his conviction for (i) stalking in violation
18	of § 18.2-60.3, (ii) sexual battery in violation of § 18.2-67.4, (iii) assault and battery of a family or
19	household member in violation of § 18.2-57.2 involving the use of force, or (iv) any offense
20	substantially similar to clause (i), (ii), or (iii) in the laws of any other state or of the United States is
21	guilty of a Class 6 felony.
22	B. The provisions of subsection C of § $18.2-308.2$ regarding petitioning a circuit court for a permit
23 24	to possess, transport, or carry a firearm shall apply, mutatis mutandis, to a person subject to the prohibitions of this section.
25	§ 19.2-386.28. Forfeiture of weapons that are concealed, possessed, transported or carried in
26	violation of law.
27	Any firearm, stun weapon as defined by § 18.2-308.1, or any weapon concealed, possessed,
28	transported or carried in violation of § 18.2-283.1, 18.2-287.01, 18.2-287.4, 18.2-308.1:2, 18.2-308.1:3,
29	18.2-308.1:4, 18.2-308.1:6, 18.2-308.2, 18.2-308.2:01, 18.2-308.2:1, 18.2-308.4, 18.2-308.5, 18.2-308.7,
30	or 18.2-308.8 shall be forfeited to the Commonwealth and disposed of as provided in § 19.2-386.29.
31 32	2. That the provisions of this act may result in a net increase in periods of imprisonment or commitment. Pursuant to $\$$ 30 10 1:4, the estimated amount of the necessary appropriation cannot
32 33	commitment. Pursuant to § 30-19.1:4, the estimated amount of the necessary appropriation cannot be determined for periods of imprisonment in state adult correctional facilities; therefore, Chapter
33 34	806 of the Acts of Assembly of 2013 requires the Virginia Criminal Sentencing Commission to
35	assign a minimum fiscal impact of \$50,000. Pursuant to § 30-19.1:4, the estimated amount of the
36	necessary appropriation cannot be determined for periods of commitment to the custody of the
37	Department of Juvenile Justice.
