7 **Be it enacted by the General Assembly of Virginia:**

8 **1. That the Code of Virginia is amended by adding in Title 15.2 a chapter numbered 65.1,**
9 **consisting of sections numbered 15.2-6550 through 15.2-6554, as follows:**

10 **CHAPTER 65.1.**11 **TOURIST TRAIN DEVELOPMENT AUTHORITY.**12 **§ 15.2-6550. Tourist Train Development Authority established.**

13 *The Tourist Train Development Authority, hereinafter referred to as the "Authority," is created as a*
14 *body politic and corporate, a political subdivision of the Commonwealth. As such it shall have, and is*
15 *hereby vested with, the powers and duties hereinafter conferred in this chapter.*

16 **§ 15.2-6551. Board of the Authority; qualifications; terms; quorum; records.**

17 *All powers, rights, and duties conferred by this chapter, or by other provisions of law, upon the*
18 *Authority shall be exercised by the Board of the Tourist Train Development Authority, hereinafter*
19 *referred to as "the board." Initial appointments to the board shall begin July 1, 2014. The board shall*
20 *consist of nine members as follows: seven members appointed by the Governor, of whom three shall be*
21 *representatives from the governing bodies of Tazewell County, the Town of Bluefield, and the Town of*
22 *Pocahontas and four shall be nonlegislative citizen members who reside in Tazewell County; one*
23 *member of the House of Delegates representing Tazewell County, who shall be appointed by the Speaker*
24 *of the House of Delegates if more than one Delegate represents Tazewell County; and one member of*
25 *the Senate representing Tazewell County, who shall be appointed by the Senate Committee on Rules if*
26 *more than one Senator represents Tazewell County. All members shall serve for a term of four years*
27 *and may be reappointed for one additional term, except legislative members, who shall serve terms*
28 *coincident with their terms of office and may be reappointed. The term of any member of the board*
29 *shall immediately terminate if the member no longer meets the eligibility criteria of the initial*
30 *appointment. Vacancies shall be filled for the unexpired term. For the initial appointments only, three of*
31 *the members shall be appointed for two-year terms and such initial terms shall not be counted toward*
32 *the term limitation.*

33 *The board shall elect from its membership a chairman and a vice-chairman and from its membership*
34 *or not, as they desire, a secretary and a treasurer, or a secretary-treasurer, who shall continue to hold*
35 *such office until their respective successors are elected. The members of the board shall receive no*
36 *compensation. All members may be reimbursed for reasonable and necessary expenses incurred in the*
37 *performance of their duties from such funds as may be available to the Authority.*

38 *Four members of the board shall constitute a quorum of the board for the purposes of conducting its*
39 *business and exercising its powers and for all other purposes. No vacancy in the membership of the*
40 *board shall impair the right of a quorum to exercise all the powers and perform all the duties of the*
41 *board. The board shall keep detailed minutes of its proceedings, which shall be open to public*
42 *inspection at all times. It shall keep suitable records of its financial transactions, and, unless exempted*
43 *by § 30-140, it shall arrange to have the records audited annually. Copies of each such audit shall be*
44 *furnished to the governing bodies of Tazewell County and all adjacent counties and the Auditor of*
45 *Public Accounts and shall be open to public inspection.*

46 **§ 15.2-6552. Executive director; staff.**

47 *The Authority shall appoint an executive director, who shall be authorized to employ such staff as*
48 *necessary to enable the Authority to perform its duties as set forth in this chapter. The Authority is*
49 *authorized to determine the duties of such staff and to fix salaries and compensation from such funds as*
50 *may be received or appropriated.*

51 **§ 15.2-6553. Powers of Authority.**

52 *The Authority shall have the following powers together with all powers incidental thereto or*
53 *necessary for the performance of those hereafter stated:*

54 *1. To sue and be sued and to prosecute and defend, at law or in equity, in any court having*
55 *jurisdiction of the subject matter and of the parties;*

56 *2. To adopt and use a corporate seal and to alter the same at its pleasure;*

- 57 3. To contract and be contracted with;
58 4. To employ and pay compensation to such employees and agents, including attorneys, as the board
59 deems necessary in carrying on the business of the Authority;
60 5. To establish bylaws and make all rules and regulations, not inconsistent with the provisions of this
61 chapter, deemed expedient for the management of the Authority's affairs;
62 6. To borrow money and to accept contributions, grants, and other financial assistance from the
63 United States of America and agencies or instrumentalities thereof, the Commonwealth, or any political
64 subdivision, agency, or public instrumentality of the Commonwealth;
65 7. To issue bonds in accordance with applicable law;
66 8. To receive and expend moneys on behalf of tourist train development; and
67 9. To cooperate with any private or governmental entity in the state of West Virginia in the
68 development of a tourist train.
- 69 **§ 15.2-6554. Authority of localities.**
70 Localities are hereby authorized to lend or donate money or other property or services to the
71 Authority for any of its purposes. The locality making the grant or loan may restrict the use of such
72 grants or loans to a specific project, within or outside that locality.
