6 7 8 9 10 11 12 13 14 15 16 17	 Be it enacted by the General Assembly of Virginia: 1. That § 58.1-2403 of the Code of Virginia is amended and reenacted as follows: § 58.1-2403. Exemptions. No tax shall be imposed as provided in § 58.1-2402 if the vehicle is: Sold to or used by the United States government or any governmental agency thereof; Sold to or used by the Commonwealth of Virginia or any political subdivision thereof; Registered in the name of a volunteer fire department or rescue squad not operated for profit; Registered to any member of the Mattaponi, Pamunkey, or Chickahominy Indian tribes or any other recognized Indian tribe of the Commonwealth living on the tribal reservation; Transferred incidental to repossession under a recorded lien and ownership is transferred to the lienholder;

A gift to the spouse, son, or daughter, or parent of the transferor. With the exception of a gift to a spouse, this exemption shall not apply to any unpaid obligation assumed by the transferee incidental to the transfer; 8. Transferred from an individual or partnership to a corporation or limited liability company or from a corporation or limited liability company to an individual or partnership if the transfer is incidental to the formation, organization or dissolution of a corporation or limited liability company in which the individual or partnership holds the majority interest; 9. Transferred from a wholly owned subsidiary to the parent corporation or from the parent corporation to a wholly owned subsidiary; 10. Being registered for the first time in the Commonwealth and the applicant holds a valid, assignable title or registration issued to him by another state or a branch of the United States Armed Forces and (i) has owned the vehicle for longer than 12 months and provides evidence of a sales tax paid to another state. However, when a vehicle has been purchased by the applicant within the last 12 months and the applicant is unable to provide evidence of a sales tax paid to another state, the applicant shall pay the Virginia sales tax based on the fair market value of the vehicle at the time of registration in Virginia; 11. a. Titled in a Virginia or non-Virginia motor vehicle dealer's name for resale; or b. Titled in the name of an automotive manufacturer having its headquarters in Virginia, except for any commercially leased vehicle that is not described under subdivision 3 of § 46.2-602.2. For purposes of this subdivision, "automotive manufacturer" and "headquarters" means the same as such terms are defined in § 46.2-602.2;

A motor vehicle having seats for more than seven passengers and sold to an urban or suburban bus line the majority of whose passengers use the buses for traveling a distance of less than 40 miles, one way, on the same day; 13. Purchased in the Commonwealth by a nonresident and a Virginia title is issued for the sole purpose of recording a lien against the vehicle if the vehicle will be registered in a state other than Virginia; 14. A motor vehicle designed for the transportation of 10 or more passengers, purchased by and for the use of a church conducted not for profit; 15. Loaned or leased to a private nonprofit institution of learning, for the sole purpose of use in the instruction of driver's education when such education is a part of such school's curriculum for full-time students;

Sold to an insurance company or local government group self-insurance pool, created pursuant to § 15.2-2703, for the sole purpose of disposition when such company or pool has paid the registered owner of such vehicle a total loss claim; 17. Owned and used for personal or official purposes by accredited consular or diplomatic officers of foreign governments, their employees or agents, and members of their families, if such persons are nationals of the state by which they are appointed and are not citizens of the United States; 18. A self-contained mobile computerized axial tomography scanner sold to, rented or used by a

59 19. A motor vehicle having seats for more than seven passengers and sold to a restricted common60 carrier or common carrier of passengers;

20. Beginning July 1, 1989, a self-contained mobile unit designed exclusively for human diagnostic
or therapeutic service, sold to, rented to, or used by a nonprofit hospital, or a cooperative hospital
service organization as described in § 501(e) of the United States Internal Revenue Code, or a nonprofit
corporation as defined in § 501(c)(3) of the Internal Revenue Code, established for research in, diagnosis
of, or therapy for human ailments;

66 21. Transferred, as a gift or through a sale to an organization exempt from taxation under § 501(c)(3)
67 of the Internal Revenue Code, provided the motor vehicle is not titled and tagged for use by such organization;

69 22. A motor vehicle sold to an organization which is exempt from taxation under § 501(c)(3) of the
70 Internal Revenue Code and which is organized for the primary purpose of distributing food, clothing,
71 medicines, and other necessities of life to, and providing shelter for, needy persons in the United States
72 and throughout the world;

Transferred to the trustees of a revocable inter vivos trust, when the individual titleholder of a 74 Virginia titled motor vehicle and the beneficiaries of the trust are the same persons, regardless of 75 whether other beneficiaries of the trust may also be named in the trust instrument, when no 76 consideration has passed between the titleholder and the beneficiaries; and transferred to the original 77 titleholder from the trustees holding title to the motor vehicle;

Transferred to trustees of a revocable inter vivos trust, when the owners of the vehicle and the beneficiaries of the trust are the same persons, regardless of whether other beneficiaries may also be named in the trust instrument, or transferred by trustees of such a trust to beneficiaries of the trust following the death of the grantor, when no consideration has passed between the grantor and the beneficiaries in either case;

83 25. Sold by a vehicle's lessor to its lessee upon the expiration of the term of the vehicle's lease, if
84 the lessee is a natural person and this natural person has paid the tax levied pursuant to this chapter with
85 respect to the vehicle when he leased it from the lessor, and if the lessee presents an original copy of
86 the lease upon request of the Department of Motor Vehicles or other evidence that the sales tax has
87 been paid to the Commonwealth by the lessee purchasing the vehicle;

88 26. Titled in the name of a deceased person and transferred to the spouse or heir, or under the will,89 of such deceased person;

27. An all-terrain vehicle, moped, or off-road motorcycle all as defined in § 46.2-100. Such all-terrain vehicles, mopeds, or off-road motorcycles shall not be deemed a motor vehicle or other vehicle subject to the tax imposed under this chapter; or
