12	1. That the Code of Virginia is amended by adding in Article 2 of Chapter 3 of Title 24.2 a

14	§ 24.2-304.04. House of Delegates districts.
15	Subject to the provisions of subsections A, B, and C of § 24.2-304.03, the following House of
16	Delegates districts shall be comprised as follows:
17	Twenty-fifth. Part of Albemarle County comprised of the Belfield (204), Brownsville (604), Crozet
18	(601), Ivy (301), Jack Jouett (201), and Yellow Mountain (605) Precincts and part of the East Ivy (304)
19 20	Precinct; part of Augusta County comprised of the Crimora (201), Dooms (801), Fort Defiance (301), New Hone (202), Variance (102), Wayner Cause (203), and Wilson (803), Precincts and part of the
20 21	New Hope (202), Verona (103), Weyers Cave (203), and Wilson (803) Precincts and part of the Fishersville (802) Precinct; and part of Rockingham County comprised of the Bridgewater (401),
22	Grottoes (304), Massanetta Springs (305), Mt. Crawford (403), North River (303), Ottobine (207), and
23	Port Republic (302) Precincts and parts of the Montezuma (402) and Silver Lake (405) Precincts.
23 24	Twenty-sixth. All of the City of Harrisonburg; and part of Rockingham County comprised of the
25	Bergton (104), Broadway (101), Dayton (404), Edom (202), Fulks Run (103), Keezletown (301), Melrose
26	(203), Mt. Clinton (204), Singers Glen (201), Stony Run (505), and Timberville (102) Precincts and
27	parts of the Montezuma (402), Plains (107), and Silver Lake (405) Precincts.
28	All other House of Delegates districts shall be comprised as provided in § 24.2-304.03.
29	2. That the first enactment changes the assignment of certain census blocks to House of Delegates

and block 511650115001019 is reassigned from District 26 to District 25.
