HOUSE JOINT RESOLUTION NO. 523

Offered January 14, 2015

Prefiled December 17, 2014

Providing for a Joint Assembly and establishing a schedule for the conduct of business coming before the 2015 Regular Session of the General Assembly of Virginia.

RESOLVED by the House of Delegates, the Senate concurring, That the General Assembly shall 8 9 meet in joint session in the Hall of the House of Delegates on Wednesday, January 14, 2015, at such 10 time as specified by the Speaker of the House of Delegates, to receive the Governor of Virginia, and such address as he may desire to make, and that the rules for the government of the House of Delegates 11 and the Senate, when convened in joint session for such purpose, shall be as follows: 12

13 Rule I. At the hour fixed for the meeting of the Joint Assembly, the Senators, accompanied by the 14 President and the Clerk of the Senate, shall proceed to the Hall of the House of Delegates and shall be 15 received by the Delegates standing. Appropriate seats shall be assigned to the Senators by the Sergeant at Arms of the House. The Speaker of the House of Delegates shall assign an appropriate seat for the 16 17 President of the Senate.

Rule II. The Speaker of the House of Delegates shall be President of the Joint Assembly. In case it 18 19 shall be necessary for the Speaker to vacate the Chair, the President of the Senate shall serve as the 20 presiding officer.

21 Rule III. The Clerk of the House of Delegates shall be Clerk of the Joint Assembly and shall be 22 assisted by the Clerk of the Senate. The Clerk of the Joint Assembly shall enter the proceedings of the 23 Joint Assembly in the Journal of the House and shall certify a copy of the same to the Clerk of the 24 Senate, who shall enter the same in the Journal of the Senate.

25 Rule IV. The Sergeant at Arms and Doorkeepers of the House shall act as such for the Joint 26 Assembly. 27

Rule V. The Rules of the House of Delegates, as far as applicable, shall be the rules of the Joint Assembly.

29 Rule VI. In calling the roll of the Joint Assembly, the names of the Senators shall be called in 30 alphabetical order, then the names of the Delegates in like order, except that the name of the Speaker of 31 the House shall be called last.

32 Rule VII. If, when the Joint Assembly meets, it shall be ascertained that a majority of each house is 33 not present, the Joint Assembly may take measures to secure the attendance of absentees, or adjourn to a 34 succeeding day, as a majority of those present may determine.

35 Rule VIII. When the Joint Assembly adjourns, the Senators, accompanied by the President and the 36 Clerk of the Senate, shall return to their chamber, and the business of the House shall be continued in 37 the same order as at the time of the entrance of the Senators; and, be it

38 RESOLVED FURTHER, That notwithstanding any other provision of this resolution and in 39 accordance with the practices of each house, a request to be added as a co-patron shall be received prior 40 to the first vote on the passage of a bill or agreement to a joint resolution or, if the bill or joint 41 resolution is not reported from committee, then prior to the last action on such legislation. A request to be removed as a co-patron shall be received no later than 5:00 p.m., Friday, February 20, 2015; and, be 42 43 it

44 RESOLVED FURTHER, That any joint resolution creating or continuing a study shall require a vote 45 of two-thirds of the members voting in each house and any resolution creating or continuing a study shall require a vote of two-thirds of the members voting in the respective house; and, be it 46

47 RESOLVED FURTHER, That any member offering for introduction a bill or joint resolution not 48 submitted to the Division of Legislative Services for drafting is encouraged to submit an electronic 49 version no later than 5:00 p.m. on the day the legislation is introduced; and, be it

50 RESOLVED FURTHER, That for purposes of the procedural deadlines established herein for the 51 2015 Regular Session of the General Assembly:

52 "Budget Bill" shall mean the general appropriation bill introduced in each house that authorizes the biennial expenditure of public revenues for the period from July 1, 2014, through June 30, 2016. 53 54

"Debt bill" shall mean any bill that authorizes the issuance of debt.

55 "Legislative day" shall mean the period of time that begins with the call to order by the presiding officer and ends when declared adjourned by the presiding officer. Unless another time is specified, any 56 57 deadline established in this resolution shall expire at the end of the legislative day.

58 "Prefiled legislation" shall mean any bill or joint resolution requested from the Division of 59 Legislative Services no later than 5:00 p.m., Monday, December 8, 2014, and prefiled no later than 60 10:00 a.m., Wednesday, January 14, 2015, or any bill or joint resolution not requested from the Division 61 of Legislative Services and prefiled no later than 10:00 a.m., Wednesday, January 14, 2015.

62 "Revenue bill" shall mean any bill, except the Budget Bill and debt bills, that increases or decreases 63 the total revenues available for appropriation, including any sales tax exemption bill.

64 "Unanimous consent" shall mean the affirmation of all the members present in the house of origin. Any legislation intended to be offered for introduction with unanimous consent or with the written 65 request of the Governor shall not require the consent of the house in order for the member to request 66 the Division of Legislative Services to draft such legislation. The Division of Legislative Services shall 67 return such legislation after the original introduction deadline. 68

"Virginia Retirement System bill" shall mean any bill that amends, adds, repeals, or modifies any 69 70 provision of any retirement system established in Title 51.1 of the Code of Virginia; and, be it

RESOLVED FINALLY, That the 2015 Regular Session of the General Assembly shall be governed 71 72 by the following procedural rules, which establish introduction limits and time limitations for elections 73 and for all legislation prefiled and introduced for or continued to the 2015 Regular Session except:

74 House and Senate resolutions, except for the time limitations established in Rules 20 and 22;

bills and joint resolutions affecting the rules of procedure or the schedule of business of the General 75 76 Assembly, either of its houses, or any of its committees;

77 bills and joint resolutions introduced with unanimous consent either to exceed the introduction limits 78 established in Rule 1 or to exceed the time limitations established in Rules 3, 4, 7, and 17;

79 joint resolutions confirming appointments subject to the confirmation of the General Assembly;

80 joint commending and memorial resolutions, except for the time limitations established in Rules 15 81 and 17:

82 bills and joint resolutions regarding elections held by the General Assembly during the 2015 Regular 83 Session; 84

bills and joint resolutions requested in writing by the Governor; or

85 bills and joint resolutions related to the redrawing of the districts of the members of the United 86 States House of Representatives.

87 Rule 1. After the deadline for filing prefiled legislation established by House Joint Resolution No. 18 88 (2014), no member of the House of Delegates shall introduce more than a combined total of five bills 89 and joint resolutions and no member of the Senate shall introduce more than a combined total of eight 90 bills and joint resolutions. Notwithstanding the provisions of this rule and in accordance with House 91 Rule 37, no member of the House of Delegates may introduce more than 15 bills during the 2015 92 Regular Session.

93 Rule 2. Neither house of the General Assembly shall receive from any committee any bill or joint 94 resolution that was continued on the agenda of such committee and acted upon later than midnight, Wednesday, December 3, 2014. For purposes of this rule, a motion to refer a measure to another 95 committee shall be treated as an action by a committee. 96

97 Rule 3. No bill or joint resolution creating or continuing a study shall be offered in either house after 98 the adjournment of that house on Wednesday, January 14, 2015.

99 Rule 4. No Virginia Retirement System bill shall be offered in either house after adjournment of that 100 house on Wednesday, January 14, 2015.

101 Rule 5. Except for bills and joint resolutions required to be requested earlier, requests for the drafting, redrafting, or correction of any bill or joint resolution shall be submitted to and received by the 102 Division of Legislative Services no later than 5:00 p.m., Friday, January 16, 2015. 103

Rule 6. No later than Monday, January 19, 2015, each house shall begin its consideration of any 104 election to fill any judicial seat in the courts of the Commonwealth, or to fill a seat on any commission 105 106 or office elected by the General Assembly. In the event that the houses cannot agree on such election 107 before Tuesday, January 20, 2015, such election shall become the subject of a special and continuing 108 joint order in each house, and such special and continuing joint order shall have precedence over all 109 other business of either house, until such time as both houses reach agreement on such election or agree 110 to hold it at another specific time. The Rules of each house, as far as applicable, shall be the rules 111 governing such election.

112 Rule 7. Except for bills required to be filed earlier, no bill or joint resolution shall be offered in 113 either house after 3:00 p.m., Friday, January 23, 2015.

Rule 8. No later than Friday, January 23, 2015, the Board of Trustees of the Virginia Retirement System shall submit, in accordance with § 30-19.1:7, impact statements for all Virginia Retirement 114 115 System bills filed by the first day of session. For any Virginia Retirement System bill filed later than the 116 first day of session, the Board of Trustees shall use due diligence in preparing the impact statement in 117 time for review by the standing committees. 118

119 Rule 9. The committees responsible for the consideration of revenue bills in the houses of introduction shall complete their work on such bills no later than midnight, Thursday, February 5, 2015.
Rule 10. The committees responsible for the consideration of the Budget Bill in the houses of introduction shall complete their work on such bill no later than midnight, Sunday, February 8, 2015, and any amendments proposed by such committees shall be made available to their respective houses no later than noon, Tuesday, February 10, 2015.

Rule 11. Except for the Budget Bill, beginning Wednesday, February 11, 2015, the House of
Delegates shall consider only Senate bills, Senate joint resolutions, House bills with Senate amendments,
and House joint resolutions with Senate amendments; the Senate shall consider only House bills, House
joint resolutions, Senate bills with House amendments, and Senate joint resolutions with House
amendments; and each house may consider conference reports and other privileged matters relating
thereto to the end that the work of each house may be disposed of by the other.

Rule 12. The houses of introduction shall complete their consideration of the Budget Bill, except for
 conference reports and other privileged matters relating thereto, no later than Thursday, February 12,
 2015.

Rule 13. The committees responsible for the consideration of revenue bills of the other house shallcomplete their consideration of such bills no later than midnight, Tuesday, February 17, 2015.

Rule 14. No later than midnight, Wednesday, February 18, 2015, each house shall complete its
consideration of the Budget Bill and all revenue bills of the other house, except for conference reports
and other privileged matters relating thereto, and the appointing authority shall appoint the conference to
such bills.

Rule 15. Requests for the drafting, redrafting, or correction of any joint commending or memorial
resolution shall be submitted to and received by the Division of Legislative Services no later than 5:00
p.m., Friday, February 20, 2015.

Rule 16. The first conference on any revenue bills shall complete its deliberations no later than
midnight, Saturday, February 21, 2015, and the report of such conference shall be made available to all
members of the General Assembly no later than noon, Monday, February 23, 2015.

Rule 17. No joint commending or memorial resolution shall be offered in either house after 5:00p.m., Monday, February 23, 2015.

148 Rule 18. Beginning Tuesday, February 24, 2015, neither house shall receive from any committee any bill or joint resolution acted on by any committee later than midnight, Monday, February 23, 2015.

150 Rule 19. No later than Tuesday, February 24, 2015, each house shall begin its consideration of any 151 election to fill any judicial seat in the courts of the Commonwealth, or to fill a seat on any commission 152 or office elected by the General Assembly. In the event that the houses cannot agree on such election 153 before Wednesday, February 25, 2015, such election shall become the subject of a special and 154 continuing joint order in each house, and such special and continuing joint order shall have precedence 155 over all other business of either house, until such time as both houses reach agreement on such election, 156 or either house votes to suspend or discharge the order. The Rules of each house, as far as applicable, 157 shall be the rules governing such election.

Rule 20. Requests for the drafting, redrafting, or correction of any single-house commending or
memorial resolution shall be submitted to and received by the Division of Legislative Services no later
than 5:00 p.m., Tuesday, February 24, 2015.

Rule 21. Any conference committee on the Budget Bill shall complete its deliberations and make the report of such conference available to the General Assembly as soon as practicable. Neither house shall consider such conference report earlier than 36 hours after receipt, unless both houses respectively determine to proceed earlier by a vote of two-thirds of the members voting in each house. No engrossment of the Budget Bill shall be required in either house, and any conference on the Budget Bill shall consider, as the basis of its deliberations, the Budget Bill as recommended by the Governor and introduced in the House and the amendments thereto proposed by each house.

168 Rule 22. No single-house commending or memorial resolution shall be offered in either house after169 5:00 p.m., Thursday, February 26, 2015.

Rule 23. Except for joint resolutions affecting the rules of procedure or the schedule of business of
the General Assembly, beginning Friday, February 27, 2015, the House of Delegates shall consider only
Senate joint resolutions and House joint resolutions with Senate amendments; the Senate shall consider
only House joint resolutions and Senate joint resolutions with House amendments; and each house may
consider conference reports or joint resolutions and other privileged matters relating thereto, to the end
that the work of each house may be disposed of by the other.

176 Rule 24. This session of the General Assembly shall be extended beyond the 30-day period provided
177 in Section 6 of Article IV of the Constitution of Virginia and shall adjourn sine die no later than
178 Saturday, February 28, 2015.

179 Rule 25. Pursuant to Section 6 of Article IV of the Constitution of Virginia, the General Assembly180 shall reconvene Wednesday, April 15, 2015, for the purpose of considering bills that may have been

181 returned by the Governor with recommendations for their amendment and bills and items of appropriation bills, including the general appropriation act, which may have been returned by the183 Governor with his objections.

184 Rule 26. The conduct of the business of any subcommittee of any House committee, any joint 185 subcommittee of House and Senate committees, and any interim study commission created pursuant to a 186 House measure shall be governed by the Rules of the House of Delegates; the conduct of the business 187 of any subcommittee of any Senate committee, any joint subcommittee of Senate and House committees, 188 and any interim study commission created pursuant to a Senate measure shall be governed by the Rules 189 of the Senate. If a House measure and a Senate measure create the same study, the conduct of the 190 business of the study shall be governed by the rules of the house of the chairman of the study, or in the 191 case of co-chairmen, the rules of the house as agreed upon by the co-chairmen.

Rule 27. Interim meetings of any standing committee, joint committee, joint subcommittee, legislative commission, or any other interim study subcommittee or study commission shall be held on Monday, Tuesday, or Wednesday during the first and third full weeks of the month, unless otherwise authorized by the Speaker of the House of Delegates or the Chairman of the Senate Committee on Rules, as may be appropriate for the house in which the chairman serves.

Rule 28. Any staff member assigned to work for, and support the efforts of, any committee of the
House or Senate, any subcommittee of any such committee, any joint subcommittee of House and
Senate committees, or any interim study commission shall work under the direction of the chairman of
such committee, subcommittee, joint subcommittee, or interim study commission.
