12	Be it enacted by the General Assembly of Virginia:
13	1. That the Code of Virginia is amended by adding in Article 2 of Chapter 4.2 of Title 55 a
14	section numbered 55-79.72:3 and by adding in Article 1 of Chapter 26 of Title 55 a section
15	numbered 55-509.3:1 as follows:
16	§ 55-79.72:3. Statement of unit owner rights.
17	Every unit owner who is a member in good standing of a unit owners' association shall have the
18	following rights:
19	1. The right of access to all books and records kept by or on behalf of the unit owners' association
20	subject to the provisions of § 55-79.74:1, including records of all financial transactions;
<b>2</b> 1	2. The right to cast a vote on any matter requiring a vote by the unit owners' association
22	membership in proportion to the unit owner's ownership interest as provided in the declaration;

23 24	meeting in accordance with the provisions of § 55-79.75;
25 25	4. The right to have (i) notice of any proceeding conducted by the executive organ or other tribunal
23 26	specified in the condominium instruments against the unit owner to enforce any rule or regulation of the
20 27	unit owners' association and (ii) the opportunity to be heard and represented by counsel at the
28	proceeding, as provided in § 55-79.80:2, and the right of due process in the conduct of that hearing;

30 31	fiduciary standards.
32	The rights enumerated in this section shall be enforceable by any such lot owner pursuant to the
3 <u>7</u>	provisions of § 55-79.53.

35	Every lot owner who is a member in good standing of a property owners' association shall have the
36	following rights:
37	1. The right of access to all books and records kept by or on behalf of the association subject to the
38	provisions of § 55-510, including records of all financial transactions;
39	2. The right to cast a vote on any matter requiring a vote by the association's membership in
<b>40</b>	proportion to the lot owner's ownership interest as provided in the declaration;
41	3. The right to have notice of any meeting of the board of directors and to participate in such
42	meeting in accordance with the provisions of subsection F of § 55-510 and § 55-510.1;
43	4. The right to have (i) notice of any proceeding conducted by the board of directors or other
43 44	tribunal specified in the declaration against the lot owner to enforce any rule or regulation of the
45	association and (ii) the opportunity to be heard and represented by counsel at the proceeding, as
<b>4</b> 6	provided in § 55-513, and the right of due process in the conduct of that hearing; and
