A BILL to amend and reenact §§ 8.01-401.2 and 8.01-581.1 of the Code of Virginia, relating to nurse practitioners; expert witness testimony and health care provider definition.

10 Be it enacted by the General Assembly of Virginia:

1. That §§ 8.01-401.2 and 8.01-581.1 of the Code of Virginia are amended and reenacted as 11 12 follows:

§ 8.01-401.2. Chiropractor, nurse practitioner, or physician assistant as expert witness.

14 A. A doctor of chiropractic, when properly qualified, may testify as an expert witness in a court of 15 law as to etiology, diagnosis, prognosis, treatment, treatment plan, and disability, including anatomical, 16 physiological, and pathological considerations within the scope of the practice of chiropractic as defined 17 in § 54.1-2900.

18 B. A physician assistant or nurse practitioner, when properly qualified, may testify as an expert 19 witness in a court of law as to etiology, diagnosis, prognosis, treatment, treatment plan, and disability, 20 including anatomical, physiological, and pathological considerations within the scope of his activities as 21 authorized pursuant to § 54.1-2952. However, no physician assistant or nurse practitioner shall be 22 permitted to testify as an expert witness for or against (i) a defendant doctor of medicine or osteopathic 23 medicine in a medical malpractice action regarding the standard of care of a doctor of medicine or 24 osteopathic medicine or (ii) a defendant health care provider in a medical malpractice action regarding 25 causation. 26

§ 8.01-581.1. Definitions.

As used in this chapter:

28 "Health care" means any act, professional services in nursing homes, or treatment performed or 29 furnished, or which should have been performed or furnished, by any health care provider for, to, or on 30 behalf of a patient during the patient's medical diagnosis, care, treatment or confinement.

"Health care provider" means (i) a person, corporation, facility or institution licensed by this Commonwealth to provide health care or professional services as a physician or hospital, dentist, 31 32 33 pharmacist, registered nurse or licensed practical nurse or a person who holds a multistate privilege to 34 practice such nursing under the Nurse Licensure Compact, nurse practitioner, optometrist, podiatrist, 35 physician assistant, chiropractor, physical therapist, physical therapy assistant, clinical psychologist, 36 clinical social worker, professional counselor, licensed marriage and family therapist, licensed dental 37 hygienist, health maintenance organization, or emergency medical care attendant or technician who 38 provides services on a fee basis; (ii) a professional corporation, all of whose shareholders or members 39 are so licensed; (iii) a partnership, all of whose partners are so licensed; (iv) a nursing home as defined in § 54.1-3100 except those nursing institutions conducted by and for those who rely upon treatment by 40 41 spiritual means alone through prayer in accordance with a recognized church or religious denomination; 42 (v) a professional limited liability company comprised of members as described in subdivision A 2 of § 13.1-1102; (vi) a corporation, partnership, limited liability company or any other entity, except a 43 state-operated facility, which employs or engages a licensed health care provider and which primarily 44 45 renders health care services; or (vii) a director, officer, employee, independent contractor, or agent of the 46 persons or entities referenced herein, acting within the course and scope of his employment or 47 engagement as related to health care or professional services.

48 "Health maintenance organization" means any person licensed pursuant to Chapter 43 (§ 38.2-4300 et 49 seq.) of Title 38.2 who undertakes to provide or arrange for one or more health care plans.

50 "Hospital" means a public or private institution licensed pursuant to Chapter 5 (§ 32.1-123 et seq.) of 51 Title 32.1 or Article 2 (§ 37.2-403 et seq.) of Chapter 4 of Title 37.2.

"Impartial attorney" means an attorney who has not represented (i) the claimant, his family, his partners, co-proprietors or his other business interests; or (ii) the health care provider, his family, his 52 53 54 partners, co-proprietors or his other business interests.

55 "Impartial health care provider" means a health care provider who (i) has not examined, treated or been consulted regarding the claimant or his family; (ii) does not anticipate examining, treating, or being 56 consulted regarding the claimant or his family; or (iii) has not been an employee, partner or 57 58 co-proprietor of the health care provider against whom the claim is asserted.

59 "Malpractice" means any tort action or breach of contract action for personal injuries or wrongful
60 death, based on health care or professional services rendered, or which should have been rendered, by a
61 health care provider, to a patient.

"Patient" means any natural person who receives or should have received health care from a licensed
health care provider except those persons who are given health care in an emergency situation which
exempts the health care provider from liability for his emergency services in accordance with § 8.01-225
or 44-146.23.

"Physician" means a person licensed to practice medicine or osteopathy in this Commonwealthpursuant to Chapter 29 (§ 54.1-2900 et seq.) of Title 54.1.

68 "Professional services in nursing homes" means services provided in a nursing home, as that term is

69 defined in clause (iv) of the definition of health care provider in this section, by a health care provider 70 related to health care, staffing to provide patient care, psycho-social services, personal hygiene,

hydration, nutrition, fall assessments or interventions, patient monitoring, prevention and treatment of medical conditions diagnosis or therepy

72 medical conditions, diagnosis or therapy.
