6 **Be it enacted by the General Assembly of Virginia:**7 **1. That the Code of Virginia is amended by adding a section numbered 24.2-303.4 as follows:**8 **§ 24.2-303.4. Senate districts.**9 *Subject to the provisions of subsections A, B, and C of § 24.2-303.3, the following Senate districts*
10 *shall be comprised as follows:*11 *Seventeenth. All of Orange County; all of the City of Fredericksburg; part of Albemarle County*
12 *comprised of the Agnor-Hurt (104), Branchlands (103), Dunlora (105), Free Bridge (504), Georgetown*
13 *(203), and Keswick (501) Precincts and parts of the Jack Jouett (201), Stony Point (502), and*
14 *Woodbrook (101) Precincts; part of Culpeper County comprised of the East Fairfax (201), Mitchells*
15 *(601), Pearl Sample (602), and West Fairfax (101) Precincts; part of Louisa County comprised of the*
16 *Cuckoo (502), Louisa #1 (201), Louisa #2 (202), Mechanicsville (102), Mineral (401), Patrick Henry #1*
17 *(301), South Anna (702), Yanceyville (402), and Zion (101) Precincts; and part of Spotsylvania County*
18 *comprised of the Battlefield (701), Belmont (501), Brent's Mill (702), Brokenburg (502), Chancellor*
19 *(204), Courthouse (504), Fairview (703), Frazers Gate (402), Hazel Run (302), Ni River (203),*
20 *Piedmont (603), Salem (601), Smith Station (602), and Todd's Tavern (503) Precincts and parts of the*
21 *Brock (505) and Plank Road (301) Precincts.*22 *Twenty-second. All of Amherst, Appomattox, Buckingham, Cumberland, Fluvanna, Goochland, and*
23 *Prince Edward Counties; part of Louisa County comprised of the Bumpass (601), Fredericks Hall (501),*
24 *Locust Creek (602), and Sheltons Mill (701) Precincts; and part of the City of Lynchburg comprised of*
25 *the First Ward Second Precinct (102), First Ward Third Precinct (103), First Ward Fourth Precinct*
26 *(104), First Ward Fifth Precinct (105), Second Ward First Precinct (201), Second Ward Second Precinct*
27 *(202), Second Ward Third Precinct (203), Third Ward First Precinct (301), Third Ward Second Precinct*
28 *(302), Fourth Ward Second Precinct (402), and Fourth Ward Third Precinct (403) Precincts and part of*
29 *the First Ward First Precinct (101) Precinct.*30 *All other Senate districts shall be comprised as provided in § 24.2-303.3.*31 **2. That the first enactment changes the assignment of certain census precincts to Senate districts**
32 **as follows:**33 **In Louisa County, census precinct Fredericks Hall (501) Precinct is reassigned from District 17**
34 **to District 22.**35 **In Louisa County, census precinct South Anna (702) Precinct is reassigned from District 22 to**
36 **District 17.**
