5.	Summary: Authorizes the Treasury Board to issue bonds pursuant to Article X, Section 9 (c) of the Constitution of Virginia in an amount up to \$67,500,000 plus financing costs to finance revenue-producing capital projects at one institution of higher education.
	The bonds are backed by the full faith and credit of the Commonwealth and therefore constitute tax-supported debt. The bill also declares that an emergency exists and that the bill is effective upon passage.
6.	Budget Amendment Necessary: No.
7.	Fiscal Impact. Preliminary. The project listed in this bill is included in House Bill 1400. It is expected that this project will generate sufficient nongeneral fund revenues to pay operating expenses and debt service.
8.	Fiscal Implications: Virginia Tech will need nongeneral fund appropriations for debt service once the project is complete and must set rates, fees, and/or charges at levels that wil generate sufficient net revenues to retire the debt.
