- 5. Summary: Office of the Attorney General; employment of special counsel. Provides that prior to entering into a contract with special counsel, the Governor or Office of the Attorney General, as applicable, shall make a written determination that the representation is both cost effective and in the public interest. Copies of the contract shall be made available to the public on the website of the Governor or the Attorney General, and the Governor and the Attorney General shall submit an annual report to the General Assembly describing the use of contracts for special counsel. The bill further provides that the Attorney General, or counsel to the Governor in cases in which the Attorney General has a conflict, shall retain control over special counsel and that special counsel shall maintain financial records relevant to the contract for no less than four years after the contract is ended. The bill also limits the contingency fee that may be charged by special counsel depending on the amount recovered.

- **8. Fiscal Implications:** This bill proposes that the Office of the Attorney General (OAG) manage all contractual undertakings with regards to the employment of special counsel. Also, it requires that copies of applicable contracts be made available on the website of the Governor or the Attorney General, and annual reports be submitted to the General Assembly.

The OAG would administratively supervise (i.e. review, monitor, approve) all aspects of matter in the hands of special counsel. As an additional function for the OAG, attorneys and support staff would need to be hired to oversee/participate in the required aspects of matters/cases. The OAG indicates that hiring needed legal staff could cost between \$2 million and \$5 million. The staff hired would need to be subject matter experts to be able to handle the referred matters to special counsel. Currently the OAG lacks subject matter attorneys within certain legal areas, thus the utilization of special counsel. The cost of additional Finance or Administration staff could be upwards of \$250,000 to \$300,000. Additionally, travel costs to ensure proper monitoring of matters would be incurred.

Estimated costs of this bill are indeterminate as they are dependent on the number of staff needed to handle the volume of contracts and correspondence relating to those contracts.
